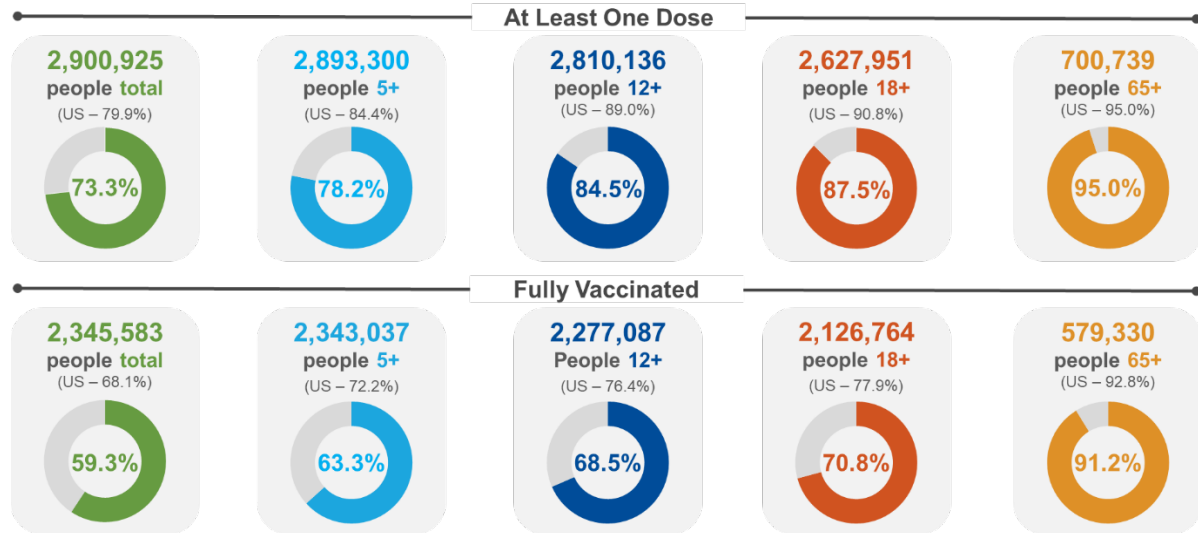

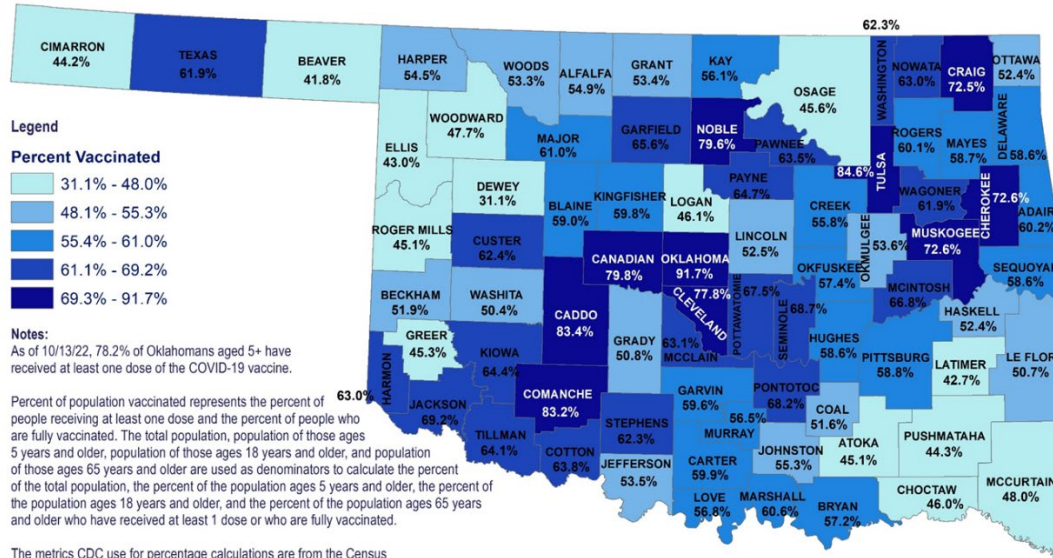

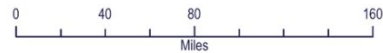

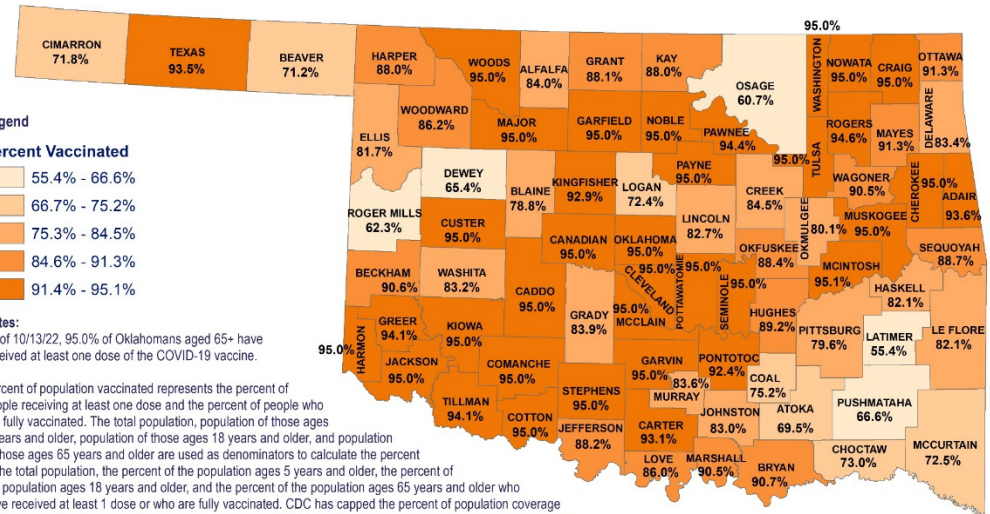

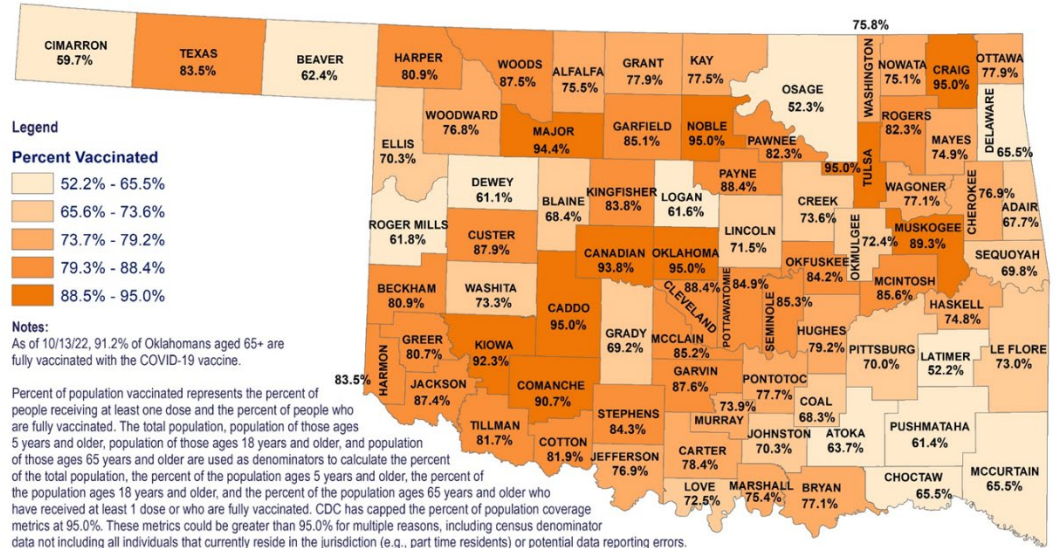

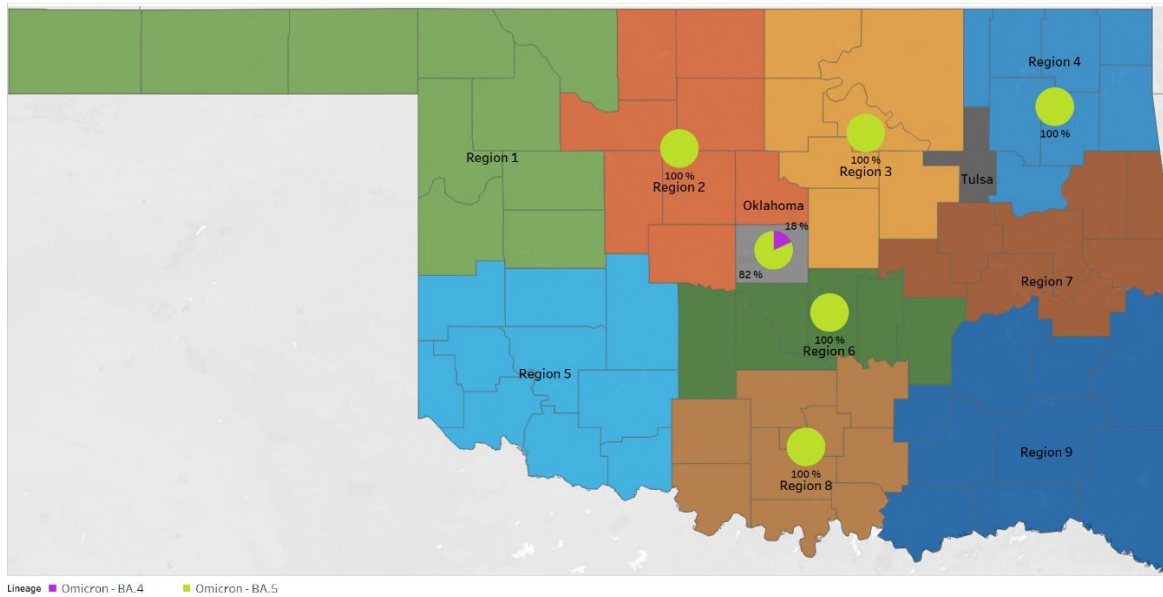

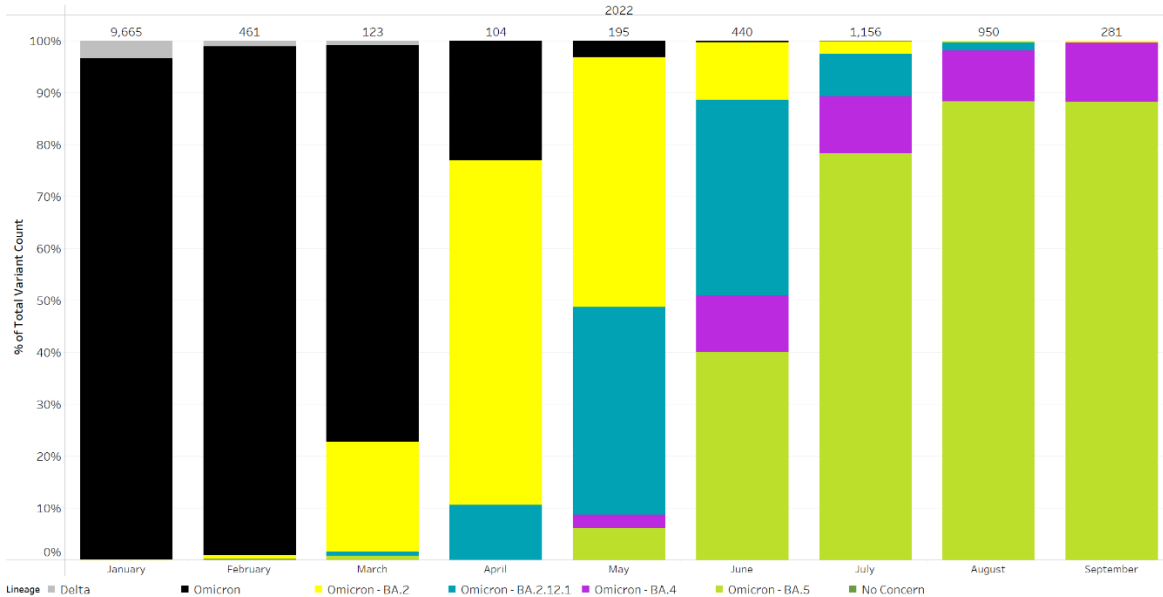

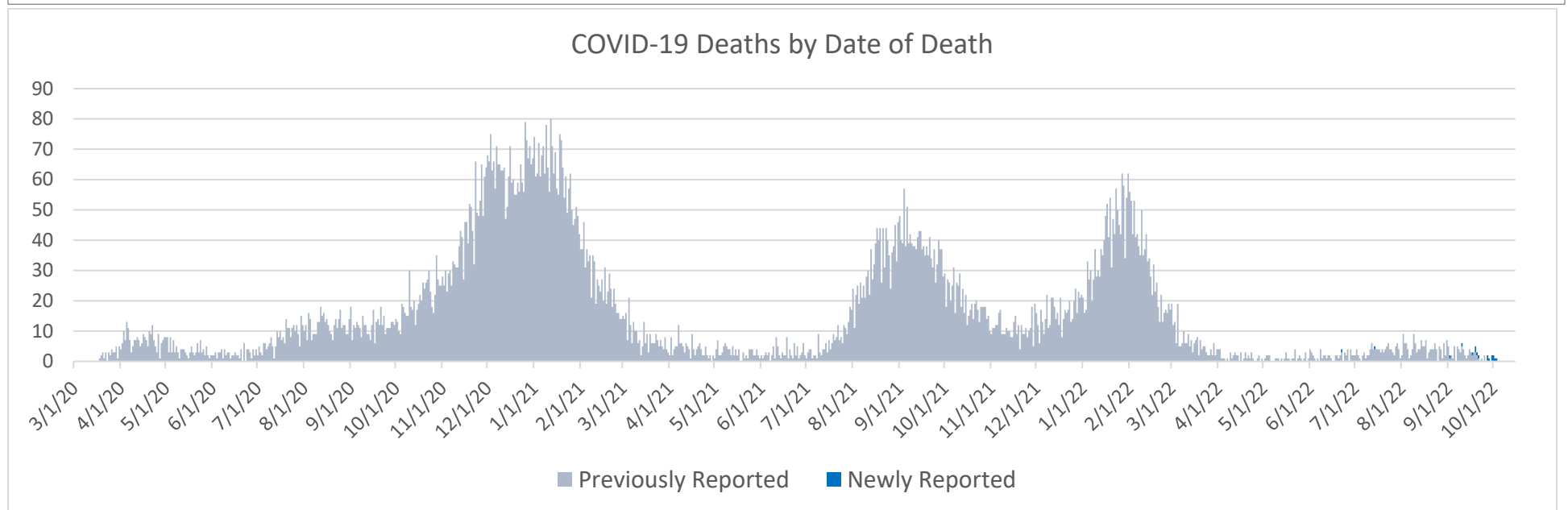
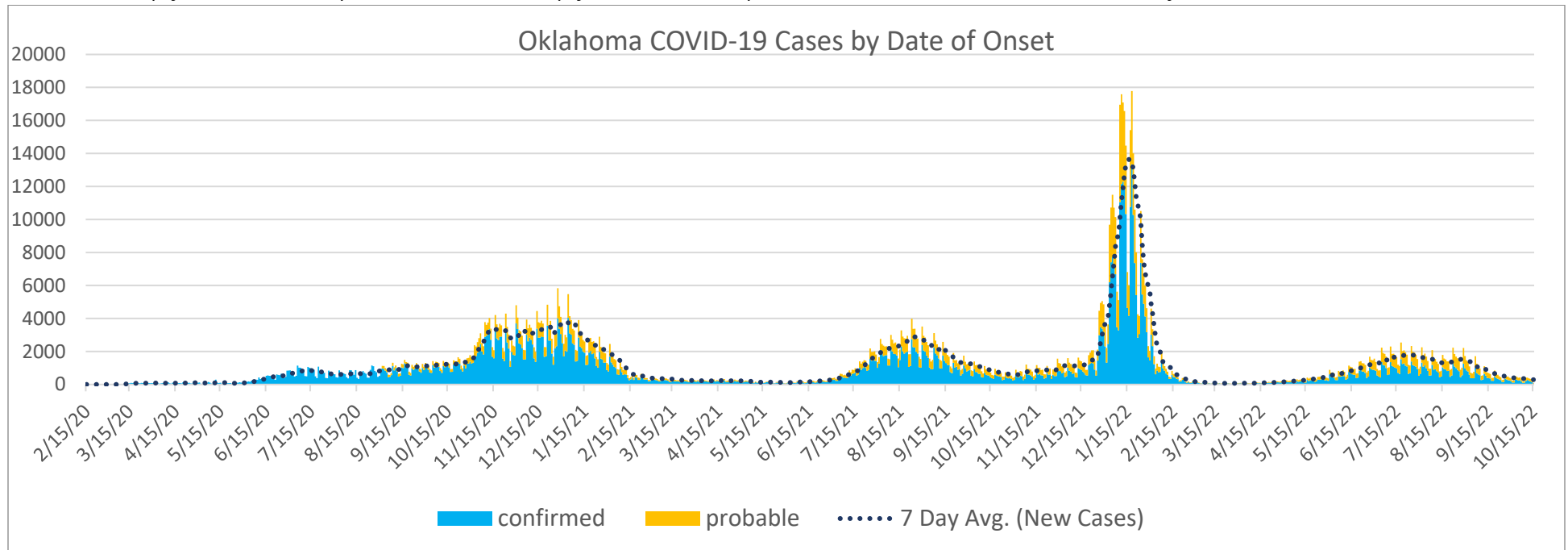
Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - October 18, 2022 (N=13,375)

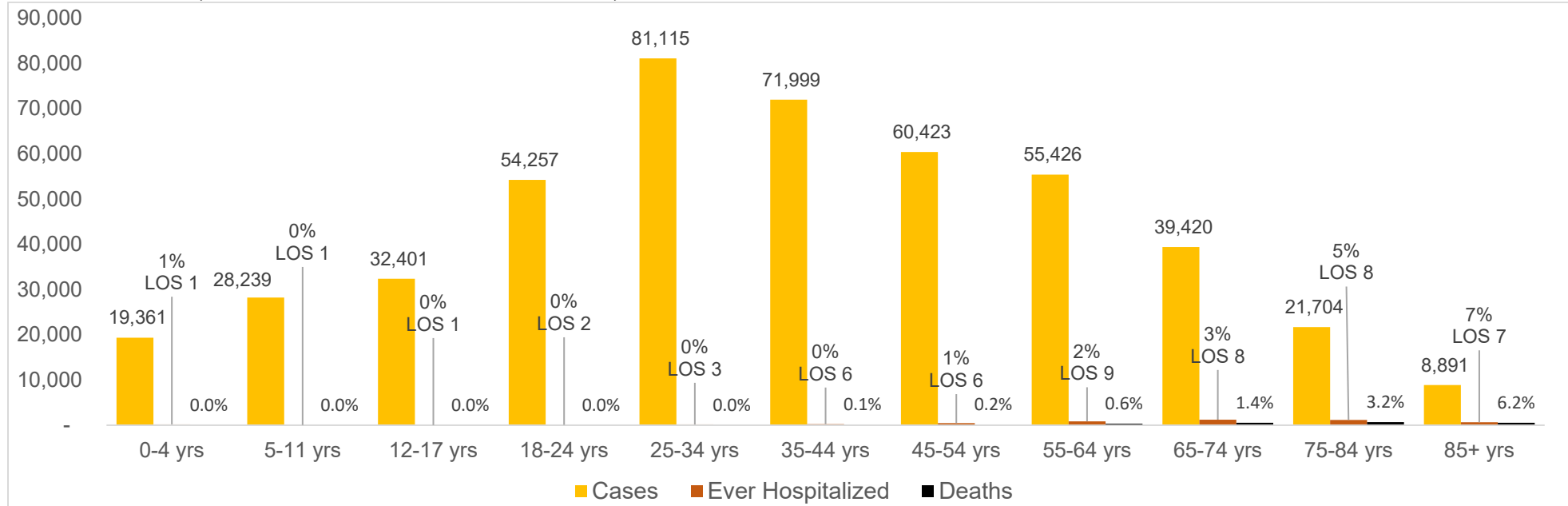

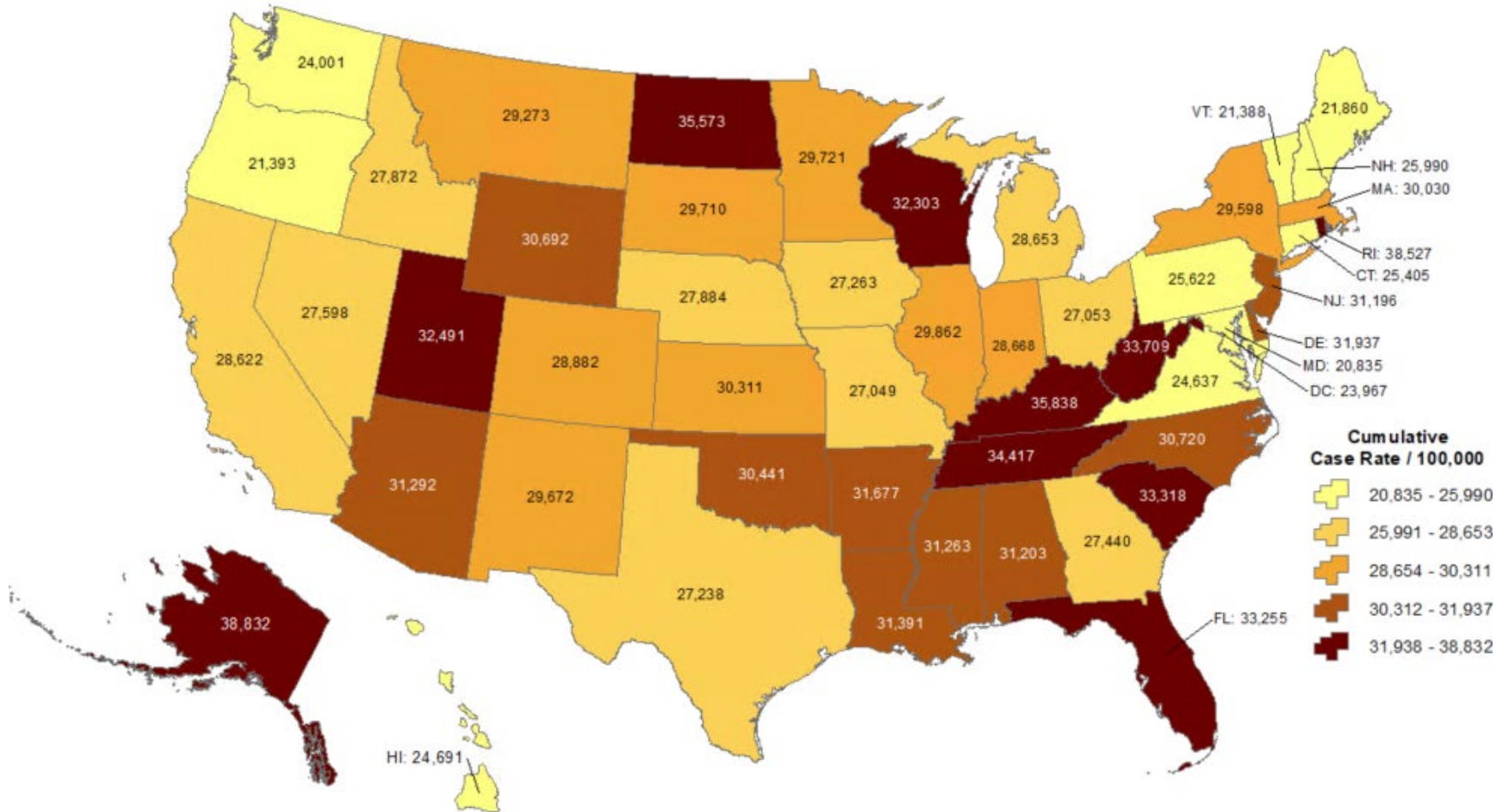
2022 CASES, PERCENT HOSPITALIZED, AVERAGE LENGTH OF STAY AND DEATHS BY AGE GROUP

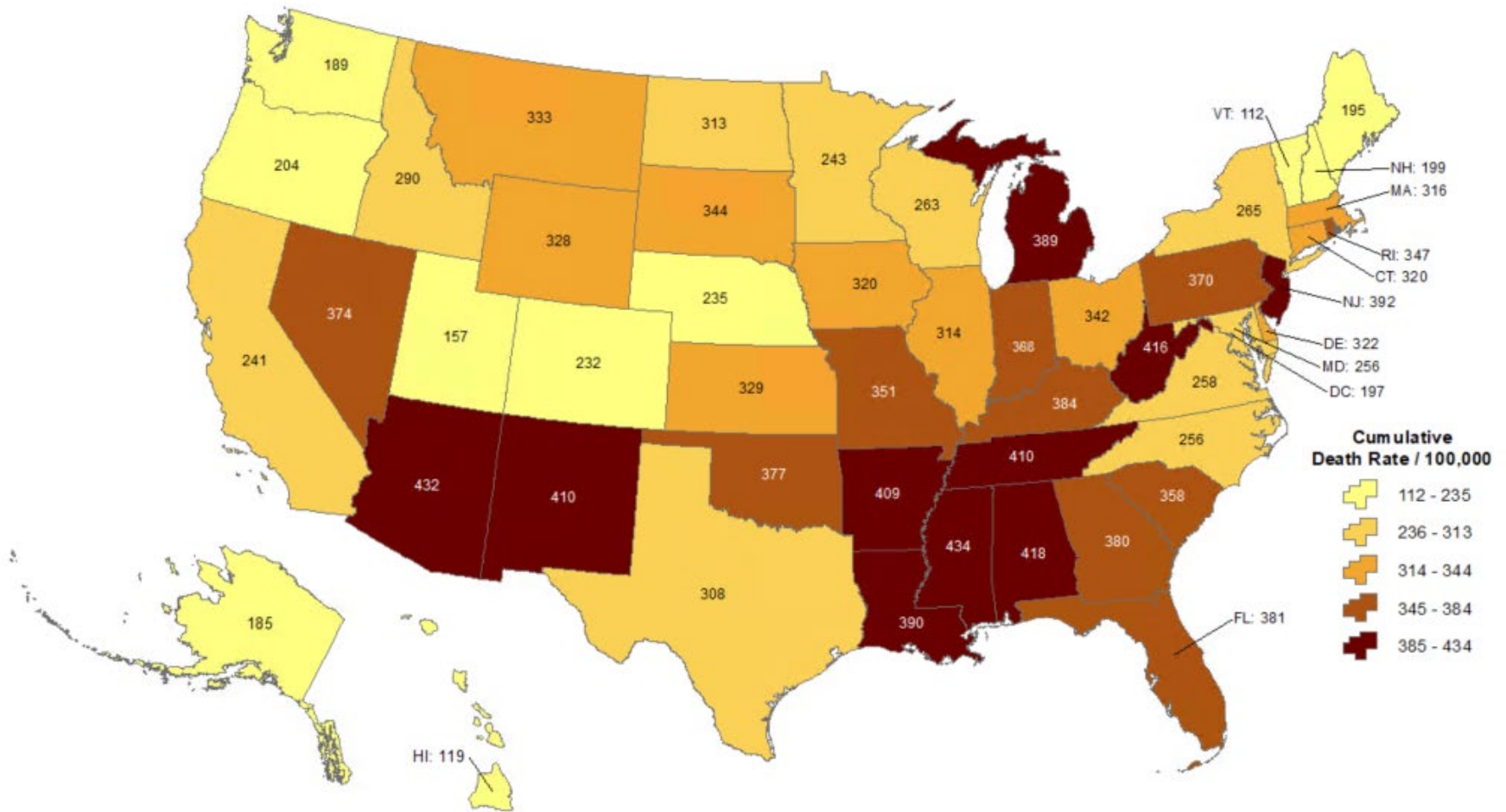

Cumulative death rate of reported COVID-19 cases

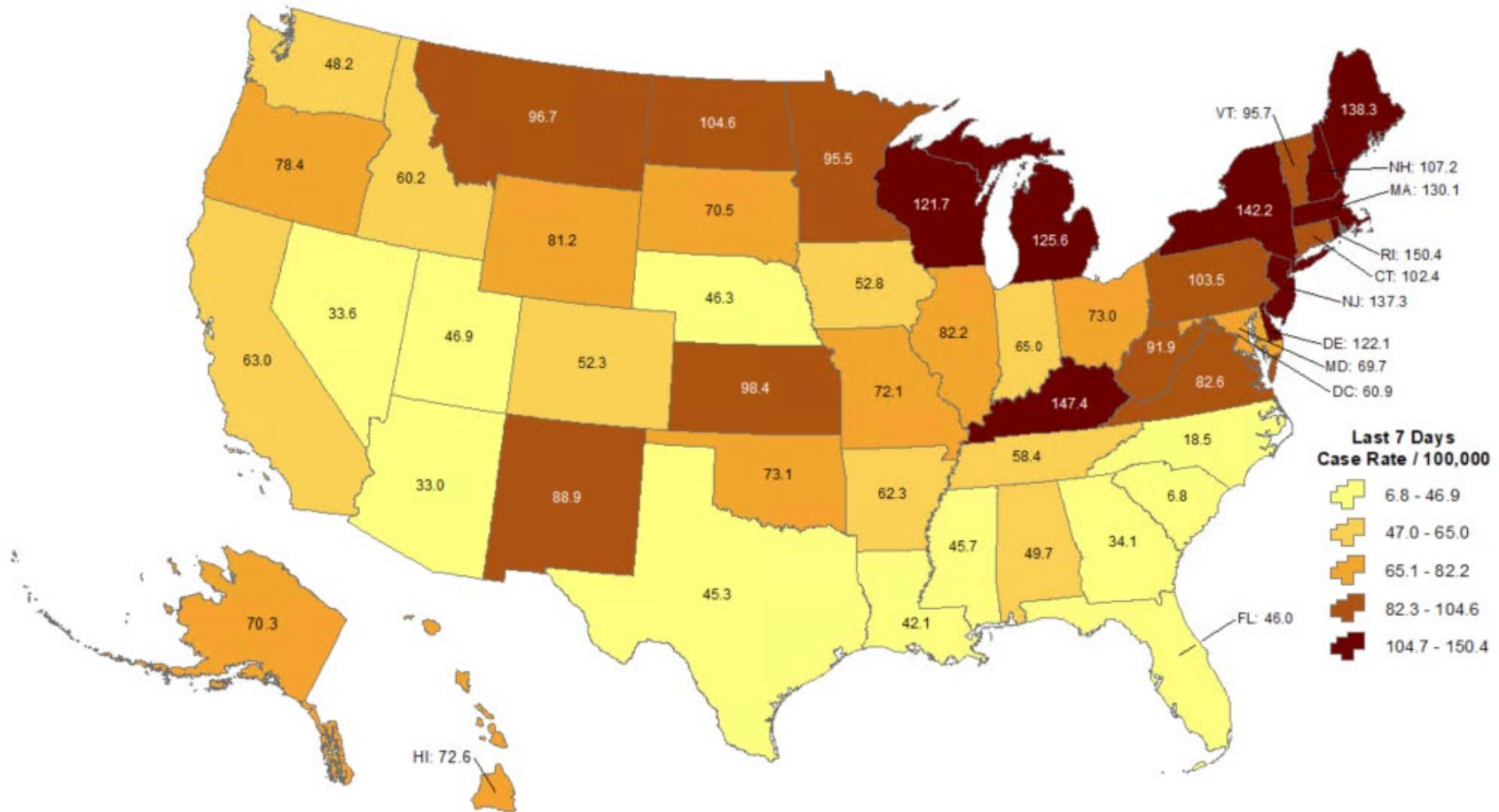

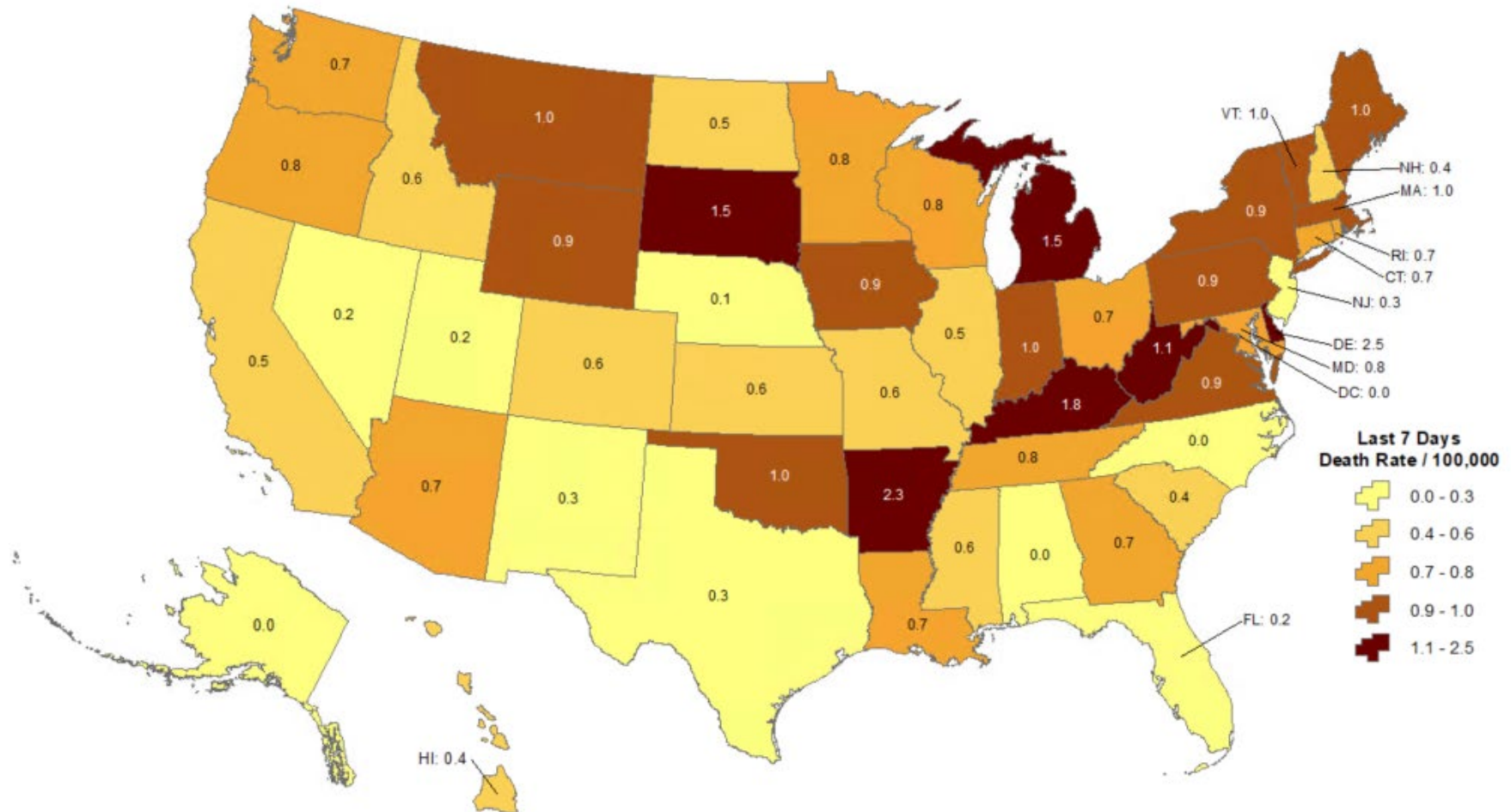

Cumulative death rate of reported COVID-19 cases in last 7 days

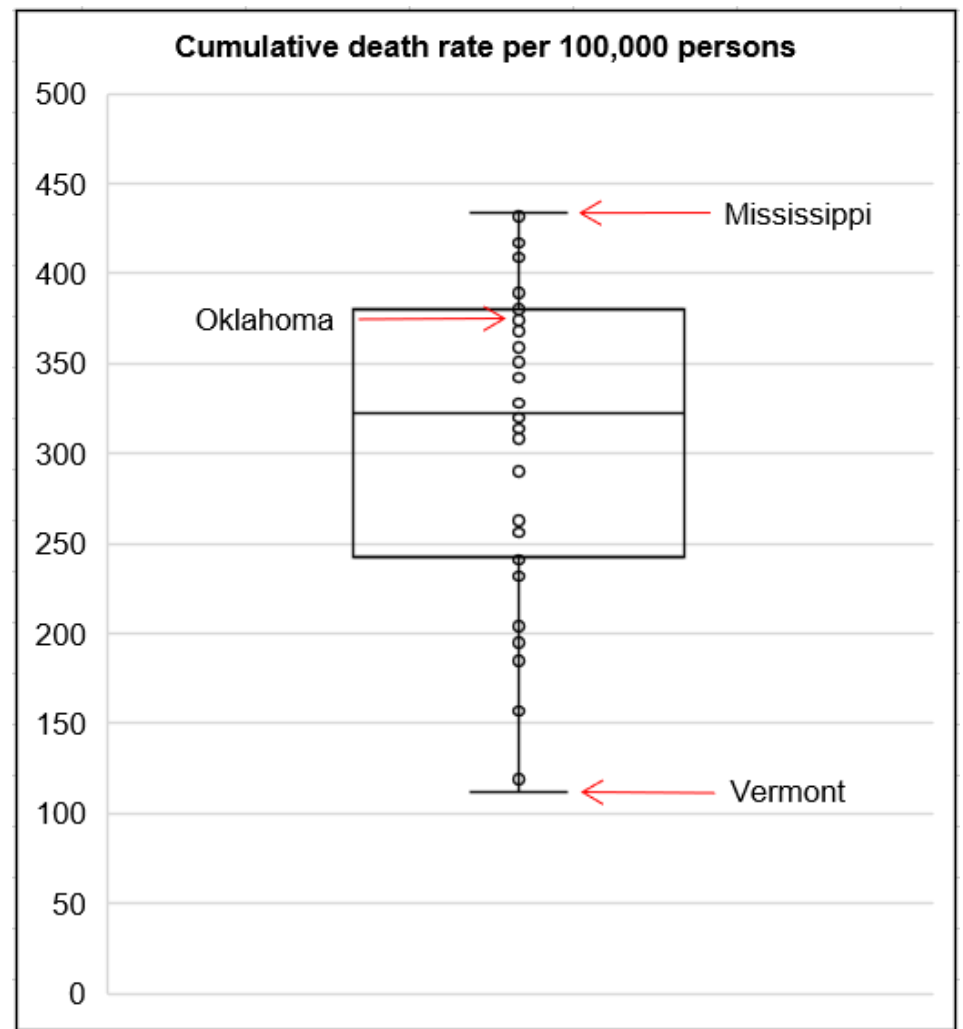
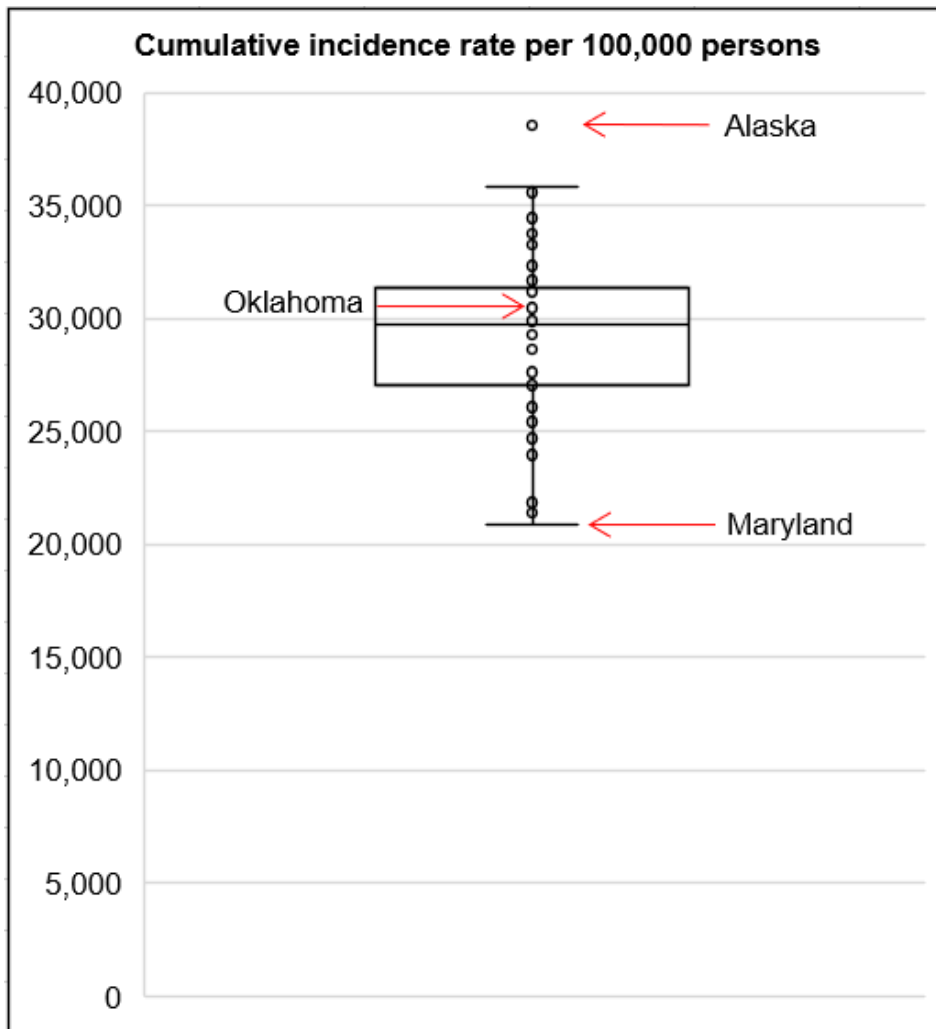

Weekly number of deaths (from all causes)

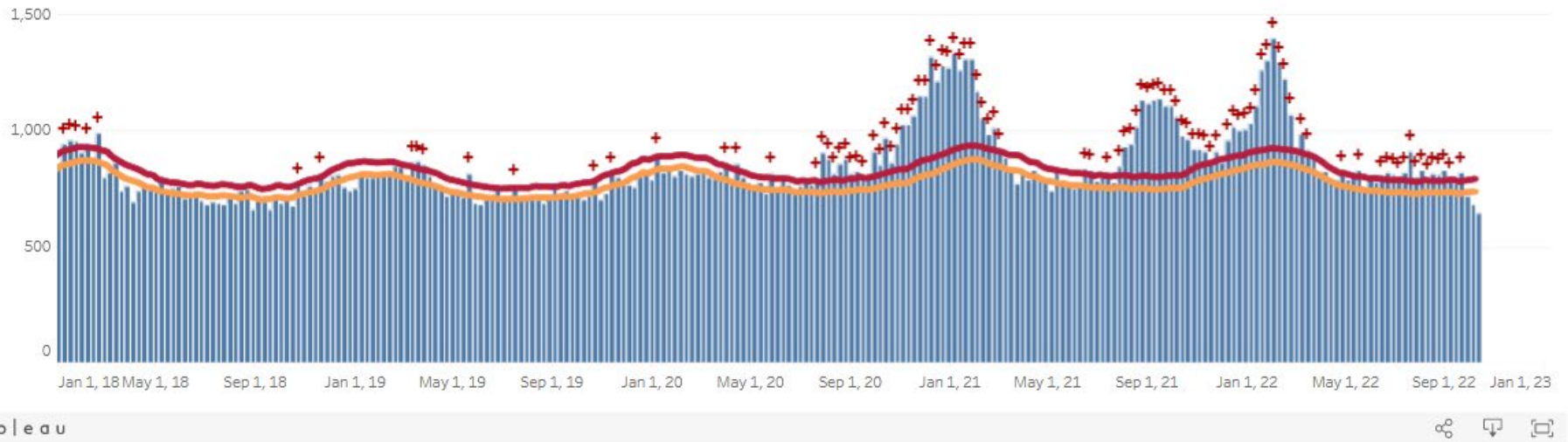
