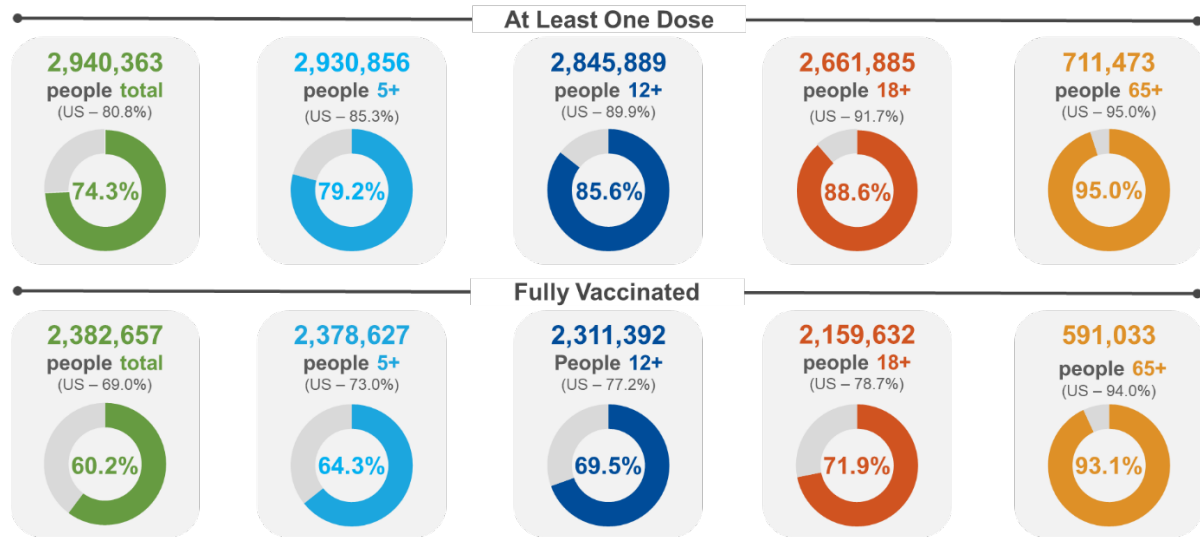

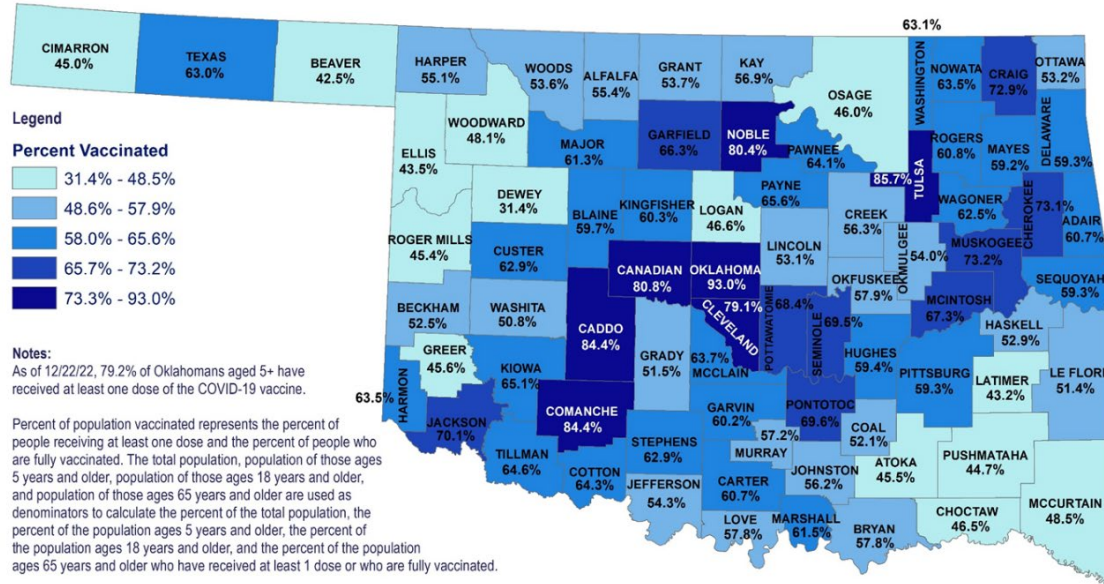

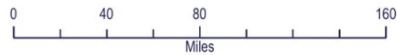

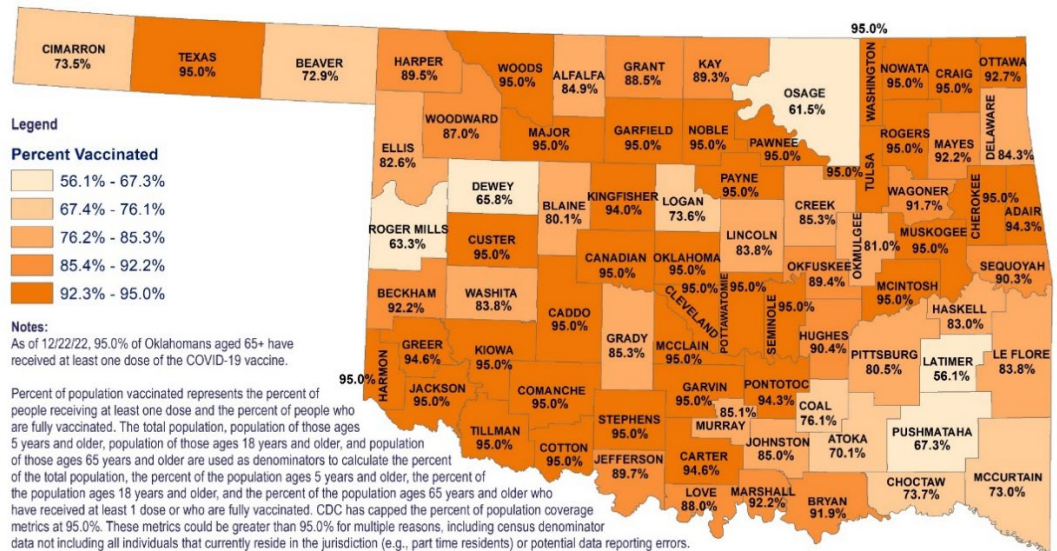

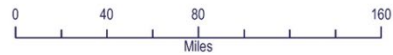

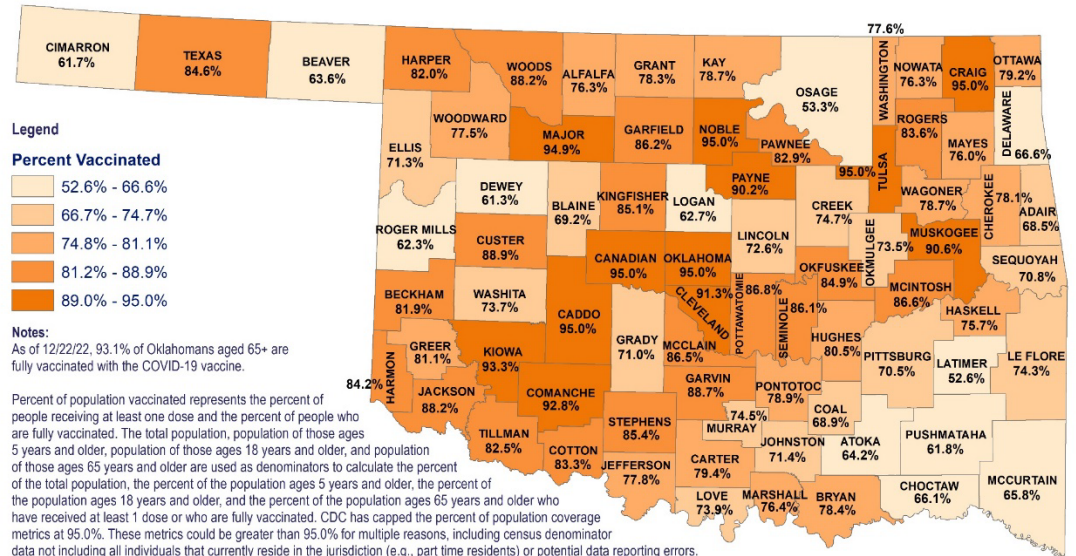

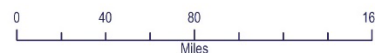

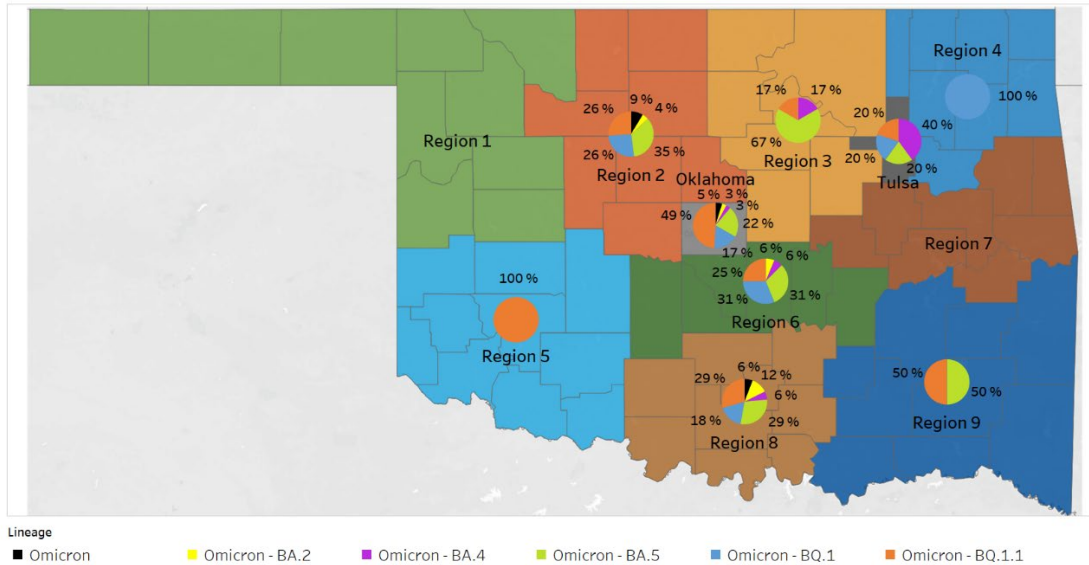

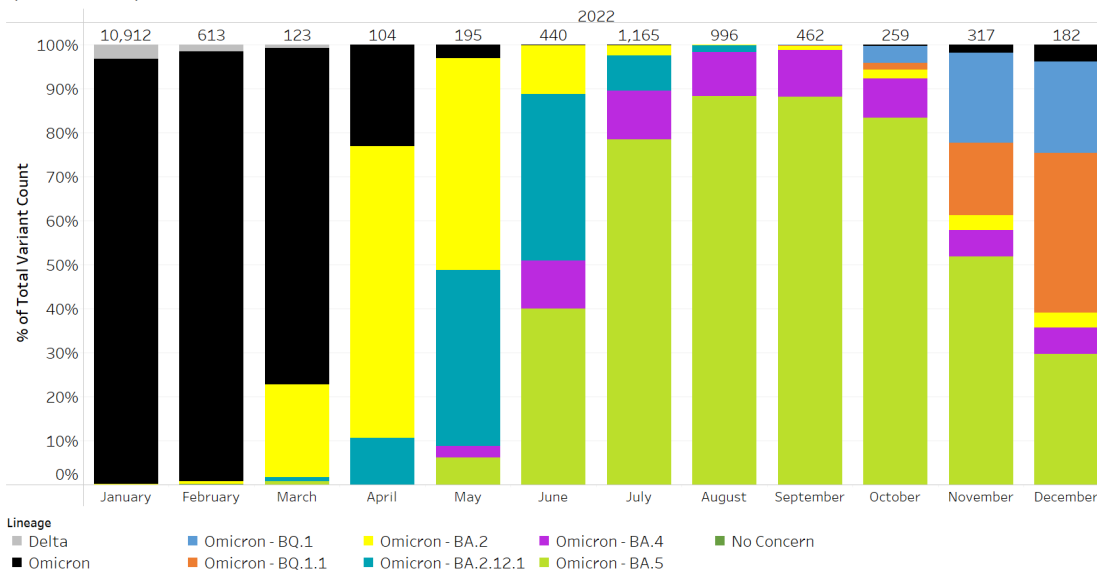
COVID-19 VARIANT STRAINS SEQUENCED*

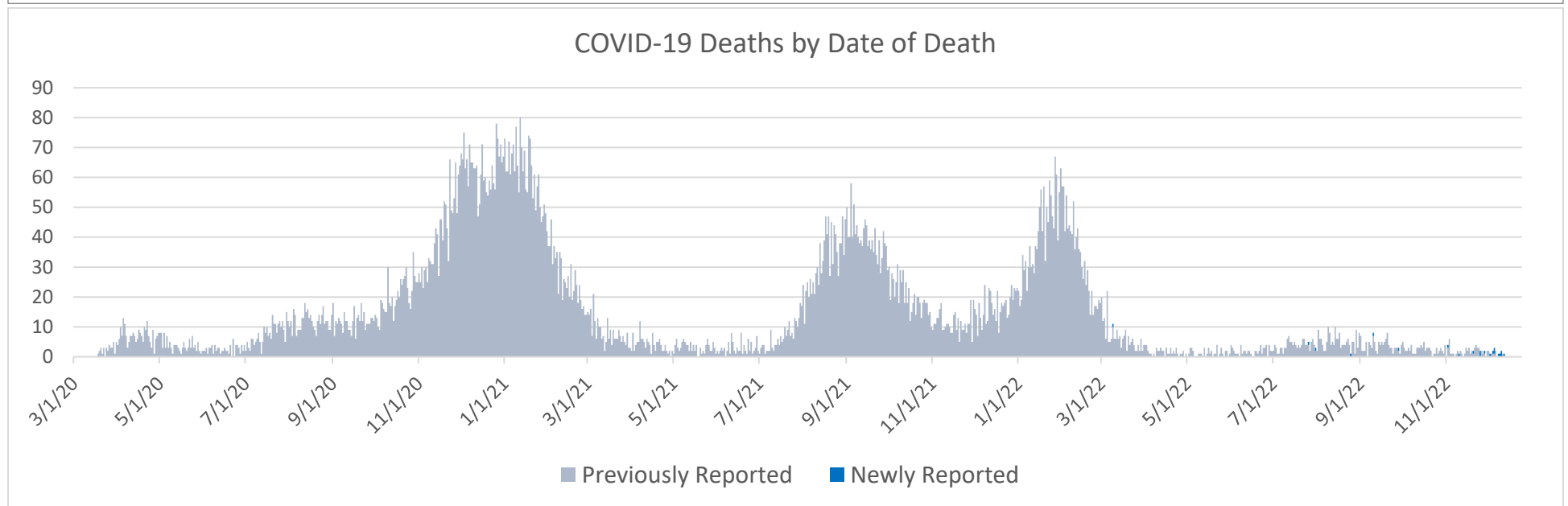
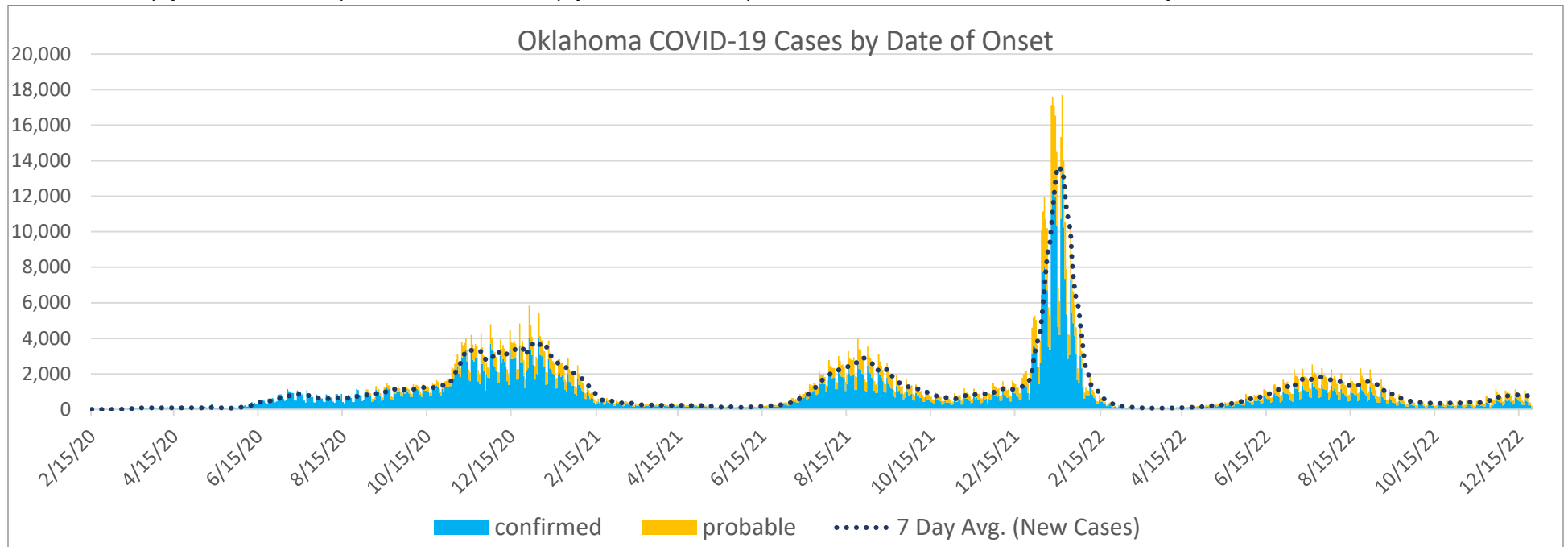
Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - December 28, 2022 (N=15,768)

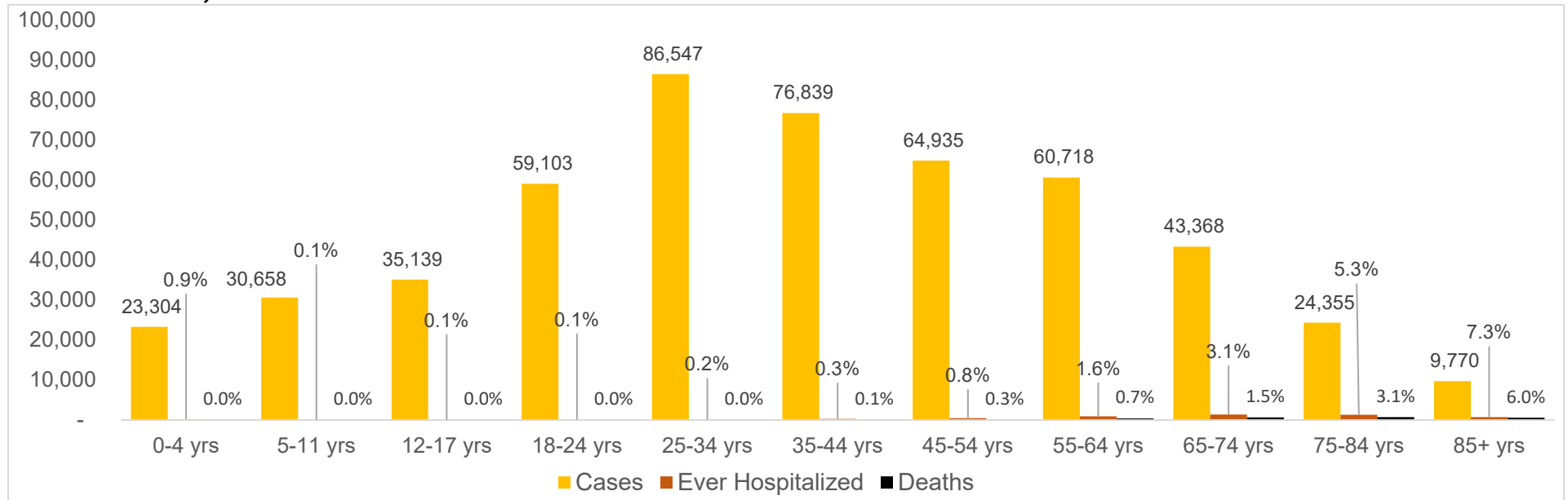

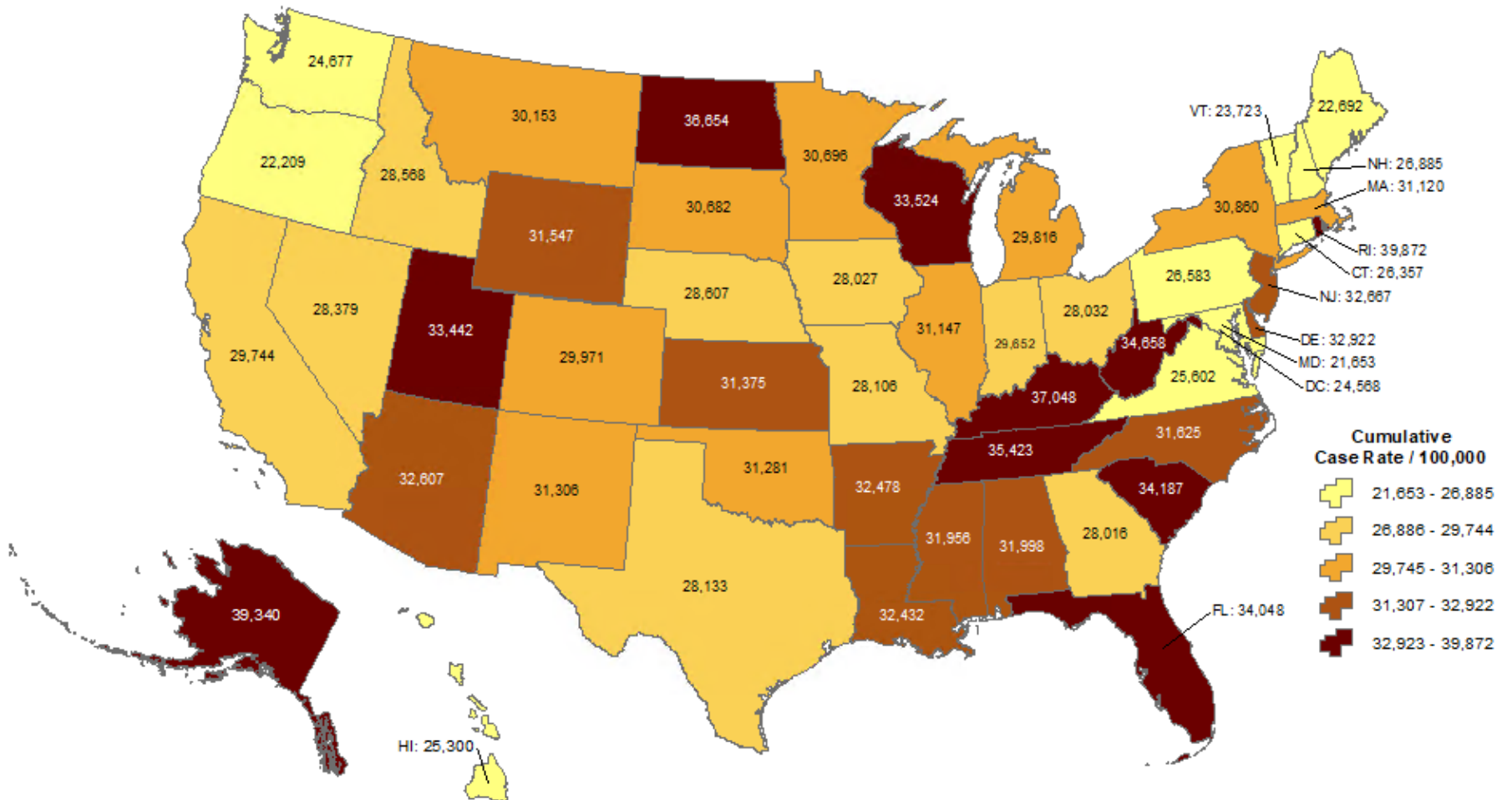
2022 CASES, PERCENT HOSPITALIZED AND DEATHS BY AGE GROUP

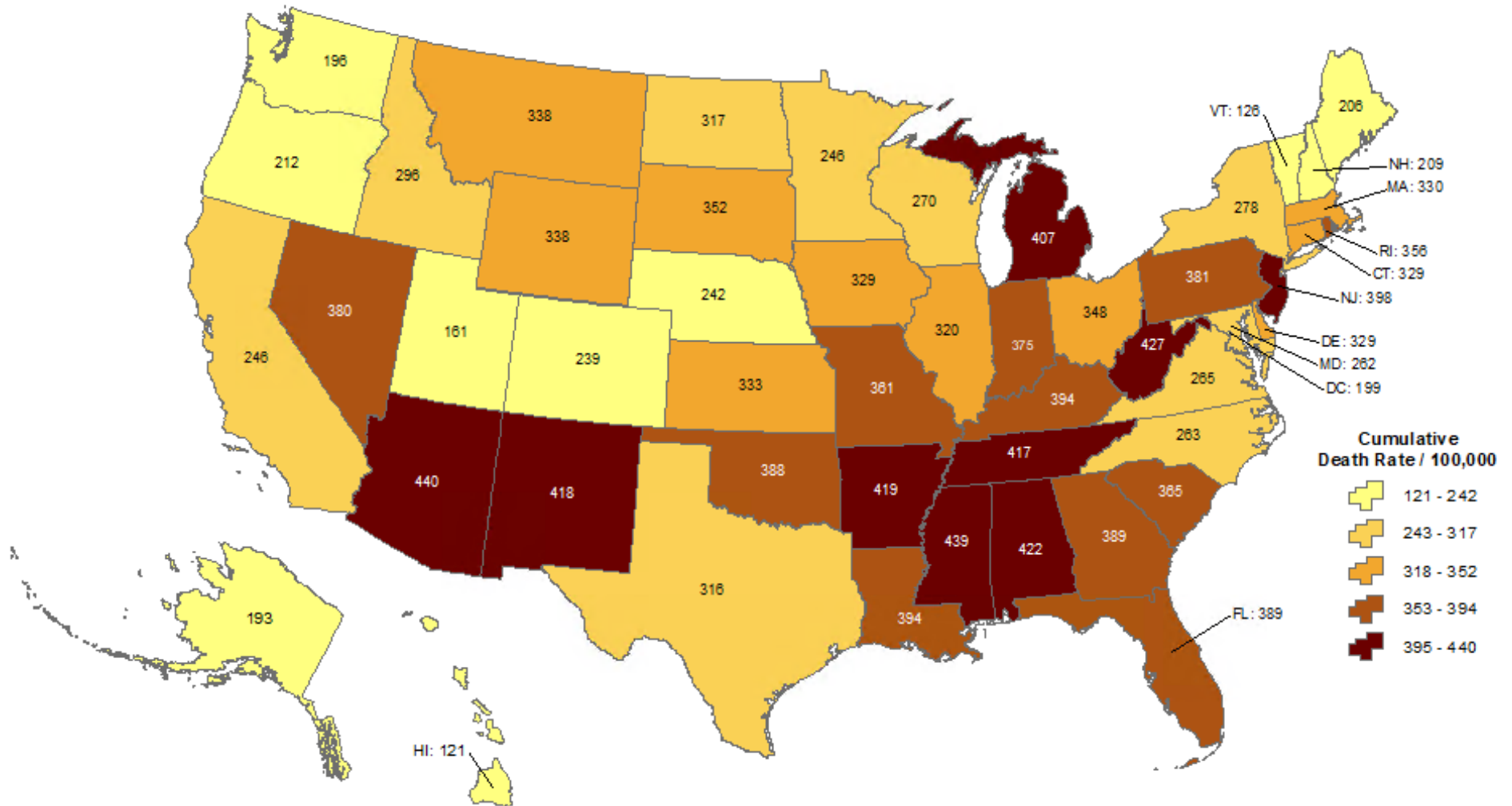

Cumulative death rate of reported COVID-19 cases

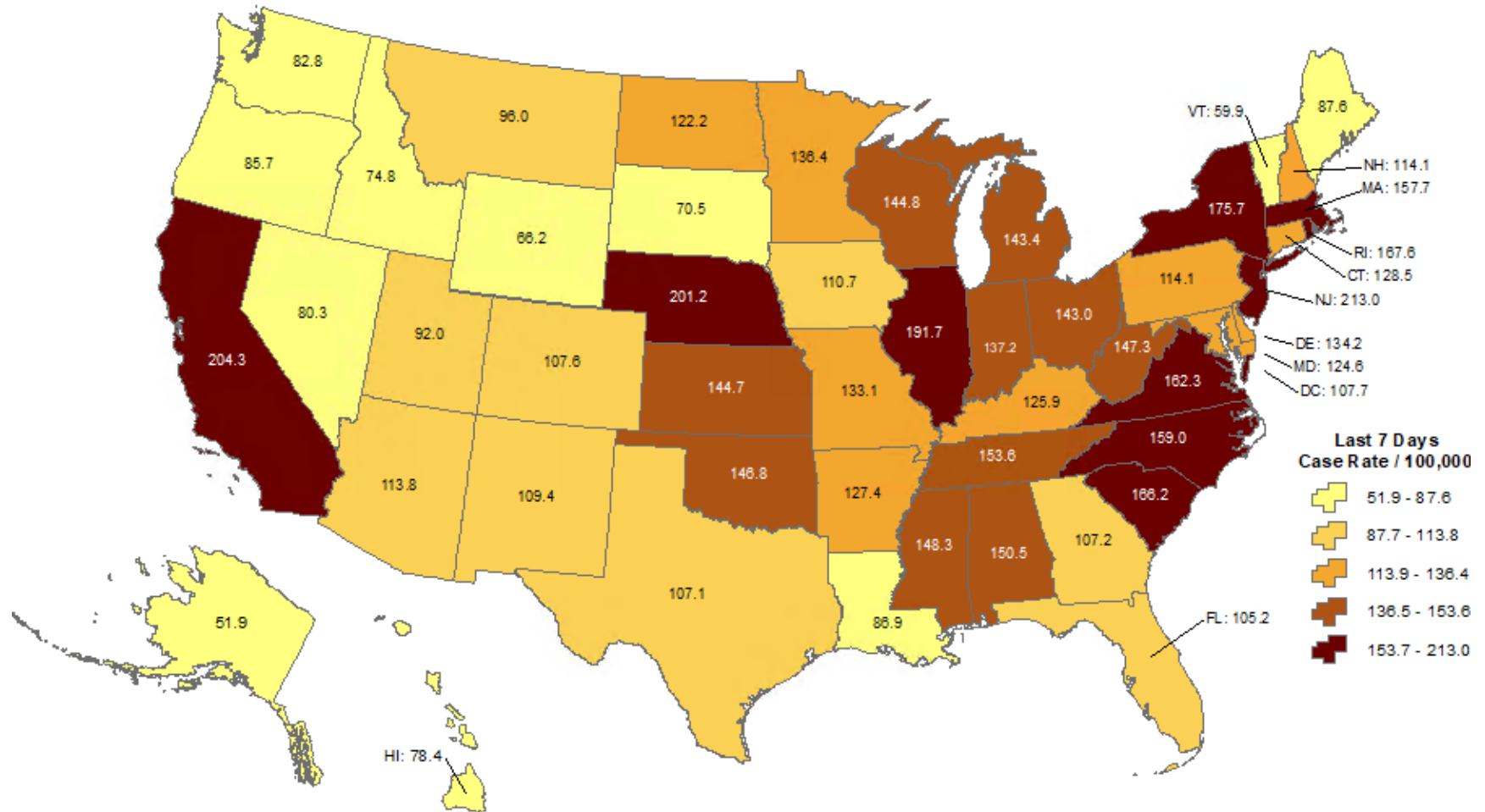

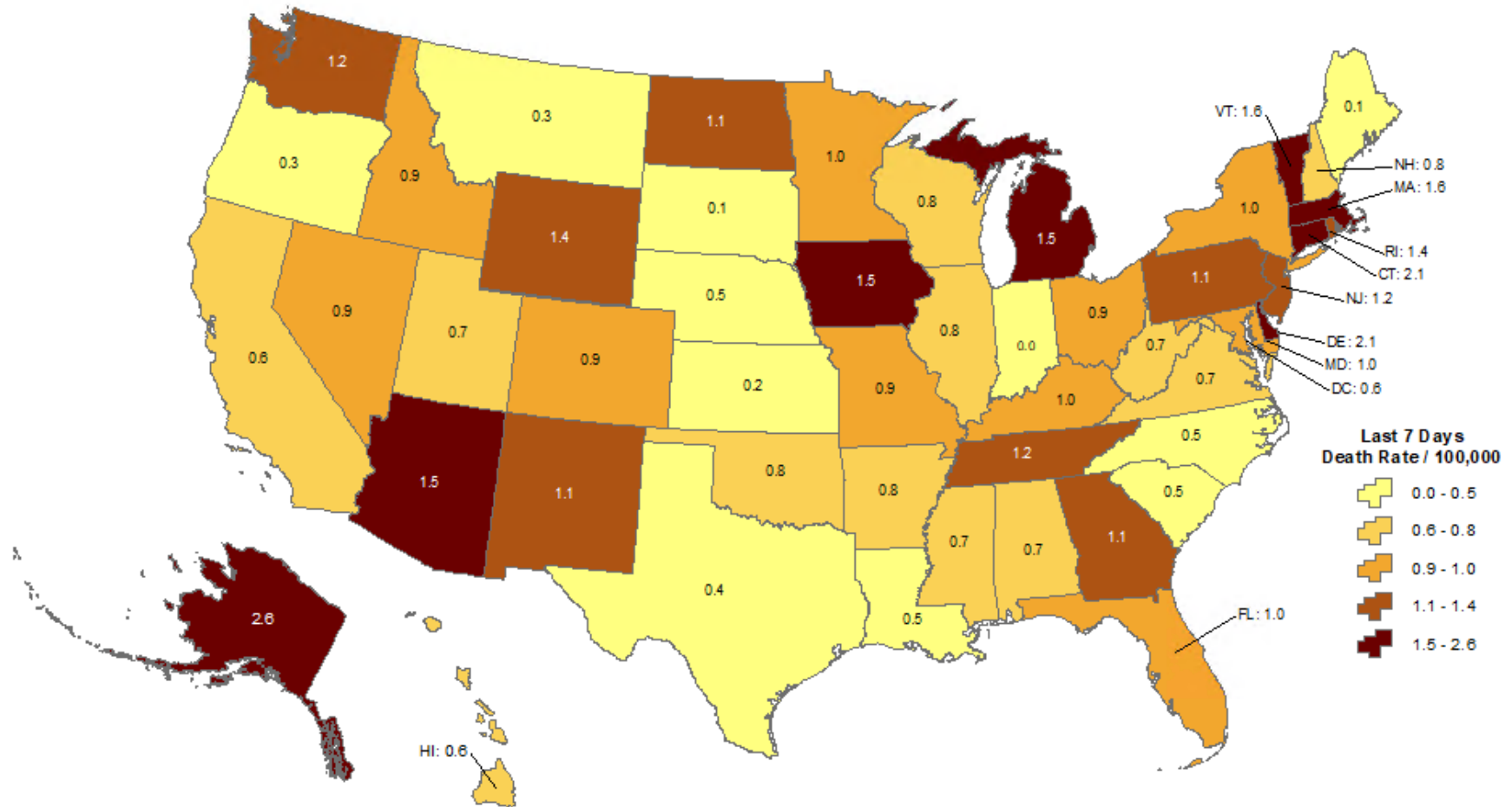

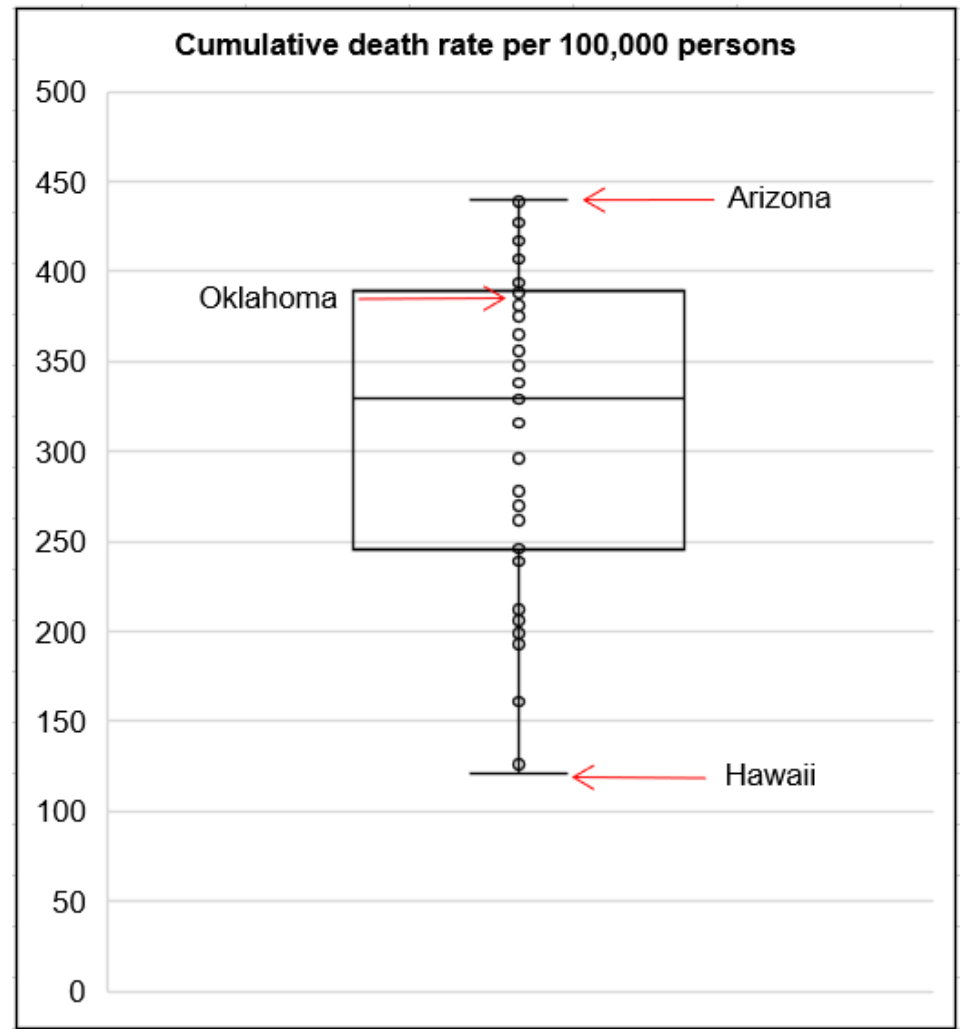
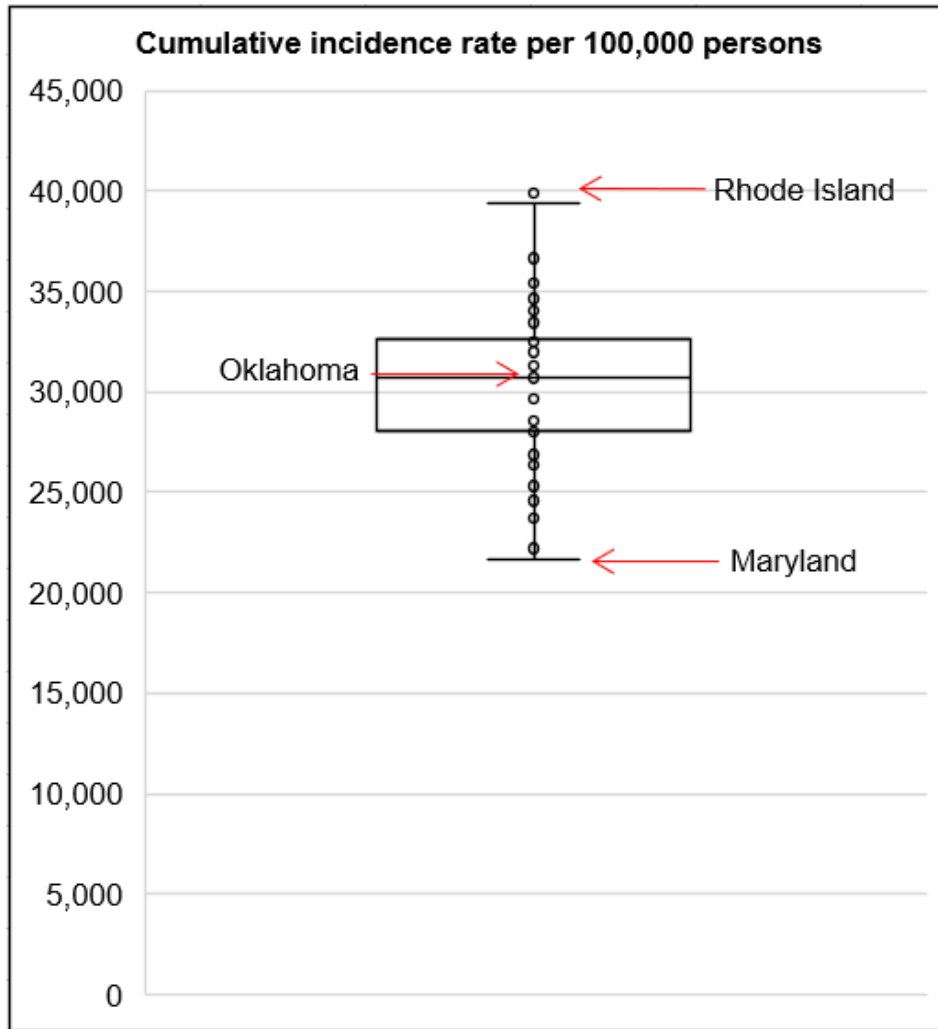

Weekly number of deaths (from all causes)

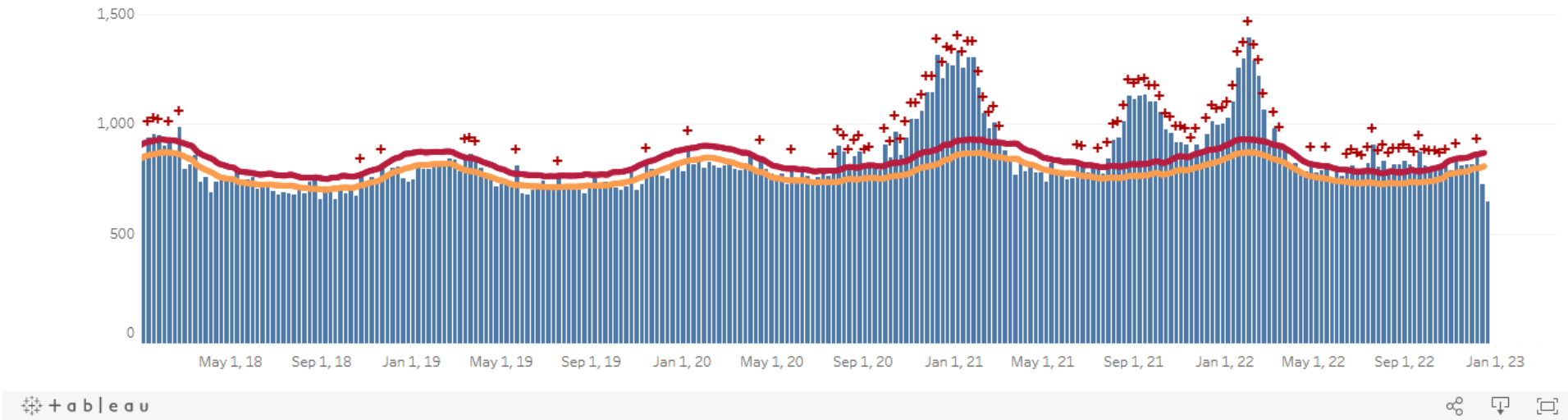
