## Maximum Allowable Clothing

Inmates being transferred from any state facility to another state or private facility will be transferred with all under garments, one state issued set of scrubs or one shirt and one pair of pants and allowable footwear. All other state issued items will remain at the facility unless otherwise specified on the matrix. All clothing items purchased through the canteen or through retail purchase will be transferred with the inmate.

Styles and colors for all personal clothing items (shirts, pants, undergarments, shoes, etc.) will be as approved by the clothing committee. Red, blue, and camouflage colored items are not allowed.

Attachment F is to be filled out by private contract halfway house facilities only. When taking an inventorying of an inmate's clothing or property, Attachment F will be completed by staff and the inmate will sign.

All under garments will be exchanged in accordance with OP-030120. XII. B. 4.
