Facility Specific Criteria

1. <u>Bill Johnson Correctional Center</u>

No sex related convictions past or present (exceptions as approved by the administrator of Classification and Population).

Ages 18 to 40

Sentence Length:

- a. 15 years non-violent
- b. 10 years violent
- c. Seven years for those with trafficking convictions and classified as non-violent
- d. No less than three years to serve or remaining to serve, unless court ordered, or with a parole stipulation.

Inmates with delayed sentences or inmates placed at BJCC for the general population unit do not have to meet the sentence length criteria.

Inmates must meet the Health Services placement criteria.

2. <u>Enid Community Corrections Center</u>

Inmates currently serving a violent offense will not be eligible.

May not have more than one prior conviction for a violent crime or deemed dangerous, assaultive or violent.

3. <u>James Crabtree Correctional Center</u>

No younger than 37 years of age for medium security.

No younger than 25 years of age for minimum security.
