#### **EXECUTIVE SUMMARY**

#### INTRODUCTION

Pursuant to <u>26 O.S.</u> § <u>3-130</u>, State Election Board Secretary Paul Ziriax directed forty-three (43) county election boards to conduct post-election manual tabulation audits of the Runoff Primary Election held on Tuesday, August 23, 2022.

The post-election audits were conducted November 29-30, 2022, and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit in advance. Additionally, the State Election Board notified the public about the upcoming post-election audits on its website and through the State Election Board's electronic news delivery system.

The post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board. Each post-election audit included a manual tabulation of votes cast in each race that was audited.

Participating precincts and races were randomly selected for the post-election audits. Additionally, two candidate-requested recounts of the August 23, 2022, election are also included in this report.

The results of each manual post-election tabulation audit confirmed the certified election results. The post-election audit identified zero differences compared to the certified election results.

#### RECOUNTS

Following the Runoff Primary Election held on August 23, 2022, a candidate-requested hand recount was conducted by the Mayes County Election Board for the Mayes County Commissioner, District 1 race. The recount confirmed the results of that election.

A candidate-requested hand recount was also conducted by the Tulsa County Election Board for the City of Tulsa, City Council, District 7 race. The recount confirmed the results of that election.

#### BACKGROUND
