#### Methods

Study Population - Current and Former Caregivers, Paid and Unpaid

Study Period – March 1-31. 2022

Mode – Online Survey, Referral

#### **Participants**

346 responded to the survey. 55 out of the 77 Oklahoma counties participated in the survey.

#### **Impact on Health**

Health of the Caregiver, Unpaid and Paid, Physical Health, Impact on Physical Health and Emotional Stress.

#### **Experiences Unpaid Caregiver**

Toll from being a caregiver, coping mechanisms, level of stress.

#### **Resources Unpaid Caregiver**

Have Necessary Information/Resources, Source of information, Received Information.

#### **Paid Caregiver**

Emotionally Stressful, Received Training, and Have Necessary Training.

#### **Resources and Training**

Unpaid Caregivers – Additional Support/Resources Needed

#### Be a Neighbor:

#### Morgan Fitzgerald/ Madelyn Maxwell

**Madelyn** – Met with Be a Neighbor – Through an innovative platform, "Be a Neighbor" seeks to identify and strengthen collaboration among Oklahoma's non-profits, faith-based groups, and community organizations across the state's 77 counties.

Madelyn demonstrated through slides how to navigate through the website and how to find resources that are needed.

**Morgan** – All OSDH Community Health Workers are currently utilizing "Be a Neighbor". Morgan explained how the system was used, how to find resources and the map feature. System was originally built for DHS for the Foster program. More State agencies are being encouraged to use this site.

Morgan recommends everyone go in and put themselves in as a seeker. It will also be included in the State Plan saying that we will promote this program. The public can also use this platform.

**Dr. Odenheimer** - Asked if there was an information regarding volunteer opportunities.

**Morgan** - Yes! There is an Event area that anyone can add an event. There is a volunteer tab/button under Volunteer Registration.

**Dr. Odenheimer -** Asked what if people were looking for volunteers?

**Morgan** – Morgan said she will find out the answer to that question. The focus has been primarily on the Resources aspect at this point.

**Madelyn** – There are routine check to make sure the home health care agency or organization is still in business.

**Morgan** – The website is completely free of charge for all users. This website is 100% funded by the State of Oklahoma for now. That may change as the website expands.

If there is any changes or updates that someone see's they are willing to work with us to make changes.

**Maggie**— How does this look for caregivers who may or may not have fully connected somewhere yet and are searching for resources and how they might get there or might hear about it? What efforts is the State leading for the usage of "Be a Neighbor"?

**Morgan** – Answered that we are going to get that out to Senior Services, and we will go out and share information. We are the promotion aspect. We will be promoting this to Senior Services and to our caregivers.

**Nadine** – On the caregiver website Okcares.org it is very much the same thing, putting resources out for family caregivers that are supporting individuals across their lifespan. Nadine would really

like to partner with "Be a Neighbor". Caregivers need to be met where they are at. Being in several places is a good thing. Resources should be on OKcares.org as well for exposure.

Morgan – We can help promote both and is a good thing. Morgan and Nadine will discuss this topic future.

**Morgan** – There is a program at the University of South Carolina that has created a 5-module program that can be used for general public, health care professionals, a dementia certificate is provided for their program. If we chose to do this, we would be the 2<sup>nd</sup> State to be doing this Statewide. The program is called Dementia Dialogs. They are willing give training showing how all of the 5 modules work. Then we can decide if we would like to have training to go out and do the same.

**Dr. Odenheimer –** Dr. Odenheimer said she would like to be part of this.

**Morgan** – Will open this up to the Coalition for anyone interested.

Morgan – Caregivers were upset that their loved one didn't have options if under the age of 60.

**Shelly** – Under 60 individuals really stood out at the conference. People living with dementia under 60 and their struggles. We really need to support this area and how these people are treated and how it makes them feel. Provide support.

**Morgan** – Asked Jacob or Maggie to help her get information about Oklahoma's support group over to Rhonda.

Getting the chance to talk to other states was very helpful. It allowed for States to share their ideas and what works for them.

**Madelyn** – Attended the Conference virtually and has the link and will send to Morgan and Morgan will share with group.

**Morgan - Dementia** Friendly Program – We will be purchasing that license to so we can utilize the Dementia Friendly Program America. Morgan will send out a poll for anyone who would like to be part of that.

**Morgan** – There are research studies going on. Morgan asked everyone to share the fliers from her Monday emails. There are specific studies going on involving African American caregivers and providers for African Americans living with the disease. They are 2x's more likely to get the disease.
