Subchapter 3. Oklahoma Dental Loan Repayment Program 310:526-3-4 [AMENDED].

SUMMARY:

310:526-3-4. Updates changes to reflect current Medicaid eligibility as it relates to the Oklahoma Dental Loan Repayment Program by elimination of the age limitation used in the calculation criteria to determine what constitutes a Dental Health Professional Area and by adding the acceptance of dental loan repayment applications in person or online.

AUTHORITY:

INITIAL RULE IMPACT STATEMENT

TITLE 310. OKLAHOMA STATE DEPARTMENT OF HEALTH CHAPTER 526. DENTAL SERVICES

1. **DESCRIPTION:**

On June 30, 2020, State Question 802 was passed and became effective July 1, 2021, expanding adult dental Medicaid benefits. Proposed changes will ensure the Oklahoma Dental Loan Repayment Program (ODLRP) aligns with current Medicaid (SoonerCare) policy. The proposed amendment to OAC 310:526-3-4 updates changes to reflect current Medicaid eligibility as it relates to the Oklahoma Dental Loan Repayment Program by elimination of the age limitation used in the calculation criteria to determine what constitutes a Dental Health Professional Area and by adding the acceptance of dental loan repayment applications in person or online.

2. <u>DESCRIPTION OF PERSONS AFFECTED AND COST IMPACT RESPONSE:</u>

Dentists participating in the ODLRP and adult Medicaid (SoonerCare) recipients. There is no direct cost impact.

3. <u>DESCRIPTION OF PERSONS BENEFITING, VALUE OF BENEFIT AND EXPECTED HEALTH OUTCOMES:</u>

Dentists participating in the ODLRP and adult Medicaid (SoonerCare) recipients. Alignment with Medicaid policy increases access to care for adult dental Medicaid (SoonerCare) recipients.

4. <u>ECONOMIC IMPACT, COST OF COMPLIANCE, AND FEE CHANGES: COST OF COMPLIANCE AND FEE CHANGES:</u>

There is no direct economic impact associated with the proposed changes to the Oklahoma State Department of Health.

There is no direct cost or benefits associated with the proposed changes to the Oklahoma State Department of Health.

Increased access to dental health care for the adult Medicaid population.

There are no detrimental effects on public health and safety.

CHAPTER 526. DENTAL SERVICES

SUBCHAPTER 1. GENERAL PROVISIONS

310:526-3-4. Procedures for administering the Program

The Program shall develop dental loan repayment procedures as may be necessary to carry out the administration of the Program. The Program shall delineate the following procedures:

- (1) Dental Health Professional Shortage Areas (DHPSA). Dental health professional shortage areas for Oklahoma shall be established by the Commissioner using the following criteria.
 - (A) The percentage of Medicaid enrollees receiving dental services each year.
 - (B) The ratio of the number of Medicaid enrollees under the age of 21 per Medicaid dental provider.
 - (C) The ratio of the number of Oklahoma residents in the general population under age 21 per Oklahoma licensed general practice or pediatric dentist.
- (2) Applications. All interested new dental school graduates shall file an application with the Department. This application can be submitted at any time during the year. Applications are available in the Dental Service office of the Oklahoma State Department of Health, in person or online.
- (3) Approval by the Department. Applications are reviewed by the Advisory Committee. Following this review, the Advisory Committee forwards their recommendations to the Department. Applications are approved or declined as determined by the Department.
- (4) Renewal of loan repayment contracts. The original loan repayment contract may be renewed for up to a total participation in the Program of five (5) years, contingent upon funding from the Legislature and continued approval of the Department based upon the dentist's performance and recommendations of the Advisory Committee if requested.
- (5) Advisory Committee. The Department will appoint and convene an Advisory Committee to assist in the dental loan repayment process. The Advisory Committee includes five (5) members with representation from the Oklahoma Dental Association, the University of Oklahoma College of Dentistry, the Oklahoma Health Care Authority, the Oklahoma Board of Dentistry, and the Oklahoma oral health coalition. The Advisory Committee is responsible for reviewing the eligible applicants, as determined by the Department, and making recommendations to the Department. The Department makes the final selection of Program participants.
