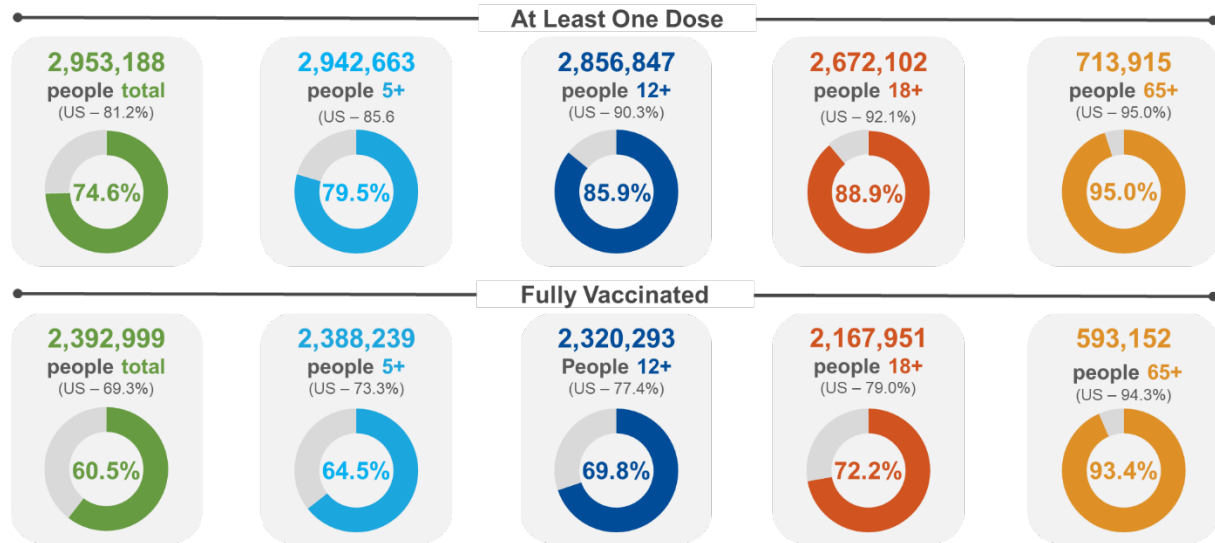

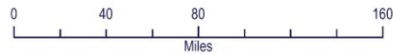

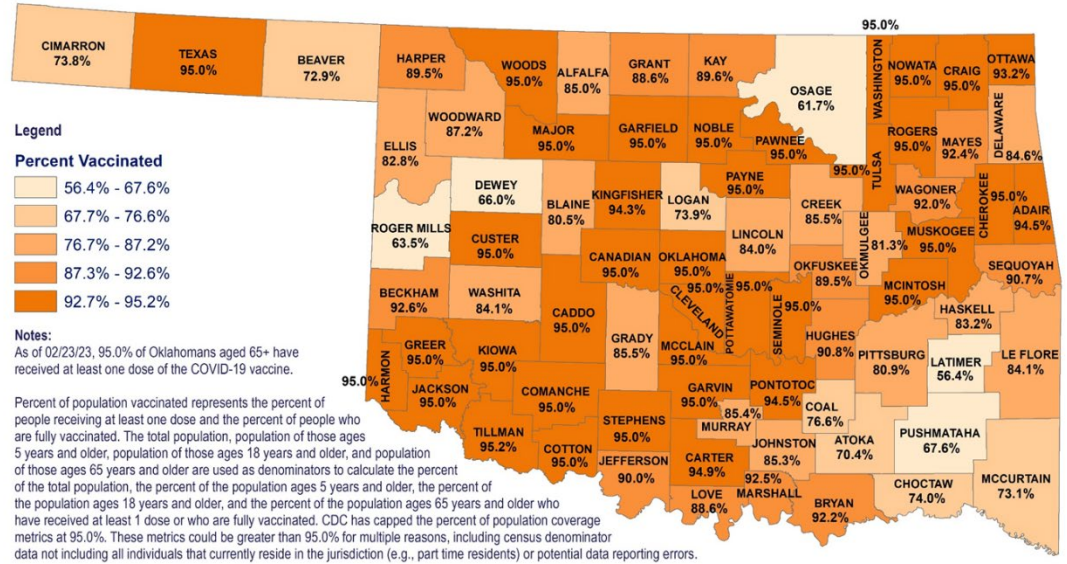

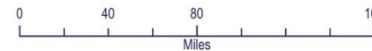

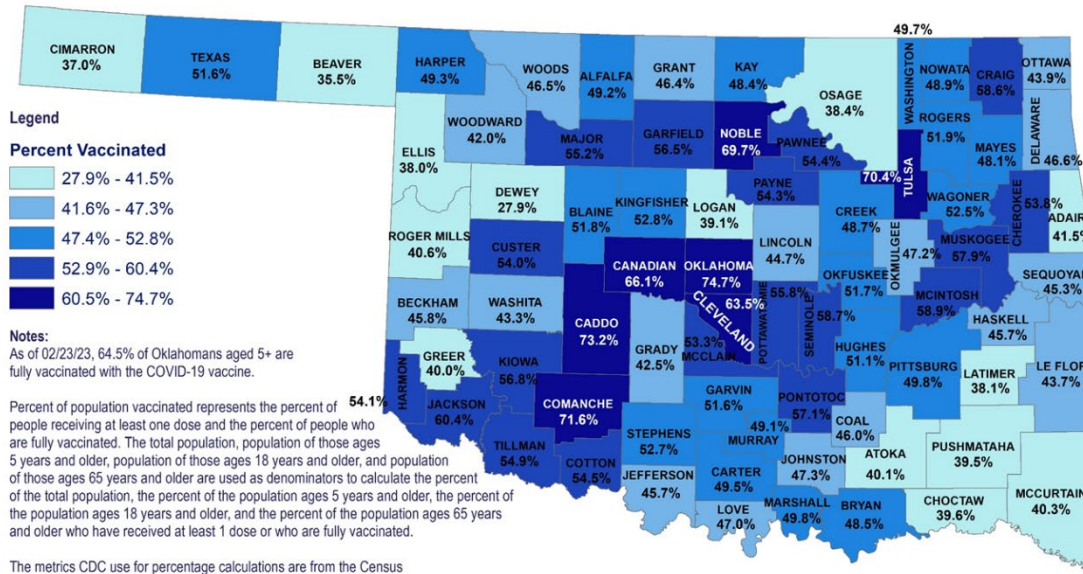

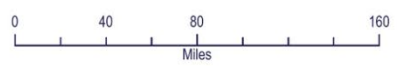

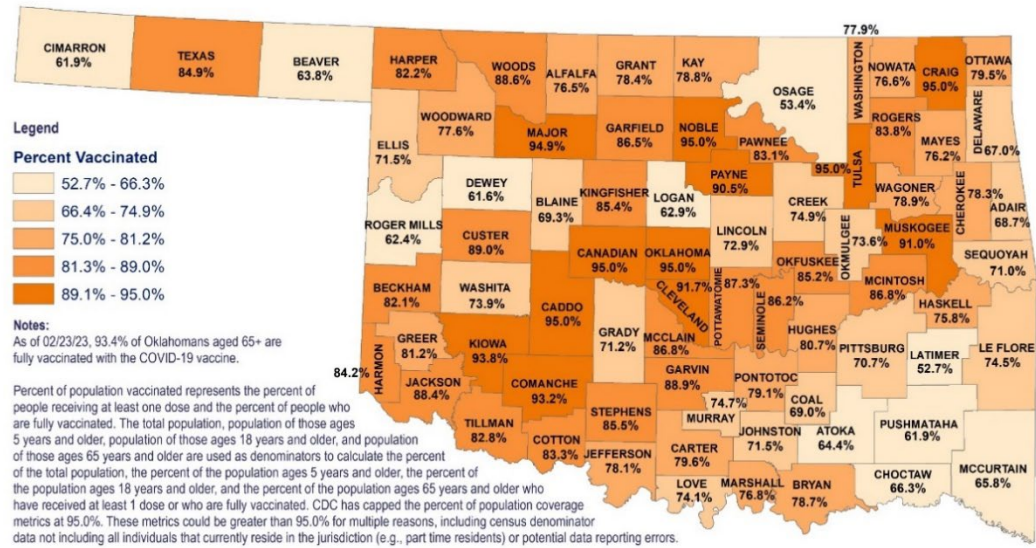

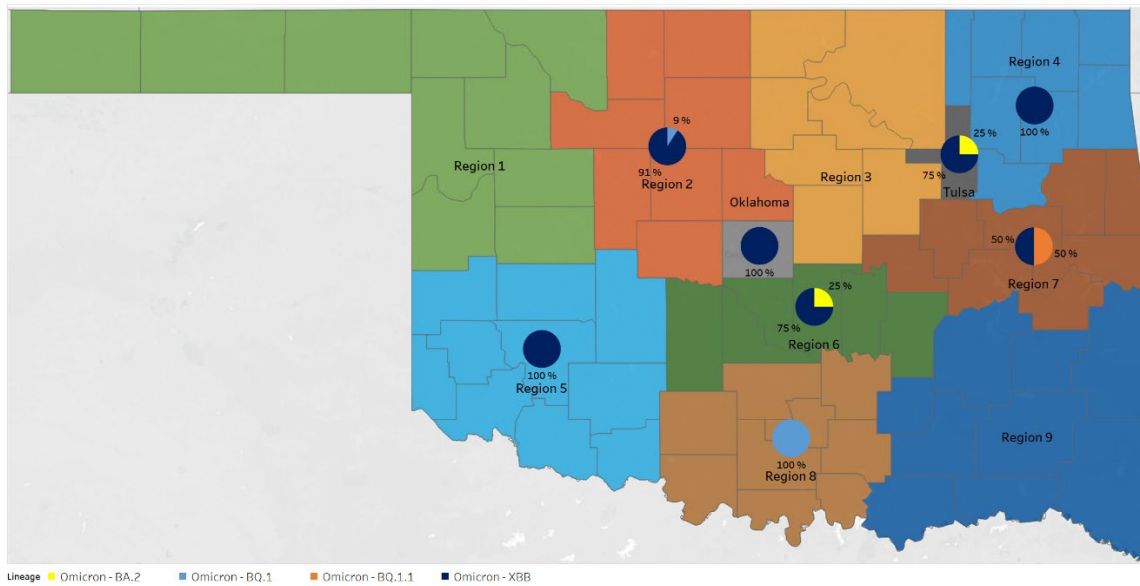

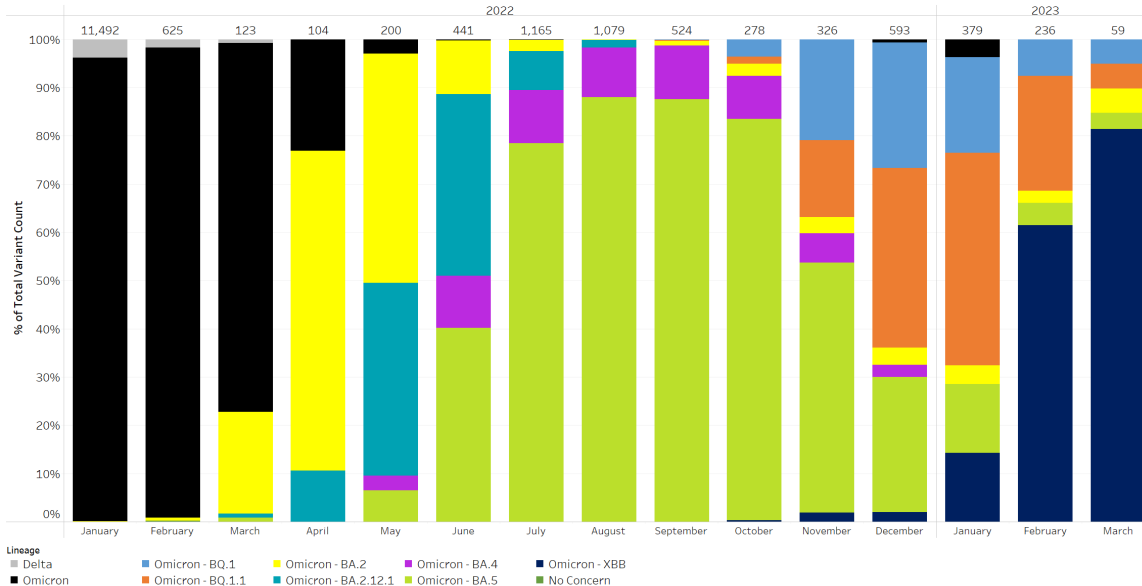
Variant Proportions by Region, Dates of Specimen Collection: March 3, 2023 - March 12, 2023, (N=35):

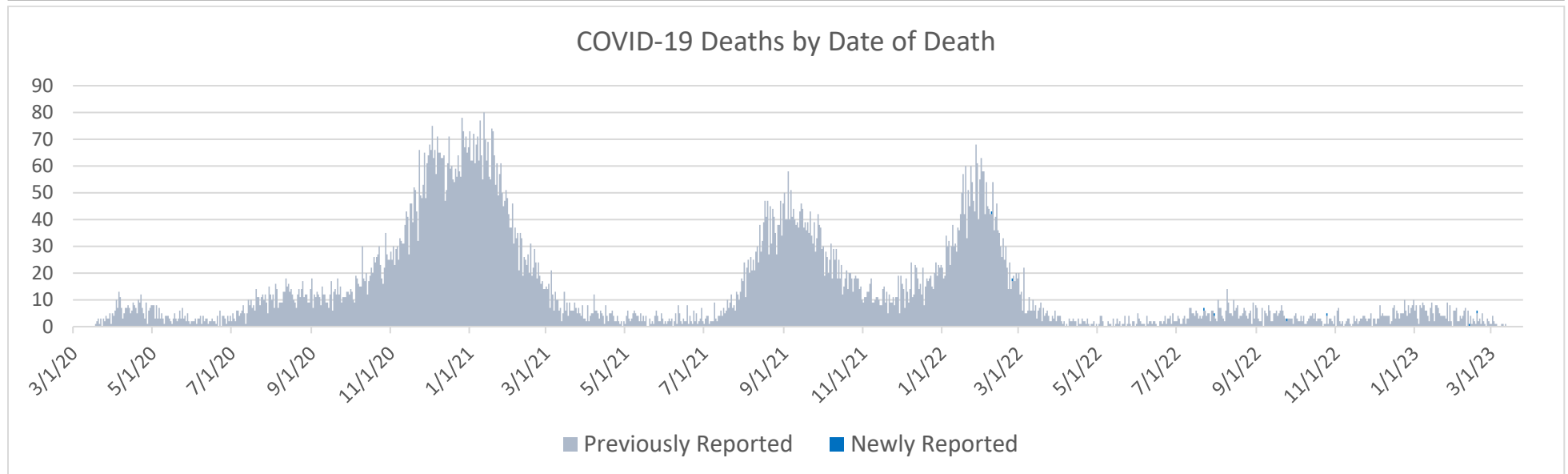
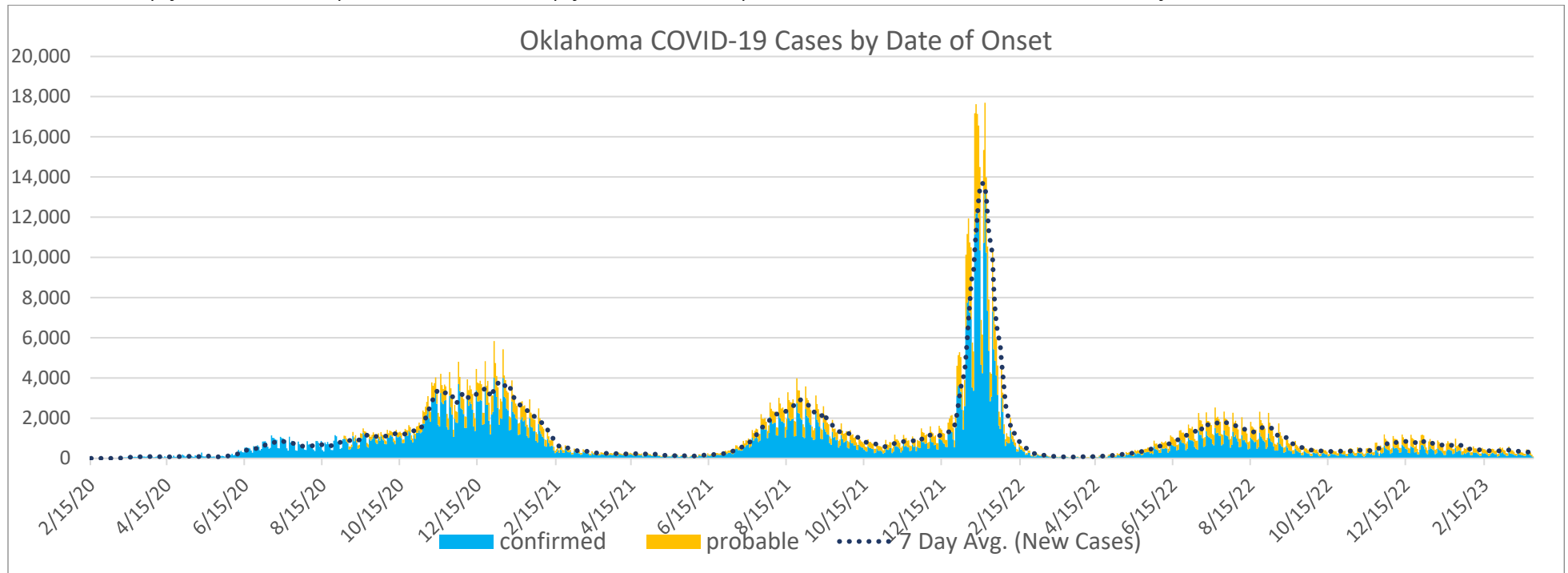
Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - March 28, 2023 (N=17,624)

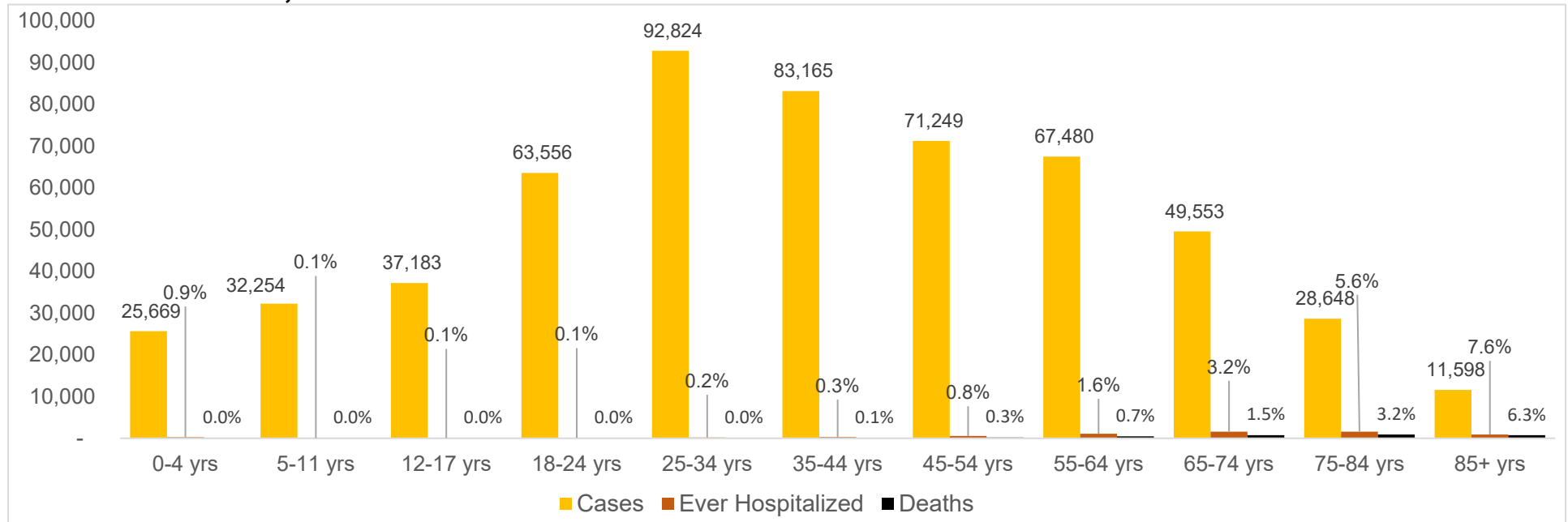

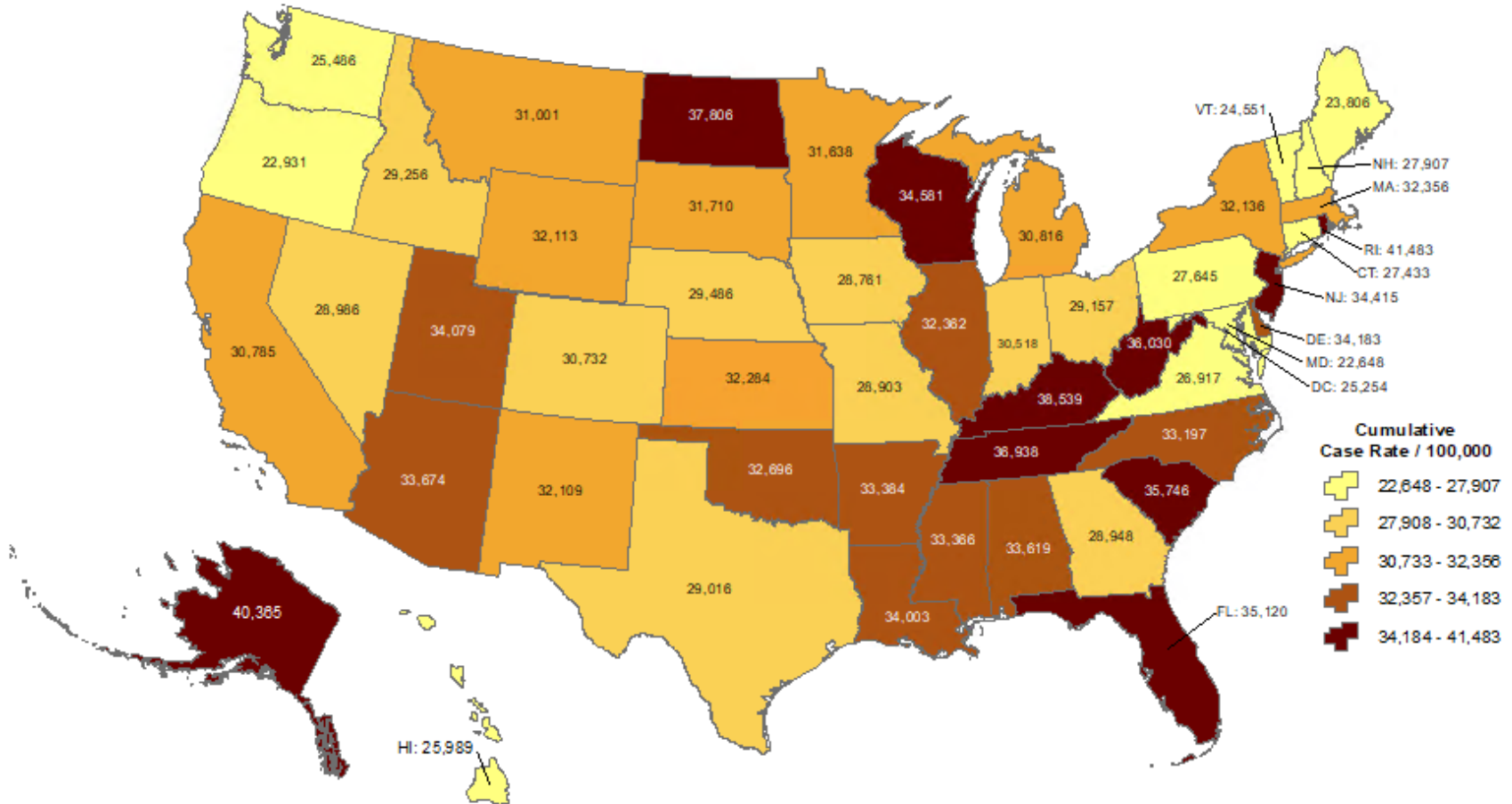
2022-2023 CASES, PERCENT HOSPITALIZED AND DEATHS BY AGE GROUP

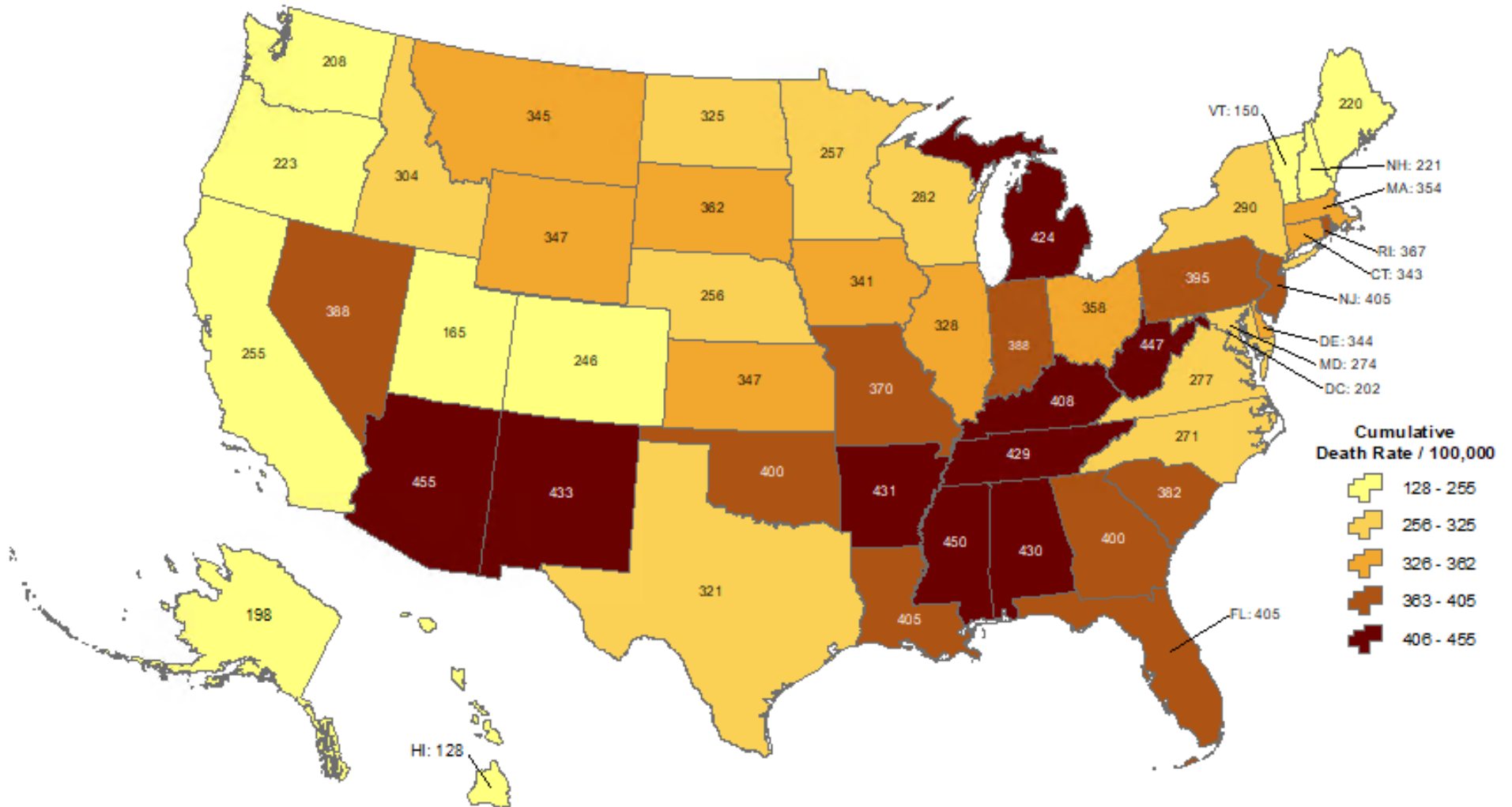

Cumulative death rate of reported COVID-19 cases

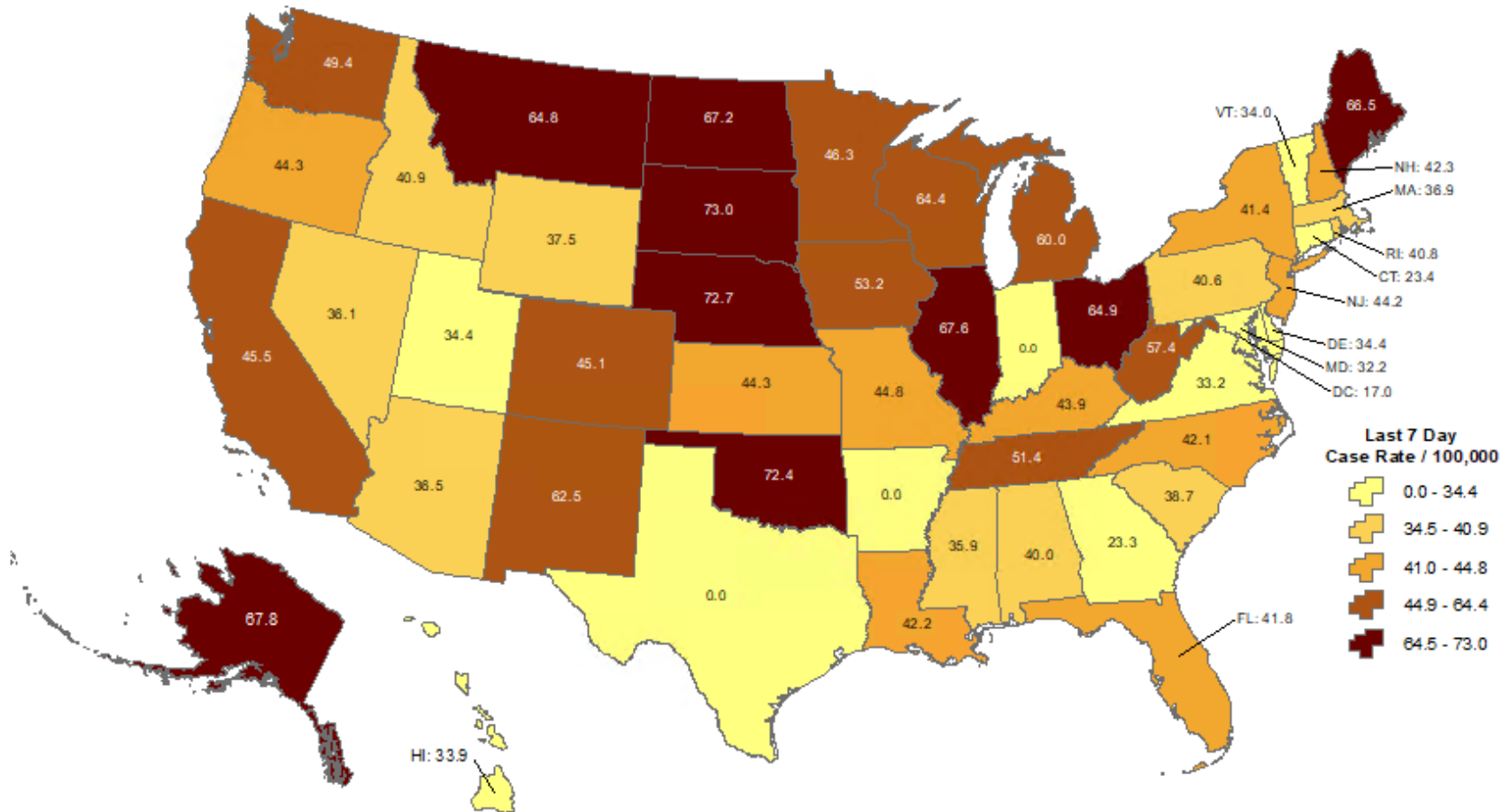

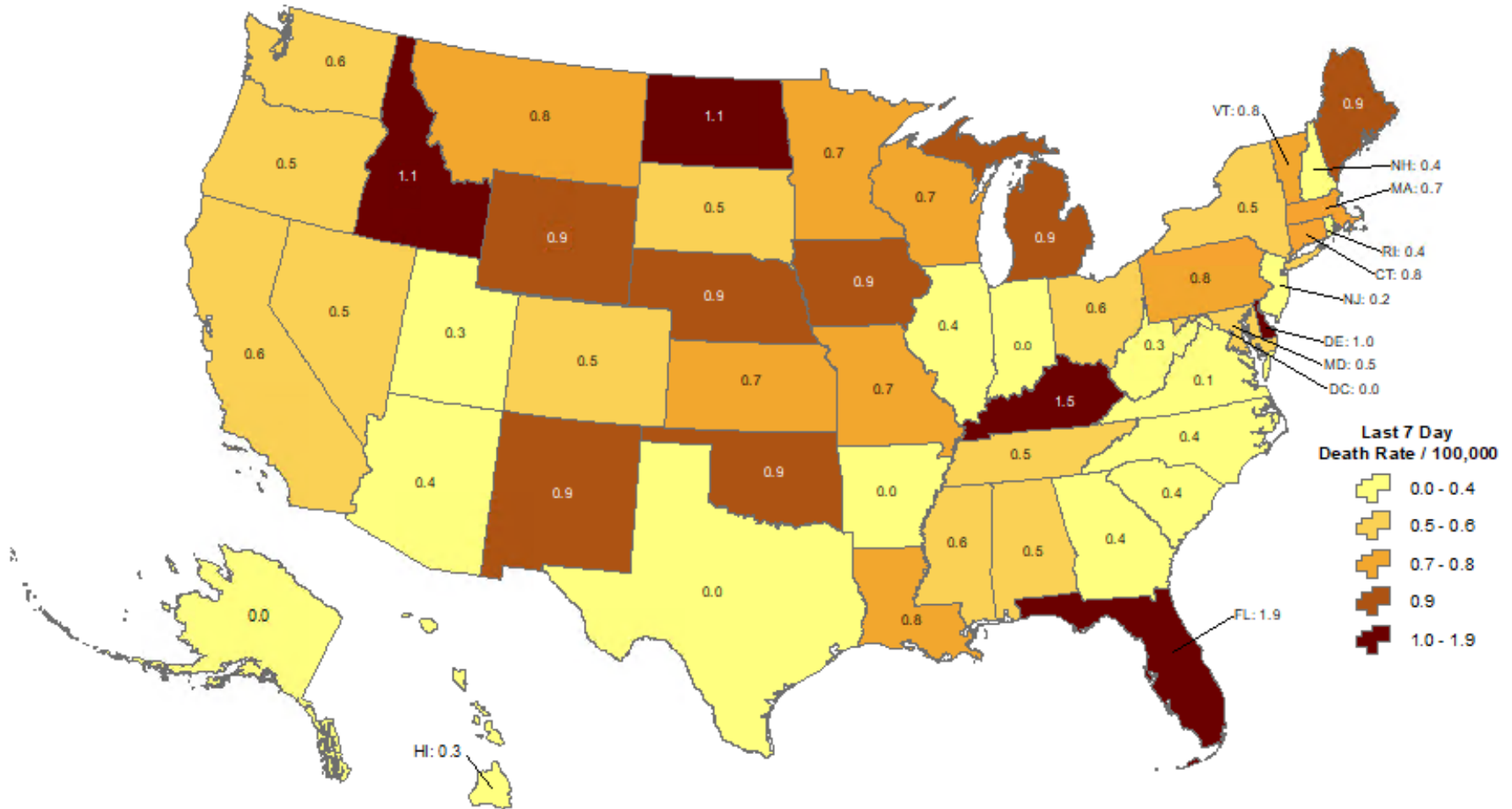

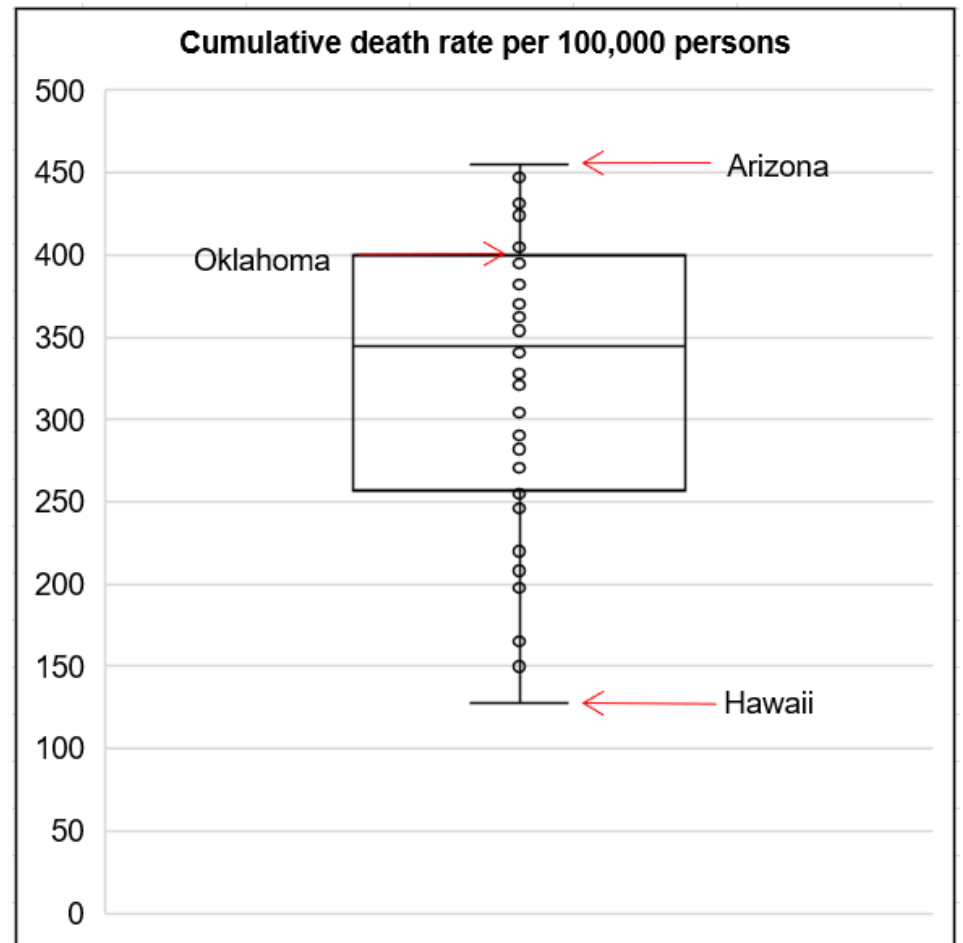
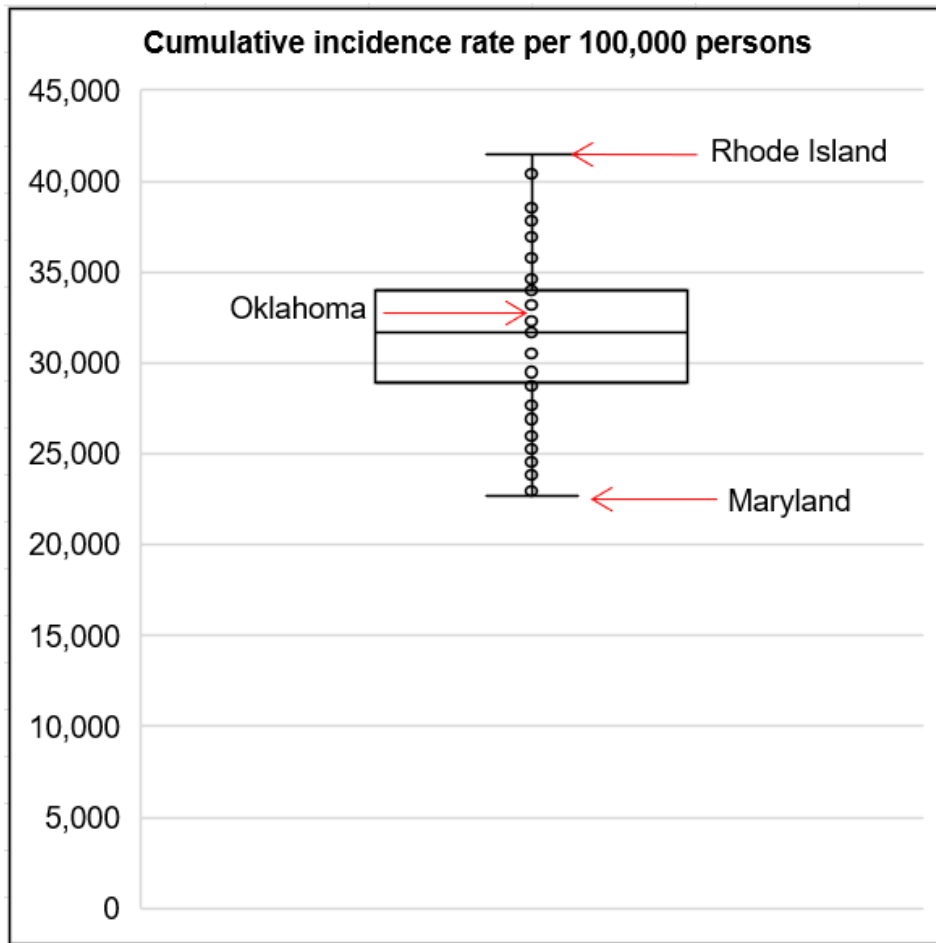

Weekly number of deaths (from all causes)

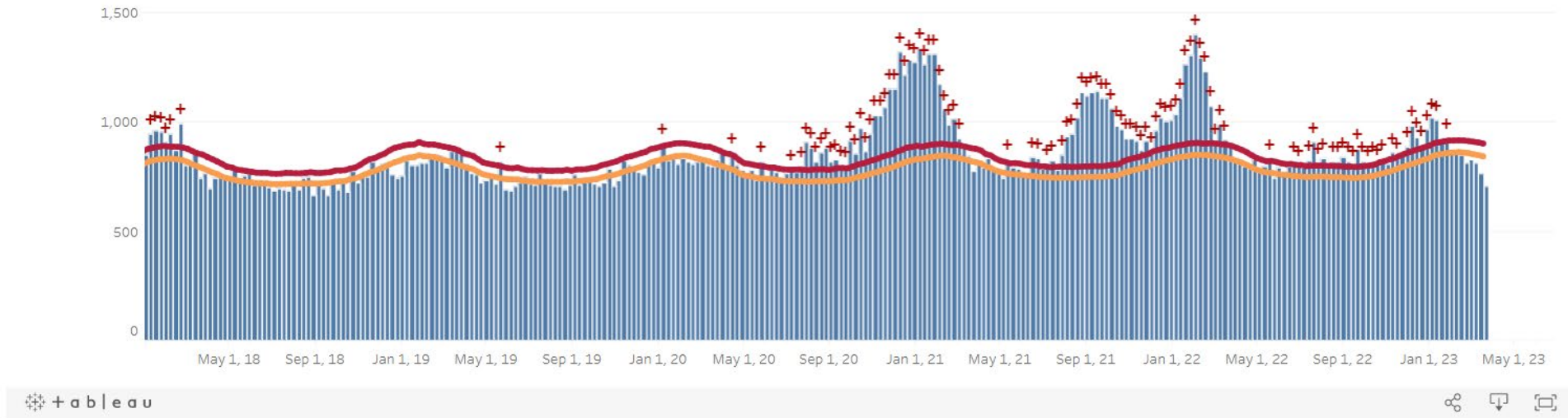
