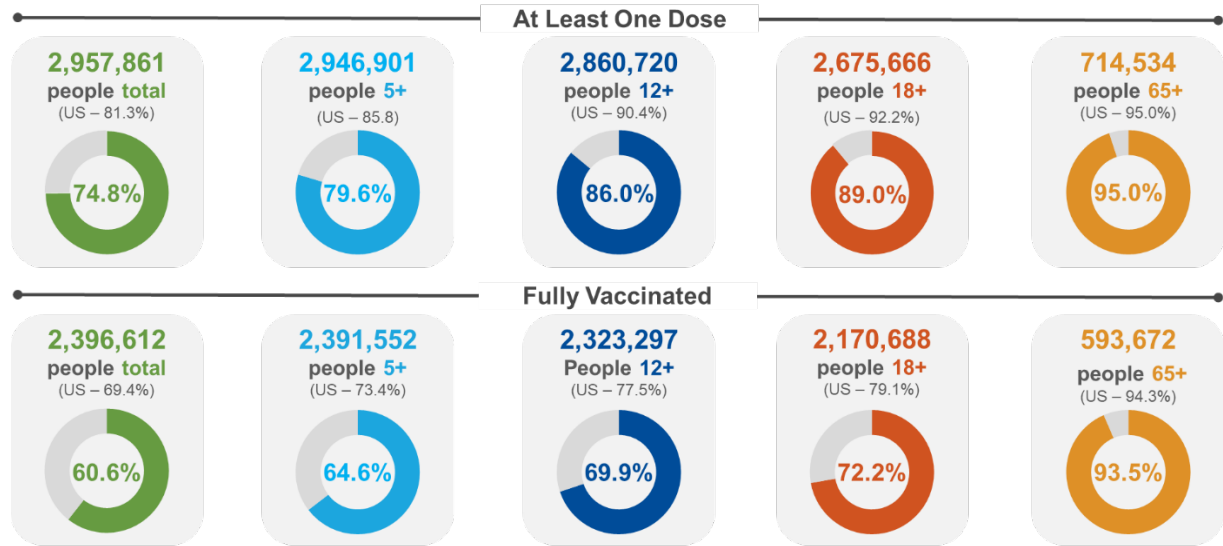

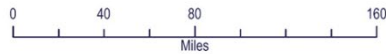

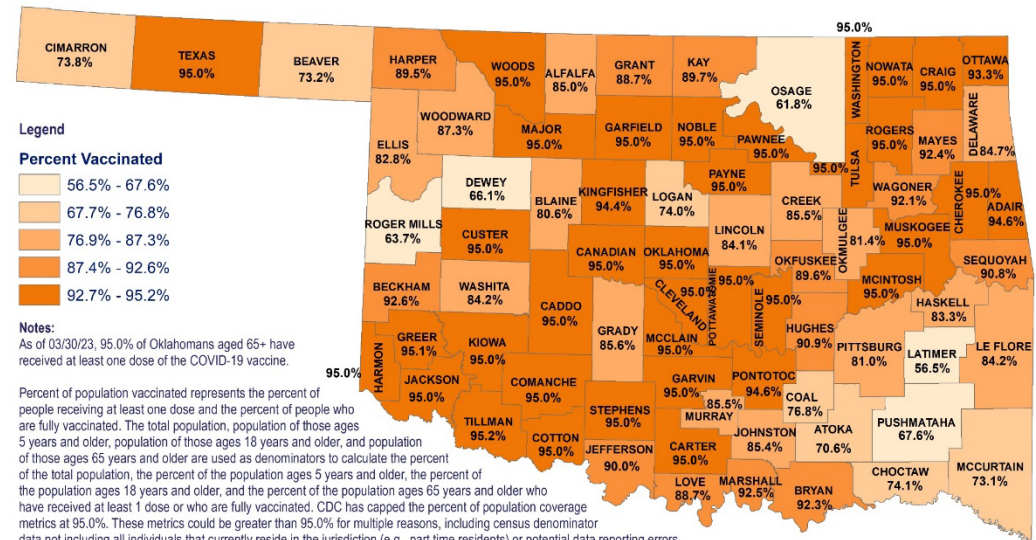

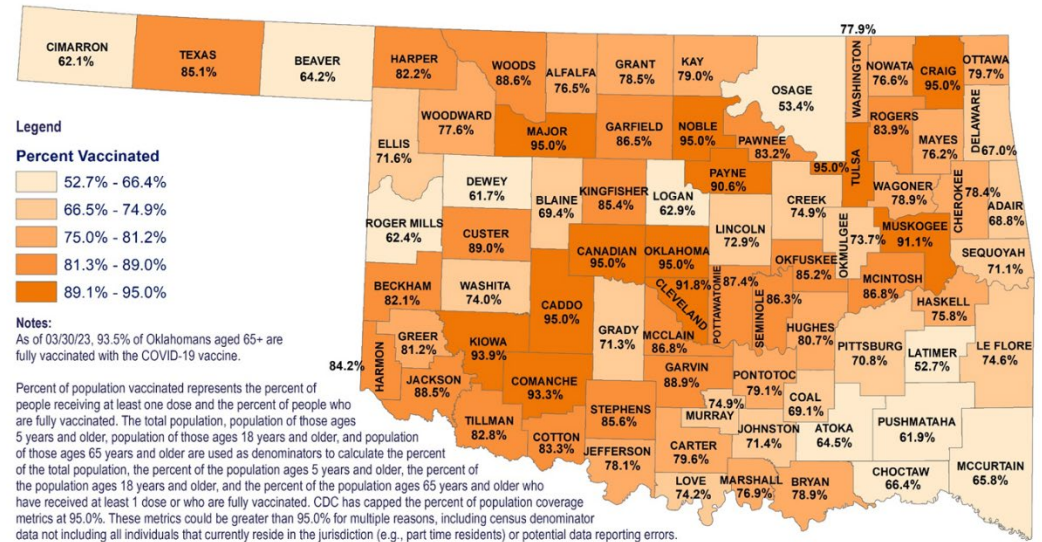

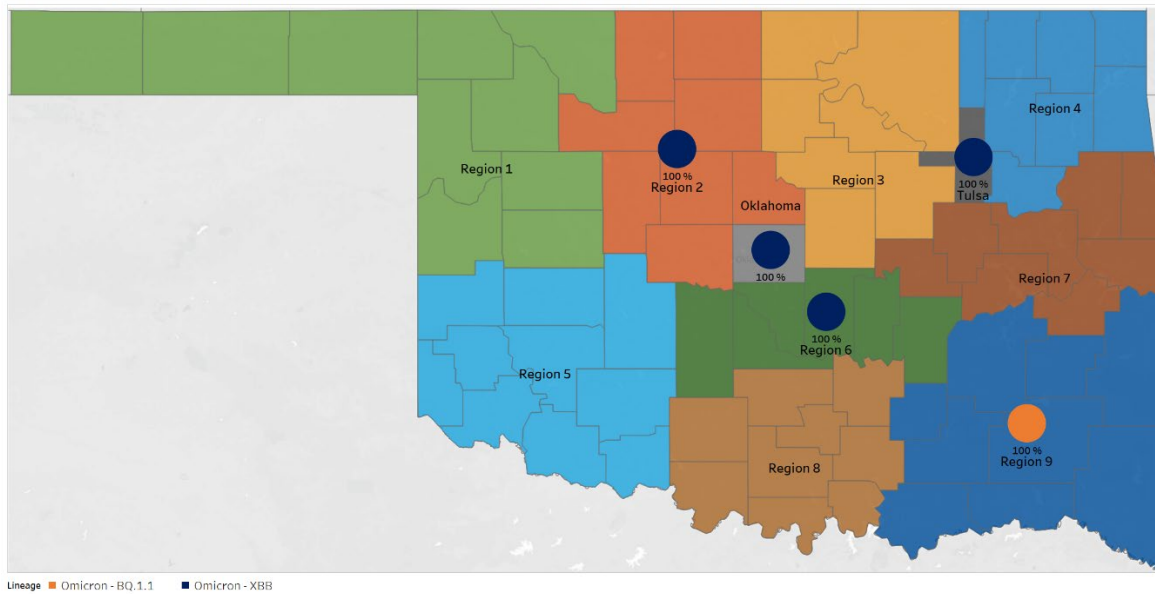

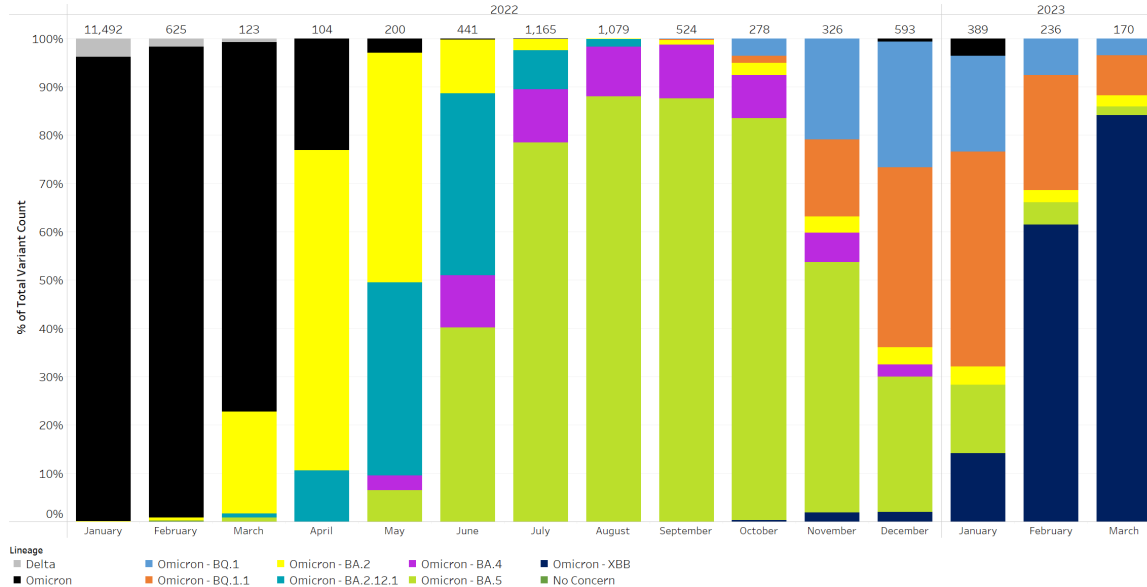
Variant Proportions by Region, Dates of Specimen Collection: March 11, 2023 - March 20, 2023, (N=6):

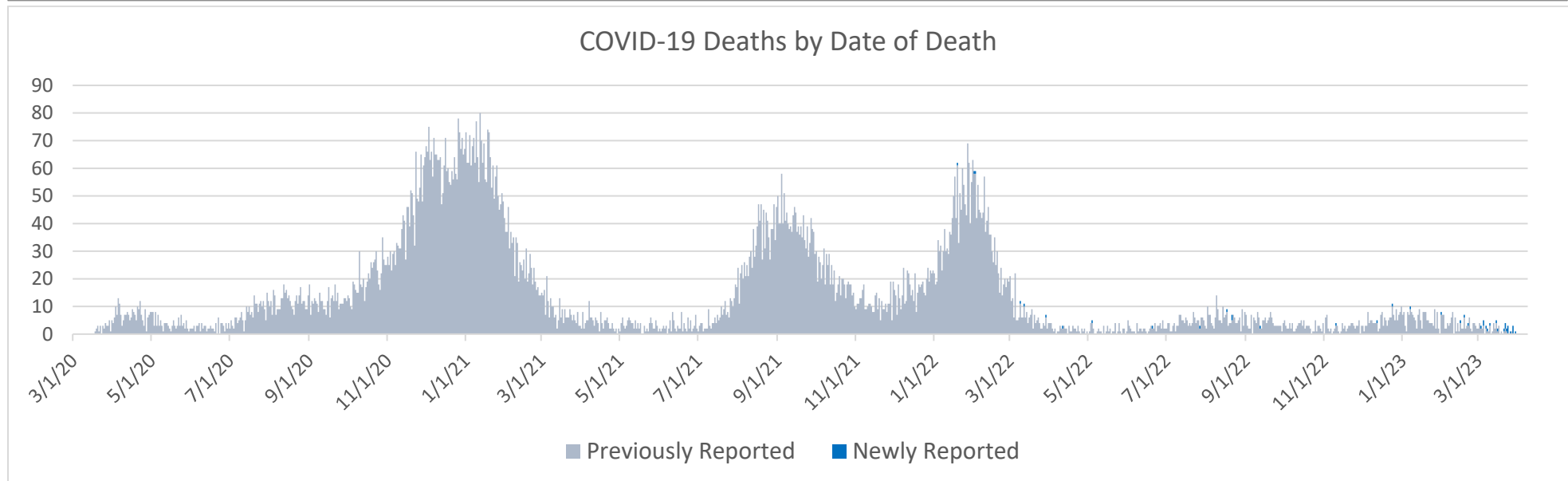
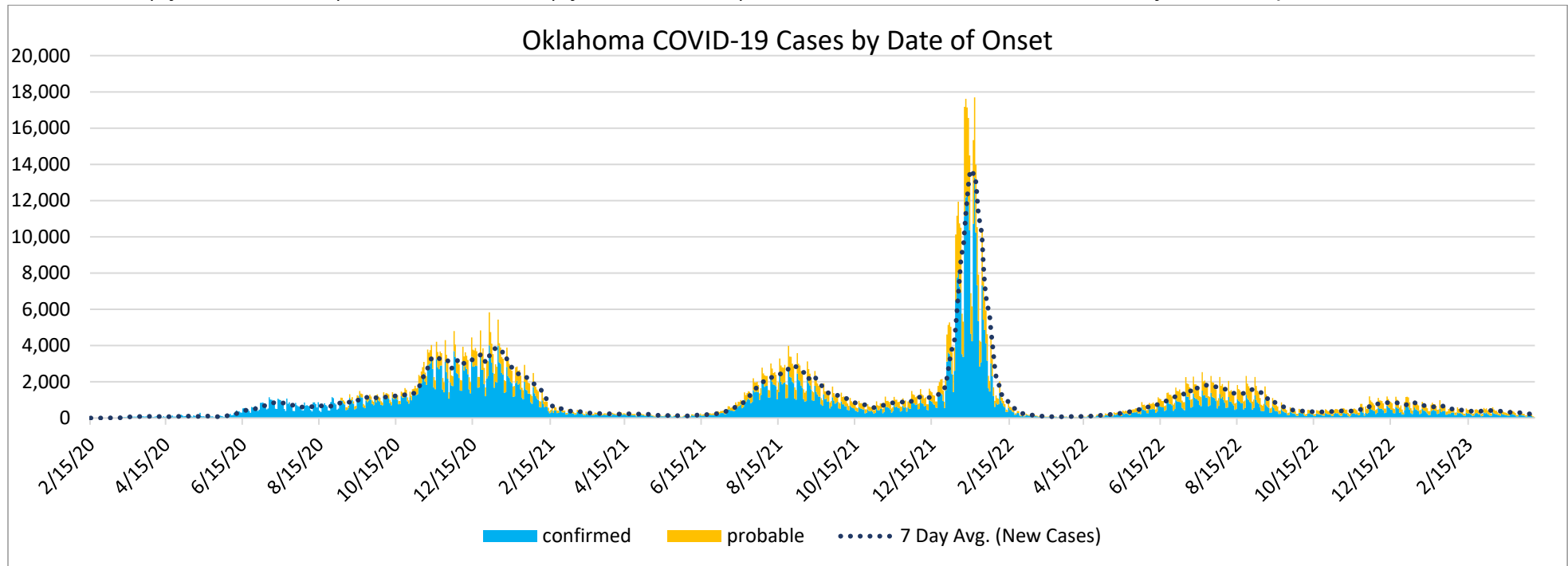
Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - April 10, 2023 (N=17,745)

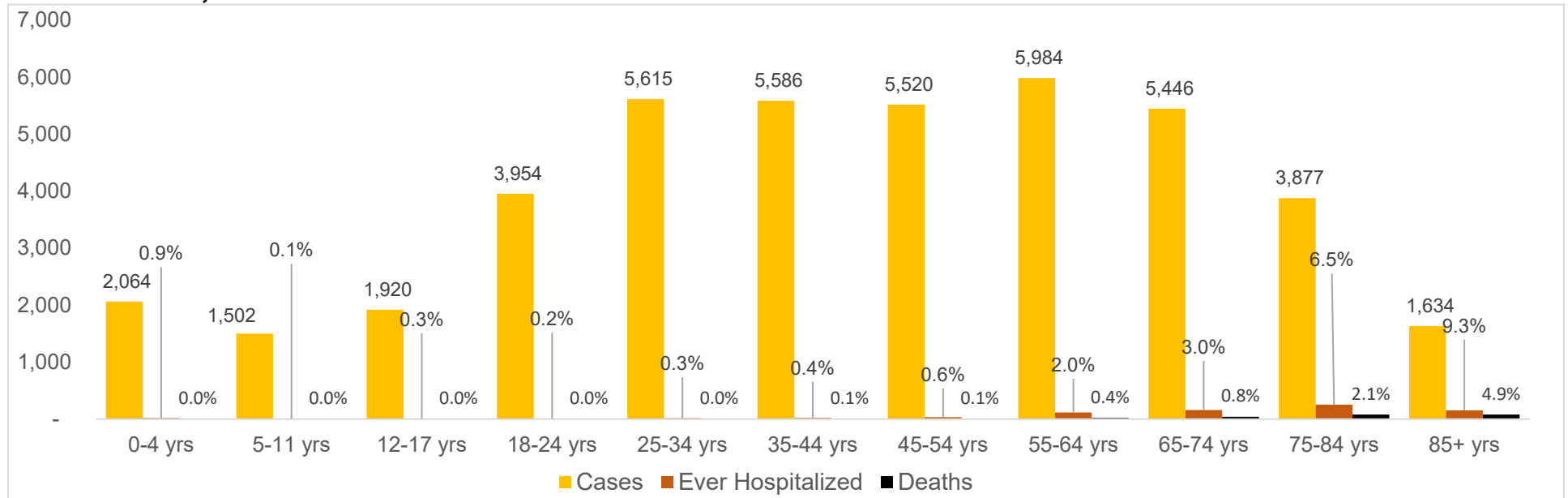

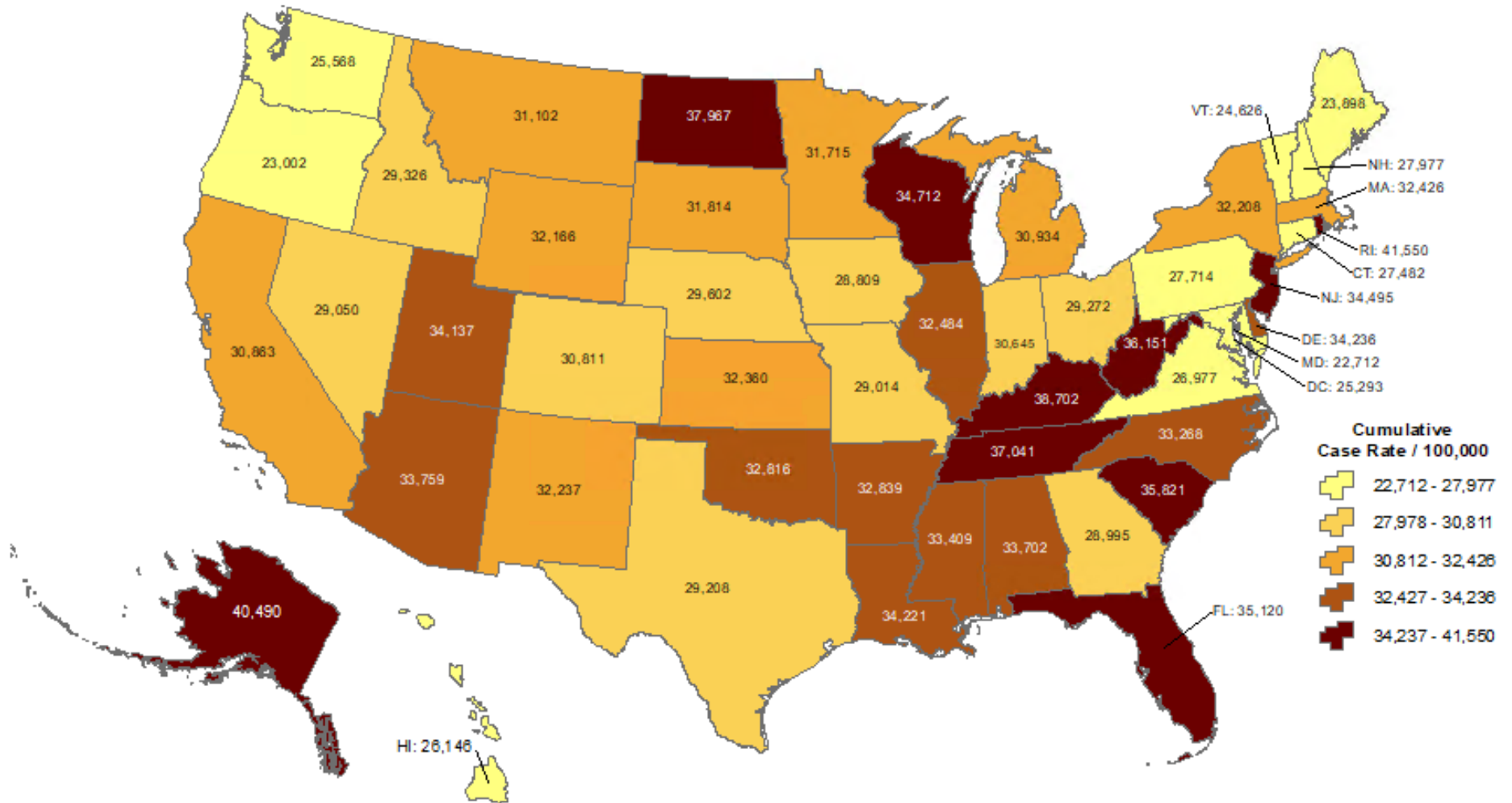
2023 CASES, PERCENT HOSPITALIZED AND DEATHS BY AGE GROUP

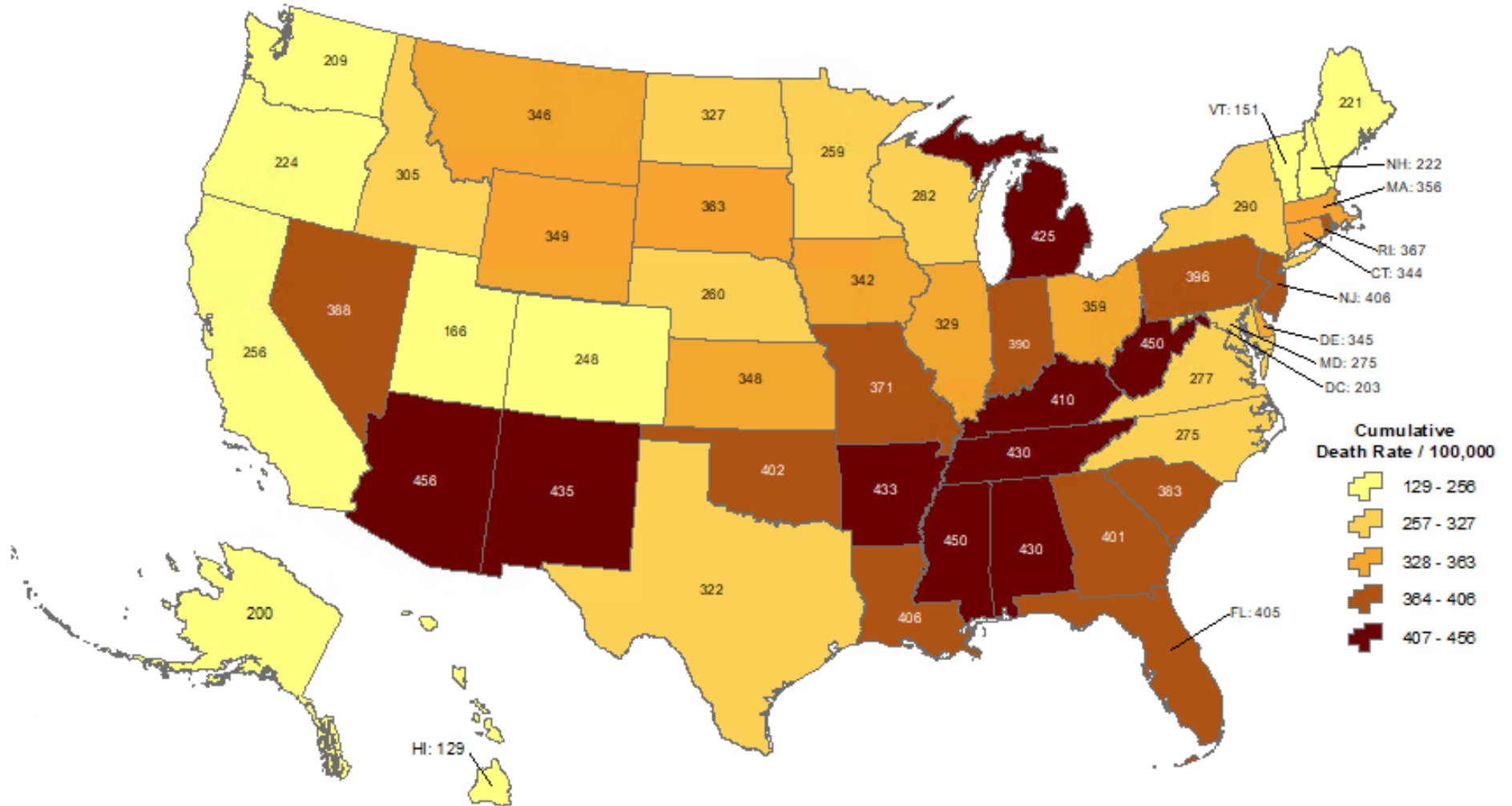

Cumulative death rate of reported COVID-19 cases

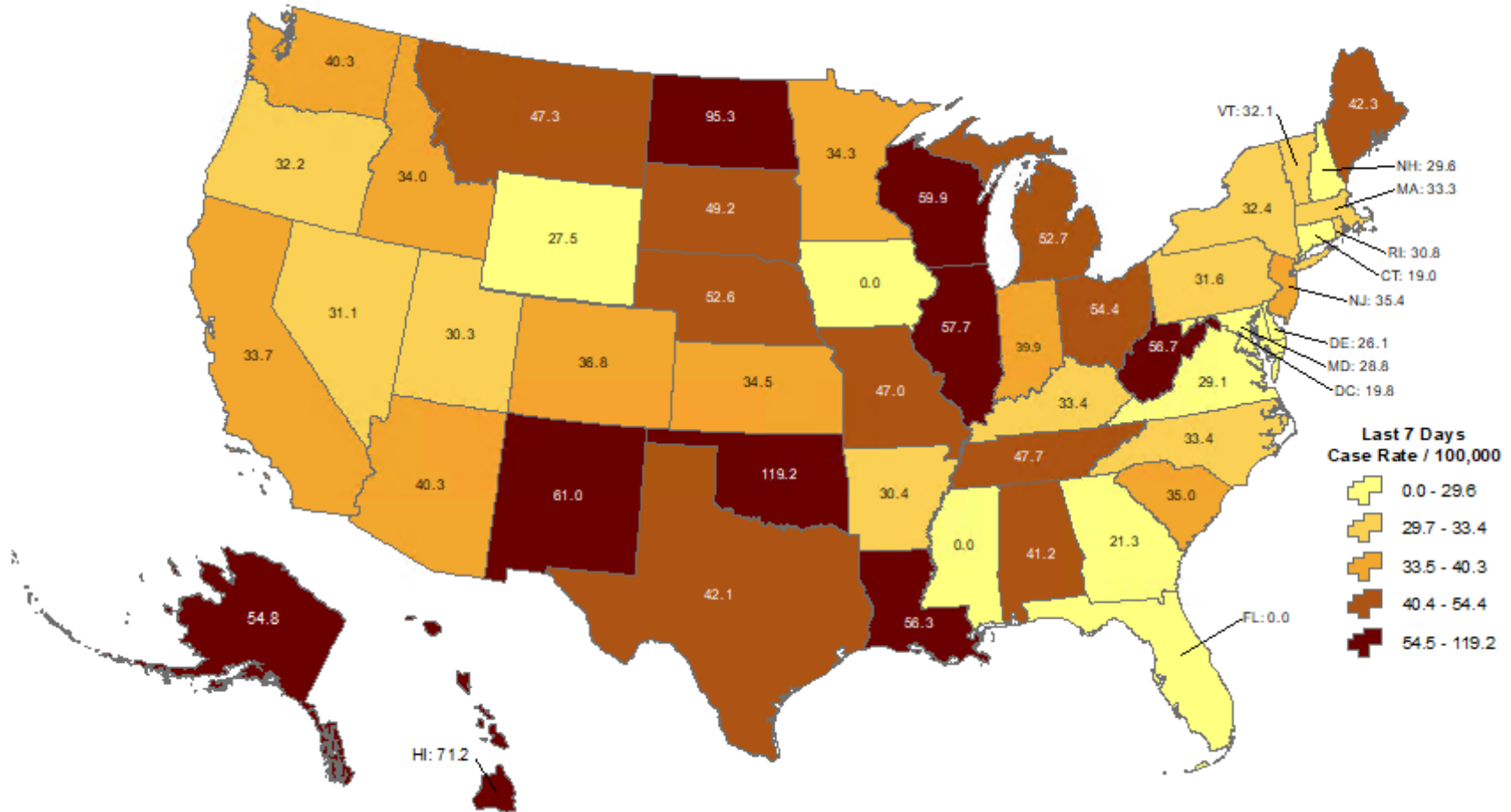

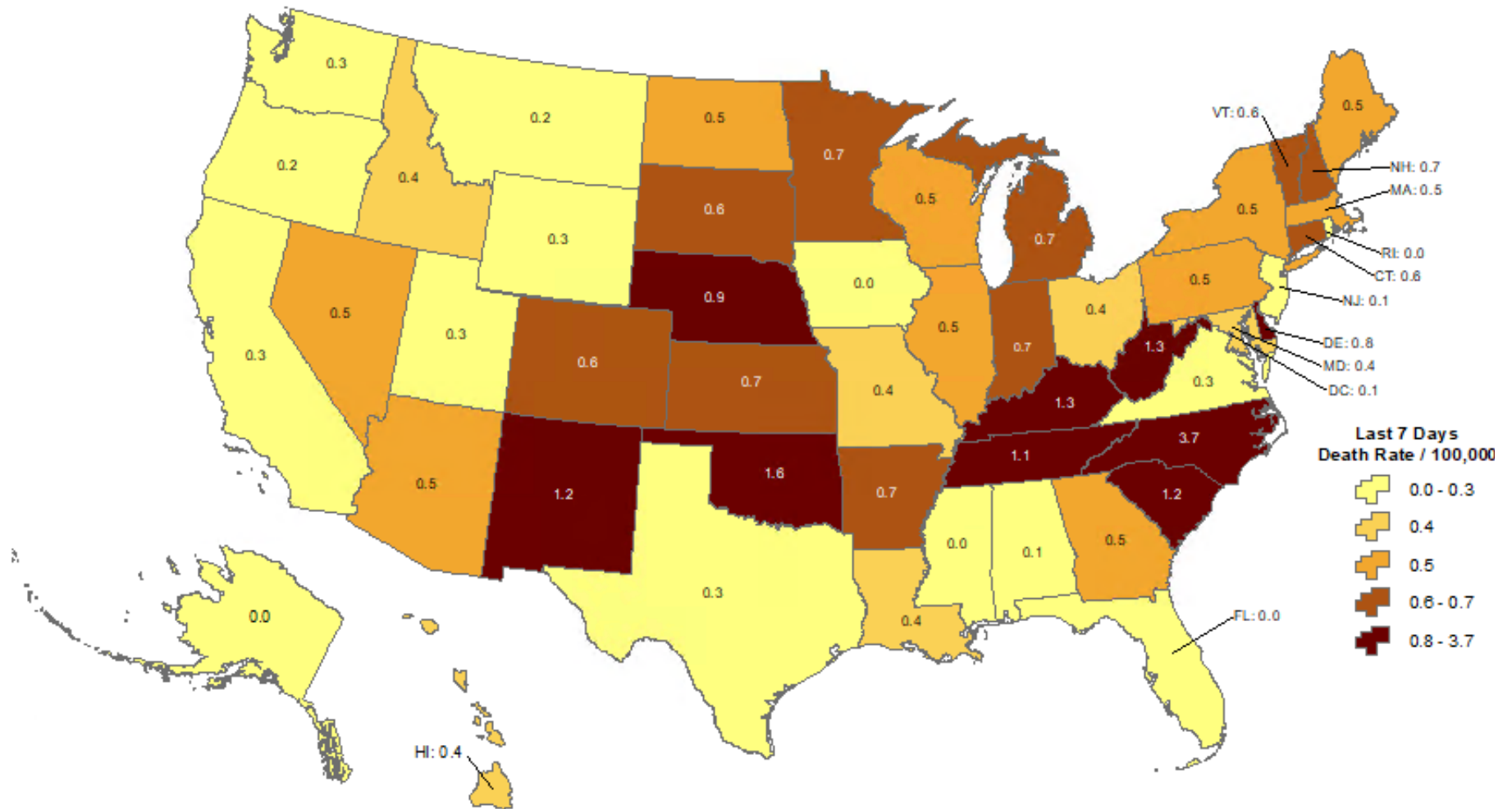

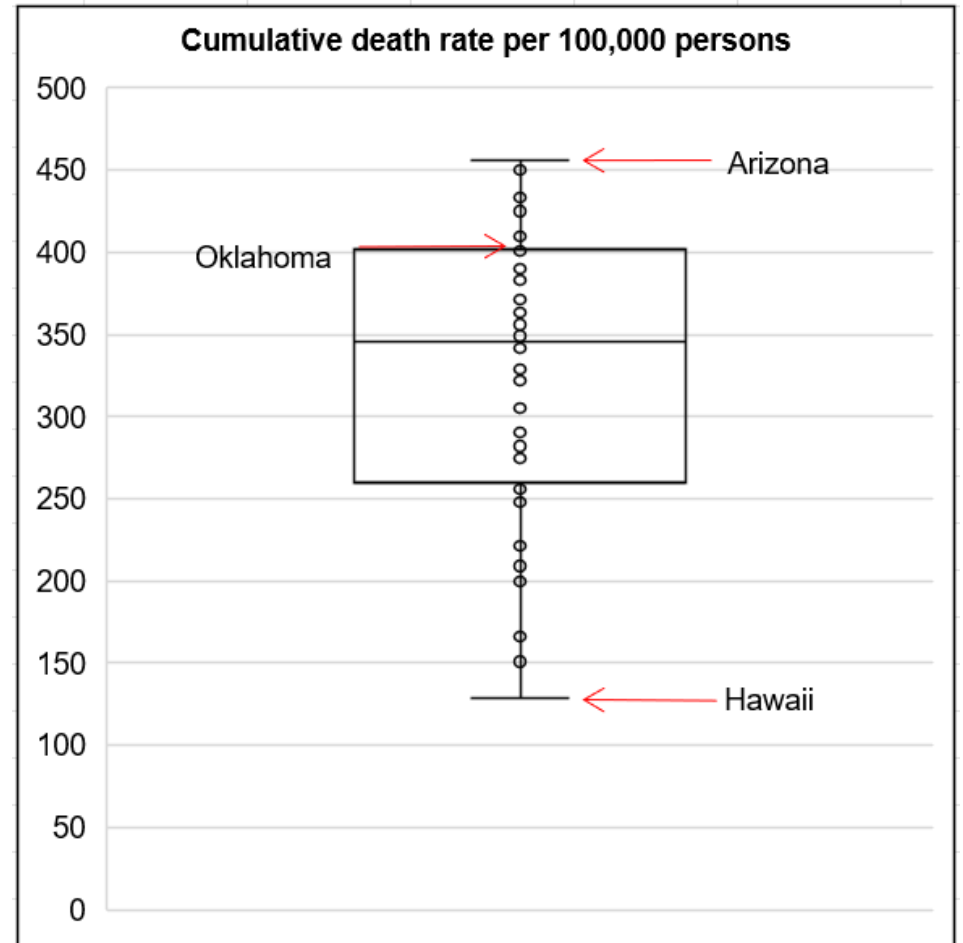
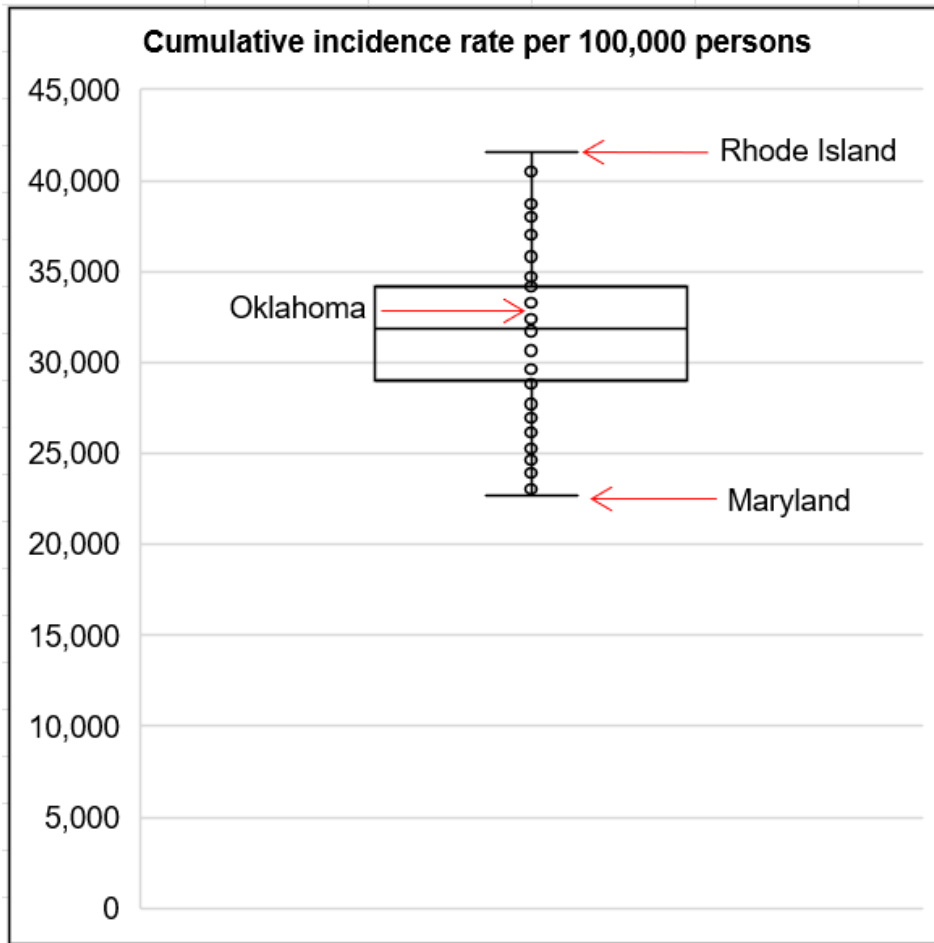

Weekly number of deaths (from all causes)

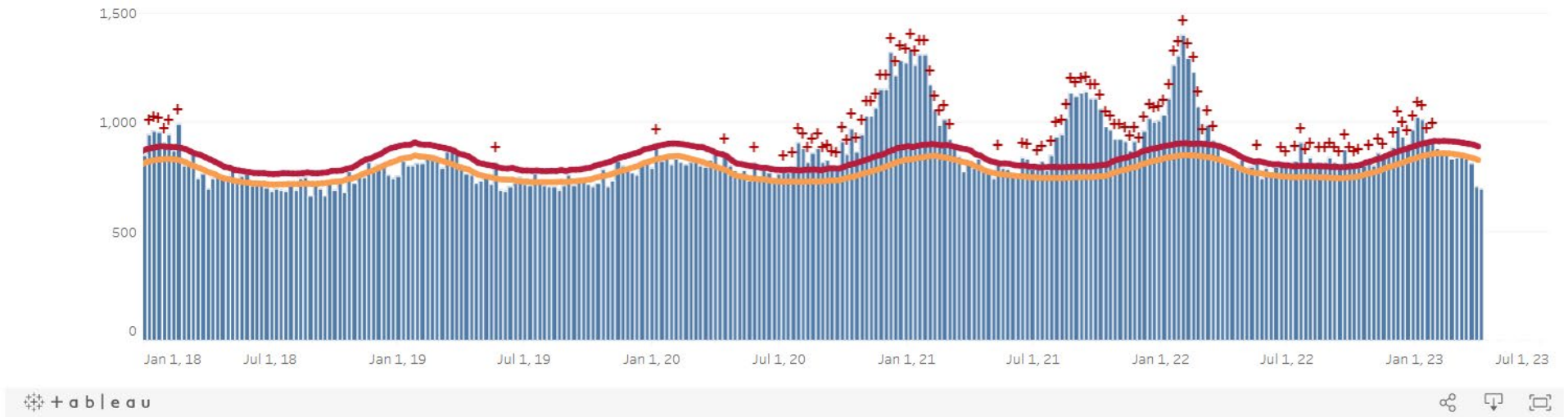
