**Hearing Aid Dealers and Fitters**

Discussed “Over the Counter Hearing Aid Sales” – New Federal regulations mean these might hit retail sales spaces next summer. The FDA will be changing some rules, and these rules will affect the State and our ability to punish bad actors. Some of these rules might mean that not all HA applicants will need to undergo a physical examination, which is potentially life threatening. Council inquires about OSDH putting in a public comment for Federal rules feedback, perhaps the OK Attorney General needs to proceed. Travis will look into public comment on Federal rules from a state agency.

**Medical Micropigmentation**

Regulations Updated- Governor Stitt has advised state agencies to condense and clarify state codes. Med Mic workgroup met to remove definitions not used in code, clean up grammar and removed unnecessary or restrictive wording.
