IV. Approval of the Minutes – July 21st, 2020 – Chair Russell Martin

A motion was made to approve the minutes by Theresa Compos and seconded by K.C. Nickels. There was no discussion and the motion passed 16-0.

V. Reports

A. Emergency Systems Quarterly Activity Report – Dean Henke

Dean Henke introduced Katrina Warden as the new Special Projects Coordinator and noted that staff will be moving to the new Oklahoma Commons Building soon. Linda Dockery is the point of contact for Trauma Fund and the new application deadlines handout was not included in the member packet, but will be emailed to members when available. The final list for the data dictionary is completed and was presented at the July 15th Oklahoma State Stroke System Advisory Council meeting. New EMS Rules were signed and went into effect September 11th, 2020. The updated rules are available on the Emergency Systems website. EMS agencies needing a new unit inspections should use the following link to schedule their inspection:

Martin Lansdale has transitioned roles and is no longer managing the Oklahoma EMS
Information System (OKEMSIS); the Statistical Research Specialist position is currently
open. Xana Howard is the point of contact and there are no trainings scheduled for
OKEMSIS. Dr. Yang Wan is the point of contact for the Trauma Registry and there is no
training scheduled at this time. EMS Director training is now being conducted virtually;
upcoming trainings will be announced as scheduled for early 2021. Oklahoma Trauma
Education Program has no classes scheduled at this time. If your agency is in need of an
OTEP class contact our department and we can try to schedule one virtually. The Trauma
Transfer and Referral Center is up and running. Oklahoma Trauma and Emergency
Response Advisory Council met October 7th, 2020 – 1:00pm. Proposed workgroup dates
will be emailed out later.

B. Quality Improvement Committee Quarterly Activity Report – Kari Smoot Kari Smoot reported that the QIC meet earlier this morning. The committee reviewed a total of ten cases and with the follow-up on 16 letters of which 8 were good job letters. A motion was made to approve items C, D, E, and F by Theresa Compos and seconded by Bruce Kelley. There was no further discussion. The motion passed 17-0.

G. Report from Russell Martin on the Ad Hoc group for Bylaws - Chair Russell Martin Chair Russell Martin referred to James Annas Jr., Kari Smoot, and Mary Howell to provide a report. Kari Smoot shared that the by-law document needed to be discussed at this meeting. Ms. Smoot provided the group has made changes to the verbiage and James Annas Jr. suggested that the document be sent to the RTAB group so they would have a chance to review it and place it on the agenda for the January 19th, 2021 meeting. Chief Annas wanted to discuss a couple of items today regarding section 5. Chief Annas stated that the data for call volume information need to be in the by-laws. Dean Henke shared that the call volume currently comes from OKEMSIS and will be reviewed every year to determine the top 4 EMS agencies. Mr. Henke shared that when he sends the proposed by-law verbiage changes to the RTAB members, he would also attach the worksheet that was used for the 2021 board rotation. Chief Annas also addressed the removal of board members needs to be reviewed and the verbiage needs to be worded that the board member (agency) will not be removed but only the members not attending for that agency would be removed. Ms. Smoot asked about the by-law verbiage with regards to a budget for the RTAB. Dan Whipple explained when the RTAB's were first started there were means to raise funds. Currently region 7 RTAB has not done anything to raise funds but they are more than welcome to. Chief Annas brought up the issue about continuing virtual meetings. Mr. Whipple explained that the by-laws would have to meet specific guidelines. Ms. Smoot brought up the need for by-law verbiage changes for special committees. Chair Russell Martin asked for the committee to consider by-law verbiage concerning attendance for special committees regarding the RPC. Mr. Henke shared that currently there were two RPC members that have not responded to calls and emails in over 1 year, which in turn affects the RPC reaching quorum. Ms. Smoot asked RTAB members to respond back with their by-law suggestions by November 20th, 2020. Chair Russell Martin tabled item number G until the January 19th, 2021 RTAB meeting.
