# Suicide Facts

#### State Facts:

- From 2013-2017, more than 3,700 Oklahomans died from suicide.
- More Oklahomans die of suicide than motor vehicle crashes.
- Oklahoma suicides outpace homicides almost 3 to 1.
- Firearms are the most common weapon involved in suicide deaths.
- In 2017, Oklahoma had the 13th highest suicide death rate in the U.S.


A suicide is a death resulting from the intentional use of force against oneself.

# Tulsa County Data (2013-2017)

- From 2013-2017, there were 614 suicide deaths in Tulsa County.
- 55% of suicide deaths involved a firearm, 27% were by hanging/strangulation, 14% were poisonings.
- 78% of suicide deaths were among males.

What is a Suicide?

- Adults age 35-44 had the highest rate of suicide.
- 49% of people who died by suicide had a history of mental health problems; 33% were experiencing intimate partner problems.
- 24% had disclosed suicidal intent to someone else.
- 81% of the deaths occurred at a home or residence.
- 34% of those tested for blood alcohol content (61%) were positive for alcohol; of the 59% tested for substances other than alcohol, 34% tested positive for one or more substances.



### Suicide is Preventable

Suicide is a serious public health problem that can have lasting harmful effects on individuals, families, and communities. While its causes are complex and determined by multiple factors, the goal of suicide prevention is to reduce factors that increase risk and increase factors that promote resilience. Ideally, prevention addresses all levels of influence: individual, relationship, community, and societal. Effective prevention strategies are needed to promote awareness of suicide and encourage a commitment to social change.

# We Can All Take Action

Evidence shows that providing support services, talking about suicide, reducing access to means of self-harm, and following up with loved ones are just some of the actions we can all take to help others.

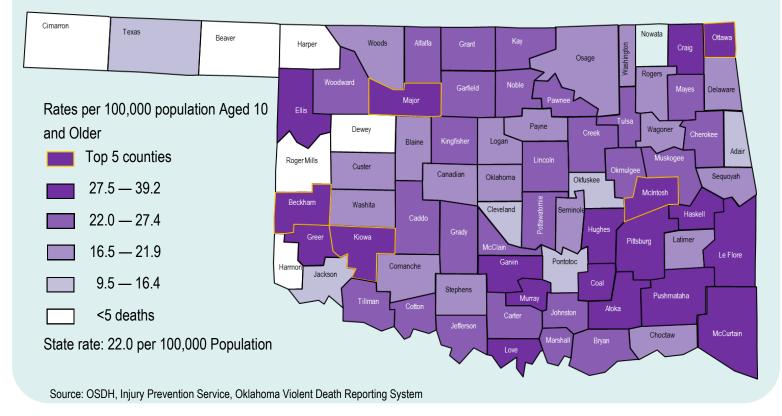

# Suicide Death Rates by County of Injury, Oklahoma, 2013-2017



The Oklahoma Violent Death Reporting System (OKVDRS) is a statewide surveillance system for suicides, homicides, undetermined manner deaths, unintentional firearm injury deaths and legal intervention deaths. Data are collected from medical examiner reports, death certificates, law enforcement reports, and child fatality review data.
