Minutes

I. CALL TO ORDER

The meeting was called to order by Chairman Greg Reid at 1:30 pm.

II. ROLL CALL

III. WELCOME AND INTRODUCTIONS

Rebecca Flatt with Stroud Regional Medical Center and Roger Smith; EMS Coordinator for OU introduced themselves to the committee.

IV. APPROVAL OF MINUTES - November 15, 2016

A motion to approve the minutes as written was made by Billy Buchanan (Chandler Fire/EMS) and seconded by Eddie Sims (EMSTAT). The motion carried after a unanimous vote.

V. REPORTS

A. Emergency Systems Report

Emergency Systems is fully staffed and introduced Mr. Samuel Curatola EMS Administrator, Ms. Darlene Alexander Administrative Assistant and Xana Howard Statistical Research Specialist. Report Writer is now functional for those agencies that use it for reports.

B. Regional Planning Committee (RPC) – Eddie Sims

Eddie Sims stated that RPC met this morning and discussed the variety of triage tags throughout the State. Eddie stated he was on the board that reviewed the Stillwater incident. The main problem they had was there was no uniformed triage system. Each service had a different triage tag. Eddie encouraged for each agency to bring their triage tags they use. Eddie would like to take a triage tag system to OTERAC to get the whole State to use the same triage tags. Region 7 and Region 8 have a system that is working well with fire and EMS.

C. Region 8 Update – Eddie Sims

Eddie Sims stated he didn't make it to the Region 8 meeting. Dan Whipple gave a brief synopsis of the meeting. The main topic was the hospital rotation for the Region.

D. OTERAC Update – Eddie Sims

Eddie Sims stated that the new Chair (Greg Reid) for OTERAC will be elected at the next OTERAC meeting; March 1, 2017. A few topics that will be discussed are: the Good Samaritan Rule; the rule change to SAV; protection of CQI to be confidential – to be immune to evidence and open records and Community paramedicine. The Region 6 Stroke Plan was approved by OTERAC.

E. Continuous Quality Improvement (CQI) Report – Heather Booher

Heather presented the committee with 2 case reviews and 1 case closure. Heather explained how easy it is to turn in a trauma case for CQI review. There are many places to find the CQI form; EMResource, OSDH website or call her. She also encouraged them to turn in cases where it went smoothly. She likes to give out good job letters.
