

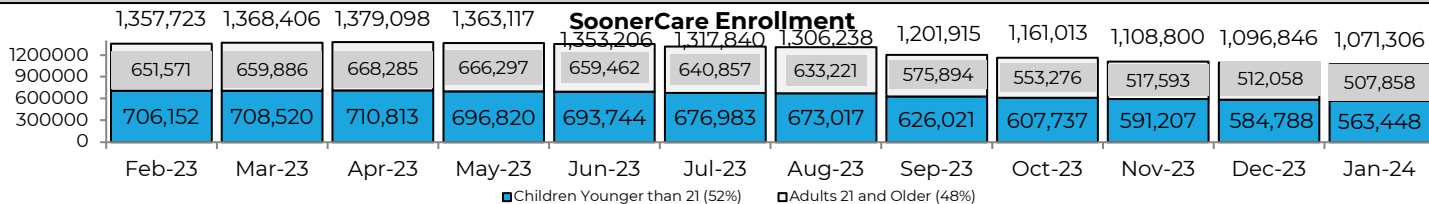

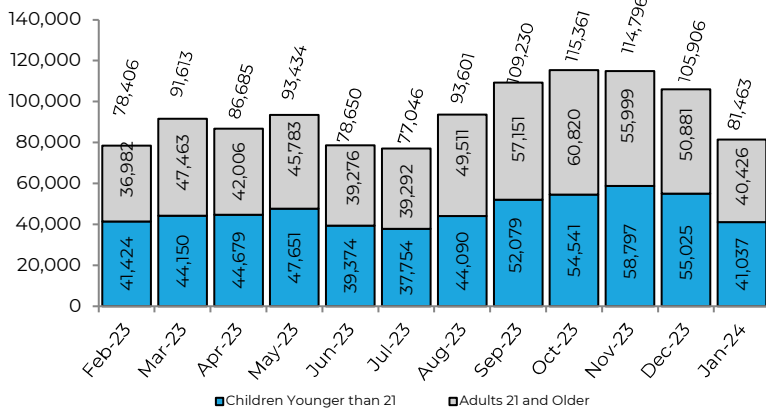

OHCA's **Behavioral Health Program** provides a behavioral health care benefit for adults 21 years of age and older and children under 21 years of age who are enrolled in SoonerCare (Traditional & Choice) programs.

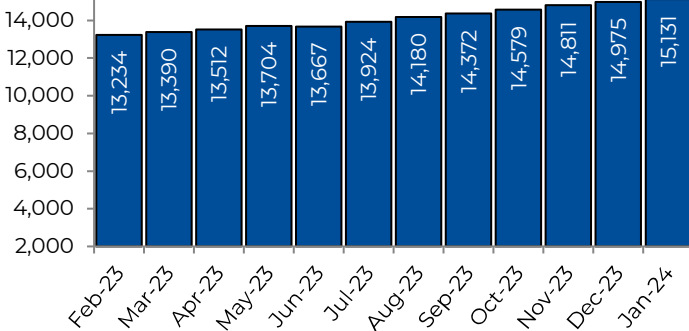

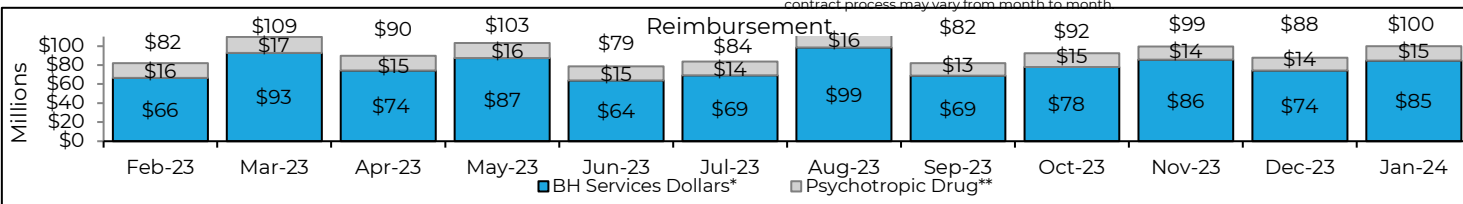
### Members Receiving Behavioral Health Services

\*Effective Feb 2017 total Behavioral Health Provider Networks include Behavioral Health Provider, Psychiatric Hospital, RTC (Residential Treatment Center), Psychiatrist, and RBMS (Residential Behavior Management Services). Provider Networks are comprised of providers who are contracted to provide health care services by locations, programs, types, and specialties. Providers are being counted multiple times if they have multiple locations, programs, types, and/or specialties. Provider contract process may vary from month to month.

\*\*Prescription claims that are not coded with diagnostic information and drugs used to treat behavioral health conditions may be used for some physical health conditions as well. This figure includes all uses of the drug included within behavioral health categories.
