Dear Pharmacy Provider,

****Effective February 21, 2006 - Prescriber ID Number / Name Match****

Pharmacy claims will be checked for a valid prescriber ID number and name match. The submitted prescriber’s last name must match the last name on the prescriber file. If the prescriber’s last name does not match or no last name is submitted, NCPDP response 56 (Non-matched Prescriber ID) will display and the claim will be denied. The complete last name of the prescriber must appear in **Field 427**. For questions regarding field 427, contact Electronic Data Interchange (EDI) at **1-800-522-0114, select option 8, and then option 2 for EDI Help Desk.**

In order to ensure a smooth transition, OHCA has created a schedule for the gradual implementation of this edit. The edit will be turned on for 1 hour per day for the first week. The active time for this edit will be increased periodically until implementation is complete on March 20, 2006.

Reminder - State Default Prescriber ID Number

A state default prescriber ID number ‘9999995’ is available for the initial fill on a prescription **only** if the valid prescriber id number is not available. The state default number is not valid for subsequent refills on a prescription and the claim will display NCPDP response 73 (Refills are not covered) if the state default number is used. Anytime the state default number is used it must be reversed and resubmitted with the correct prescriber ID within two weeks to avoid automatic recoupment of funds.
