Dear Pharmacy Provider,

Please be sure that you use your DME provider number not your pharmacy provider number when billing DME claims. DME claims will not process through the pharmacy point-of-sale system.

Diabetic supplies should be billed using your DME provider number on a CMS 1500 claim form or using the professional claim option at the OHCA secure web site. Claims will process with the HCPCS codes, not NDC's.
