Review, discussion and possible action to authorize OCIA staff, to prepare and distribute requests for proposals ("RFPs") for services of financial advisor, bond counsel, underwriter(s), trustee/paying agent, printer and to appoint a committee for the purpose of making a recommendation to the Authority for selection of the same for the proposed bond issuance, to be issued in one or more series, for an aggregate amount sufficient to generate net proceeds of approximately Thirty-Five Million dollars (\$35,000,000) as authorized by SB 1070, 2019 Okla. Sess. Laws 502, to provide funding for construction of two long-term care

facilities authorized by Section 229.1 of Title 72 for the Oklahoma Department of Veterans Affairs. [Andrew Messer]

Lieutenant Governor Pinnell moved to authorize staff to issue RFPs for services of financial advisor, bond counsel, underwriter(s), trustee/paying agent, printer and to appoint a committee composed of Treasurer McDaniel, Secretary Gatz, and Director Harpe for the purpose of making a recommendation to the Authority for selection of the same for the proposed bond issuance of approximately Thirty-Five Million dollars (\$35,000,000) as authorized by Senate Bill 1070 (2019 Legislative Session) to provide funding for construction of two long-term care facilities authorized by Section 229.1 of Title 70 for the Oklahoma Department of Veterans Affairs. Director Harpe seconded the motion. The motion passed and the following votes recorded:
