PORTFOLIO PERFORMANCE, DIVERSIFICATION AND STRATEGY

March portfolio yielded 3.14%, up from 2.20% last year, with a weighted average maturity of 991 days.

Total assets under management of \$15.6 billion, up \$800 million in comparison to March 2023.

Total portfolio contained 70% in U.S. Treasurys, 6% in U.S. government agencies,

16% in mortgage-backed securities, 6% in money market mutual funds, 0.3% in certificates of deposit, and **0.9% in state bond issues and foreign bonds**, comprising the balance of funds invested.

"Yields will continue to grow as the portfolio sheds the older investments and takes on the influence of the new rate range. Total portfolio yields are lower than current yields due to the laddered structure of the investments over a 3 year average." **STATE TREASURER**

MARKET CONDITIONS March saw an overall decrease in US Treasury rates. The 10-year treasury ended the month down .05% to 4.20%. The 2-year treasury remained unchanged at 4.62%. The 30-year treasury declined by .04% and closed the month at 4.34%.

The third straight record-setting month for the stock market occurred in March. According to Reuters, "The U.S. stock market is off to a soaring start in 2024, as optimism over the economy and interest rate cuts has combined with exuberance about the business opportunity in artificial intelligence to stir up a potent cocktail for equities." After a hard to top February, the market did not look back. The S&P's 10.16% first-quarter gain was the largest since 2019.

The Federal Reserve met on March 19-20 and decided to leave the federal funds rate unchanged for the fifth consecutive meeting at 5.25%-5.5%. Due to a hotter than expected jobs report and consumer price index (CPI), the possibility of a June

rate cut has dwindled. According to the CME Fed Watch tool, the probability of rates being cut by 1% or more by the end of the year has dropped to 6%, down from 61% last month.

According to the Federal Reserve's FOMC statement, "The Committee does not expect it will be appropriate to reduce the target range until it has gained greater confidence that inflation is moving sustainably toward 2%."

ECONOMIC DEVELOPMENTS The March unemployment rate came in at **3.8%**, compared to **3.9%**, contrary to the Feds goal, in February. The rate has held in the **3.7%-3.9%** range since August 2023. Total nonfarm payroll increased by **303,000**, compared to an increase of **275,000** in February.

The Bureau of Labor Statistics reports, "job gains occurred in health care, government, and construction."

The CPI increased by **0.4%** in March and was the same as February's increase. Over the last 12 months, the CPI has risen **3.5%**. Contrary to the Feds, some economists expected a **3.4%** annual rise, and **0.3%** increase over the month. The Bureau of Labor Statistics said shelter and gasoline contributed to more than half of the monthly increase. Core CPI,

which excludes energy and food prices, also increased **0.4%**, the same as the 2 previous months. The producer price index (PPI), beat economists' expectations and rose only **0.2%** over the month of March. February's growth came in at **0.6%**. Year-over-year, the PPI increased by **2.1%**. Core PPI also rose **0.2%**, which matched economists' expectations. The annual rise for core PPI was **2.4%**.

According to Reuters, "U.S. consumer prices increased more than expected in March amid rises in the costs of gasoline and shelter, casting further doubt on whether the Federal Reserve will start cutting interest rates in June."

Retail sales beat expectations and rose by **0.7%** in March. February's increase was upwardly revised from **0.6%** to **0.9%**. Online sales rose by **2.7%**, whereas department stores saw a **1.1%** decline. Sales of motor vehicles dropped **0.7%**. Excluding motor vehicle sales, retail sales rose **1.1%** over the month. Core retail sales excludes automobiles, gas, building materials, and food services. This figure rose **1.1%**, the largest increase in over a year.

According to CNN, "Sales were up across several categories in March, including at gas stations, which increased a strong 2.1% from February. Gas prices have steadily risen in the past several weeks. Still, excluding sales at gas stations, retail sales were up 0.6% in March."

The number of homes actively for sale in March was 23.5% higher compared to the same time last year. This is 8.7% higher than February's year-over-year increase. This marks the fifth straight month of growth in the housing market. Homes for sale in the \$200,000 - \$350,000 range grew by 30.5% compared to last year. While inventory has increased at a strong rate, it is still down 37.9% compared to 2017-2019. In February, inventory was down 39.6% from pre-pandemic levels.

According to Realtor.com, "This increase in affordable inventory was a contributing factor to the nation's low median home listing price growth rate, as did this past month tying with March 2019 for the highest level of price reductions seen since our records began in 2017."

The third estimate for fourth quarter 2023 real gross domestic product (GDP) was upwardly revised to a **3.4%** annual growth rate. This is compared to the second estimate, which showed a downwardly revised figure of **3.2%**. Real GDP increased **2.5%** in 2023, higher than the Federal Reserve's **1.8%** non-inflationary growth target.

According to the Bureau of Economic Analysis, "The increase in the fourth quarter primarily reflected increases in consumer spending, state and local government spending, exports, nonresidential fixed investment, federal government spending, and residential fixed investment that were partly offset by a decrease in private inventory investment."

COLLATERALIZATION All funds under the control of this office requiring collateralization were secured at rates ranging from 100% to 110%, depending on the type of investment.





The Treasurer had revised the estimated earnings to the Board of Equalization for Fiscal Year 2024. The amount estimated was \$334,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

The following page presents market rates of return on the Securities portion of the General Account and the State's aggregated State Agency Accounts. These figures, which are dollar-weighted and time-weighted where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month.

To ensure the integrity of data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are held with the custodian bank Northern Trust Company.



Note: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported are shown at the contracted rate.

Securities Lending Program

The State Treasurer participates in a securities lending program with Northern Trust Company acting as lending agent. Northern Trust retains 20% of the revenues generated as compensation for services, their share for the month(lag 1 month) was \$14,728. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of security lending revenue in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.

Northern Trust Custody Fees

Pursuant to custodial contract with Northern Trust Company, custody fees are paid quarterly. Fees paid to Northern Trust Company for the first two quarters total to 22,500.
