To the People of Oklahoma:

I am pleased to issue the February monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

US Treasuries outperformed stocks in February for the first time since October 2012. Fear of spending cuts increased the demand for the safety of U.S. debt. The Dow Jones Industrial Average (DJIA) advanced 1.4% for the month. The Standard & Poor's 500-stock index and Nasdaq Composite both marked their fourth monthly gain in a row, up 1.1% and 0.6%, respectively. The Federal Open Market Committee (FOMC) did not meet in February. Federal Reserve Chairman Ben Bernanke testified to the Senate Banking Committee for his Semi-annual Monetary Policy Testimony in February. Chairman Bernanke reiterated that future asset purchases would continue to depend on labor market and inflation conditions. Bernanke criticized the sequester as "a significant headwind" to near term growth and proposed replacing it with "policies that reduce the federal deficit more gradually in the near term, but more substantially in the longer run."

Economic Developments

Numerous reports were issued in February that affected performance of the markets during the month. The Institute for Supply Management reported that its index of manufacturing activity climbed to 53.1 in January. The unemployment rate edged up to 7.9% in January from 7.8% in December. Over the past twelve months, average hourly earnings have increased by 2.1% for all employees. The producer price index (PPI) for finished goods rose 0.2% in January. U.S. retail sales rose 0.1% in January to a seasonally adjusted \$416.6 billion. The consumer price index (CPI) was flat in January. The trade deficit narrowed in December to \$38.5 billion from \$48.6 billion in November. After adjusting for prices, the real trade gap stood at \$44.14 billion. Exports increased 2.1% while imports fell 2.7%. Against year-ago levels, exports are up 4.9% and imports are down 2.0%. The Conference Board's consumer confidence index jumped to 69.6 in February after reporting 58.4 in January. Gross domestic product (GDP) for the 4th quarter was revised upward to 0.1% from -0.1%. Housing starts fell 8.5% in January. Building permits continued to rise for the fourth consecutive month, increasing 1.8% in January. Existing home sales decreased 0.4% in January. Pending home sales rose 4.5% in January. Inventory fell 4.9% to the lowest level since December 1999. The share of total purchases that were foreclosures increased to 14% from 12%. This possibly contributed to the decline in the median home price from \$180,200 to \$173,600. The U.S. Census Bureau reported that sales of new single-family homes rose 15.6% in January from the previous month. Single-family home sales are up 28.9% from January 2012. In the past two years many builders have offered concessions, such as paying closing costs, to new home buyers that made it easier to buy a new home than an existing one. The median sales price of a new home in January was \$226,400 while the average sales price was \$286,300.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 2.05% in February and the weighted average maturity was 1,067 days. In terms of segment weightings decreases in money market mutual funds were offset by purchases of mortgage-backed securities. The year-to-date monthly average investable base rose by \$19 million to \$3.888 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 37% of the portfolio. Mortgage-backed securities were 45%, municipal bonds were 2% and Certificates of Deposit represented 3% of assets. Money market mutual funds were 7%, and the allocable portion of sales and use tax to General Revenue collected by the Oklahoma Tax Commission was 3%. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on challenging and potentially volatile market conditions, portfolio strategy consists of a combination of laddered maturities and market observation for investment opportunities that will maximize income in a secure environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,938,075,459 and State Agency balances in OK Invest at \$2,213,212,358 for a total of \$6,151,287,817.



In February 2012, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2013. The amount estimated was \$83,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison

February 28, 2013

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



NOTE: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securitiet Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$3,884.35. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
