To the People of Oklahoma:

I am pleased to issue the August monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

Yields on U.S. Treasury securities fell across the board in August. Yields on two and ten year Treasury notes touched their lowest levels since August 21 at month end. Rates on six month Treasury bills hit .22%, the lowest level this year. As reports from consumer confidence to home sales topped economic forecasts, the S&P 500 added 3.4% in August and the Dow Jones Industrial Average (DJIA) climbed 3.5%. The U.S. government and the Federal Reserve have spent, lent or committed more than \$12 trillion to revive the economy and credit markets. Policy makers announced they will let a \$300 billion program to buy long-term Treasuries expire in October.

Economic Developments

The Institute for Supply Management reported that its index of manufacturing activity rose to 48.9 in July, from 48.9 in June. The unemployment rate dropped to 9.4% in July from 9.5% in June. The median duration of unemployment fell to 15.7 weeks in July from 17.9 weeks in June. From May to July, job losses averaged 331,000 per month, compared with losses averaging 645,000 per month from November to April. The total number of jobs lost since December of 2007 is 6.7 million, the largest drop in more than six decades. Average hourly earnings rose 0.2% in July and were 2.5% higher than a year ago and the average workweek rose to 33.1 hours. Year-over-year hourly earnings have been declining steadily since December 2008. The Commerce Department reported retail sales dropped 0.1% in July. Excluding autos, all other retail sales dropped 0.6%. Consumer prices in July fell 2.1% from a year ago, the largest year over year decline in almost six decades. Prices were unchanged compared to June levels. The U.S. trade deficit widened to \$27 billion in June from \$26 billion in May. The deficit was largely due to energy prices, which have been on the rise. The Conference Board's consumer confidence index advanced to 54.1 in August from 47.4 in July. Housing starts fell 0.1% in July from the previous month. Single family units rose 1.7%, for the fifth straight increase. It is taking homebuilders 11.8 months to sell new homes post completion. The National Association of Realtors reported new home sales climbed 7.2% in July, the biggest gain since 1999 and the median price fell 15%. The second quarter delinquency data released by the Federal Reserve showed delinquencies rose across all loan types. The delinquency rate hit record highs for total loans 6.49%; credit card loans 6.70%; residential real estate loans 8.84% and commercial real estate 7.91%, the highest since 1993.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 3.53% in August and the weighted average maturity was 506 days. Yields by class were fairly stable. There were decreases in U.S. Treasuries and U.S. government sponsored enterprises as funds from maturities in those classes were invested in Mortgage-backed securities. Due to the current interest rate environment the Link Deposit program continues to decrease. The year-to-date monthly average investable base was down \$11 million to \$3.513 billion as revenue collections continue to decline compared to the prior year. Portfolio diversification continues to be sound. U.S. Treasuries represented 7% of holdings, and U.S. government sponsored enterprises accounted for approximately 40%. Mortgage-backed securities were 22%, Municipal Bonds were 2% and Certificates of Deposit represented 6% of assets. Money market mutual funds were 8% and 11% was maintained in overnight repurchase agreements. Link deposits (at less than 1%), State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on market conditions, portfolio strategy will consist of a combination of laddered maturities and market observation for investment opportunities.

Collateralization

All funds under the control of this office requiring collateralization were so secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees, mutual fund operating expenses and fees charged by JPMorgan Chase for the Tri-Party Repurchase Agreement Program are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,407,820,743 and State Agency balances in OK Invest at \$1,837,261,711 for a total of \$5,245,082,445.



In February 2008, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2009. The amount estimated was \$146,500,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison August 31, 2009

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at Northern Trust ("Northern").

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



The State Treasurer participates in a Securities Lending Program with The Northern Trust Company ("Northern") acting as lending agent. Northern retains 25% of the revenues generated as compensation for services. Its share for the month was \$20,745.08. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$425,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
