To the People of Oklahoma:

I am pleased to issue the February monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

The benchmark 10-year Treasury note, used in determining mortgage rates and other consumer loans, ended the month at 2.65%. The 30-year Treasury began February at 3.53% and closed February at 3.58%. The Dow Jones Industrial Average ended at 16,321, leaving it up 4% for the month. After advancing to an intraday record of 1,867 the S&P 500 rose 0.3% to 1,859 and gained 4.3% for the month. The NASDAQ came in at 4,308 which represented a 5% gain for the month. Federal Reserve Chair Janet Yellen's message during the month was that the Fed would likely continue tapering its asset purchases, while tracking data to determine the impact of harsh winter weather on the economy.

Economic Developments

In January, the unemployment rate decreased by 1/10th of a point to 6.6%, which was its lowest reading since October 2008. The typical unemployed person had been jobless for 16 weeks, unchanged from January 2013, with 35.8% of all unemployed people being out of work for at least half of a year. Downward pressure on wages is one of the big factors in the Fed's thinking about the jobless rate. So far, the falling unemployment rate has not fueled stronger wage gains or high inflation.

The Conference Board's Index of Consumer Confidence fell to 78.1 in February from a downwardly revised January reading of 79.4. Fewer Americans expected future business conditions to improve over the coming six months, decreasing to 75.7 from 80.8 the month prior. The Bureau of Labor Statistics reported the core Consumer Price Index (CPI), which is net of both energy and food, grew 0.1% during the month in comparison to 0.2% for December. Food prices increased 0.1% and energy by 0.6%, which reflected higher prices for fuel oil, utility delivered gas and electricity. The Producer Price Index (PPI) for final demand- which includes goods, services, and construction sold for personal consumption, capital investment, government purchases and export- expanded at a seasonally adjusted 0.2% pace, up from 0.1% during December.

The January retail sales report was affected for the second month in a row by the harsh winter weather and was down to a seasonally adjusted -0.4%. Retail sales have grown 2.6% over the past year, the smallest twelve-month comparable since November 2009. Car dealers and auto part sales dropped 2.1% during the month. Net of car sales and auto parts, retail sales were unchanged for the month and were up 2.2% from a year ago. At building material retailers, gas stations, electronics and appliance stores sales rose, but sales softened at sporting goods, hobby stores, apparel retailers and restaurants and bars.

A culmination of weather, under supply and rising costs have attributed to the downturn in the housing sector. Housing starts plunged by 16% in January, the lowest annualized rates since September 2013. Building permits also declined markedly, decreasing from 991,000 from the month before to 937,000 in January. As demand for housing has waned this winter, homebuilder confidence has languished. The National Association of Home Builders Confidence Index dropped in February from 56-46. The index had never experienced a drop of that degree since its inception in 1985.

The Gross Domestic Product advanced 1.9% during 2013, in comparison to the 2012 rate of 2.8%. The economy for the fourth quarter expanded 3.2% on a seasonally adjusted annualized basis, as reported by the Bureau of Economic Analysis. Fourth quarter GDP growth has been attributed to an increase in consumption and improved trade, as exports surged 11.4% and imports only increased by 0.9%.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 1.87% in February and the weighted average maturity was 1,110 days. The year-to-date monthly average investable base was \$4.126 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 42% of the portfolio. Mortgage-backed securities were 39%, municipal bonds were 1% and Certificates of Deposit represented 3% of assets. Money market mutual funds and commercial paper sweep were 8%, and the allocable portion of sales and use tax to General Revenue collected by the Oklahoma Tax Commission was 3%. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on challenging and potentially volatile market conditions, portfolio strategy consists of a combination of laddered maturities and market observation for investment opportunities that will maximize income in a secure environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,889,040,395 and State Agency balances in OK Invest at \$2,419,702,482 for a total of \$6,308,742,877.



In February 2014, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2014. The amount estimated was \$68,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison

February 28, 2014

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



NOTE: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securitiet Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$4,098.51. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
