## OKLAHOMA STATE TREASURER

To the People of Oklahoma:

I am pleased to issue the March monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

### Market Conditions

Except for three-month Treasury bills, yields were up for U.S. Treasuries during March. Yields on benchmark 10-year Treasury notes have climbed 33 basis points since the end of 2011 to 2.21%. They reached 2.40% on March 20, the highest level since October 28, 2011. Thirty-year bond yields rose 44 basis points from January through March to 3.34%. The Treasury yield curve steepened during the first quarter. The Dow Jones industrial Average (DJIA) ended the first quarter up 8.1%. The Standard & Poor's 500-stock index is up 12% this year and the Nasdaq Composite jumped 19%.

### Economic Developments

Numerous reports were issued in March that affected performance of the markets during the month. The Institute for Supply Management reported that its index of manufacturing activity eased to 52.4 in February after rising to 54.1 in January. The unemployment rate was unchanged in February at 8.3%. This is the lowest level since February 2009. U.S. average hourly earnings rose 0.1% in February and 1.9% year-on-year. The average workweek was unchanged at 34.5 hours for the second consecutive month. The producer price index (PPI) for finished goods rose 0.4% in February after posting a 0.1% rise in January. Retail sales rose at the fastest pace in five months rising 0.6% in January. Total retail sales were boosted by a jump in gasoline prices which resulted in a 3.3% jump in sales at gasoline stations. The overall consumer price index (CPI) rose 0.4% in February, mainly due to higher prices at the pump. The U.S. trade deficit expanded in January to its highest level in more than three years as exports to China and the euro plunged. The deficit rose 4.3% to \$52.57 billion from \$50.42 billion in December. The real or inflation-adjusted deficit, which economists use to measure the impact of trade on GDP, widened to \$49.11 billion in January from \$48.29 billion the month before. The Conference Board's consumer confidence index pulled back slightly in March to 70.2 from 70.8 in February. Gross domestic product (GDP) for the fourth quarter 2011 expanded 3.0%, the best performance since the middle of 2010. Existing home sales fell 0.9% in February. January sales represented the highest level of existing home sales seen since May 2010. The median sales price rose 1.29% to \$156,000 compared to a month ago. Distressed properties accounted for 34% of all sales. New home sales unexpectedly fell 1.6% in February to an annual rate of 313,000 units. This was the second consecutive monthly decline following four months of steady gains. The median new home sales price for February jumped to \$233,700 from \$215,700 in the prior month.

### Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 2.39% in March and the weighted average maturity was 947 days. There were no significant changes in asset weightings. In March, the year-to-date monthly average investable base increased by \$10 billion to \$4.25 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 38% of the portfolio. Mortgage-backed securities were 39%, municipal bonds were 2% and Certificates of Deposit represented 4% of assets. Money market mutual funds were 10% and OK Invest was 3%. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on challenging and potentially volatile market conditions, portfolio strategy consists of a combination of laddered maturities and market observation for investment opportunities that will maximize income in a secure environment.

### Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

### Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees, mutual fund operating expenses and fees charged by JPMorgan Chase for the Tri-Party Repurchase Agreement Program are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

### Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,537,970,904 and State Agency balances in OK Invest at \$2,281,889,190 for a total of \$5,819,860,094.



In December 2011, the Treasurer adjusted estimated earnings to the Board of Equalization for Fiscal Year 2012. The amount estimated was changed to \$80,000,000 from \$96,000,000. Fiscal Year to Date Revenue estimates reflect this revised estimate. Year-to-date actual earnings are recorded on a cash basis of accounting.

# Explanation of Performance Comparison

## March 31, 2012

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$4,068.00. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$425,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
