To the People of Oklahoma:

I am pleased to issue the June monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

The US Treasury markets experienced continued turbulence in June. The yield on the 10-year Treasury was 2.49%, while the 30-year ended with a yield of 3.50%. On June 19 Federal Reserve Chairman Ben Bernake issued a statement that sent the markets plummeting, reflecting troubles in communicating the Fed's complicated message. Volatility will persist as investors continue to analyze central bank effects on the economy. The Dow Jones Industrial Average (DJIA) ended the month at 14,909. The NASDAQ Composite Index closed at 3,403. The S&P 500 had its first monthly loss since October. The index rose 2.4% in the second quarter, bringing the 2013 rally to 13%. June was the busiest month for American stock trading since November 2011, with more than 10 billion shares changing hands.

Economic Developments

The June economic data was mixed but was broadly consistent with continued moderate growth rather than a surge in new activity. According to the Labor Department, 175,000 jobs were added in May and the unemployment rate rose slightly to 7.6% from April's 7.5%. The Institute for Supply Management reported that the manufacturing index fell by 1.7 points in May to 49.0, the first sub-50 reading on this series since July 2009.

The consumer price index (CPI) rose .1% in May on a seasonally adjusted basis from -.4% in April, as reported by the Labor Department. The .3% increase in the shelter component of the index was part of the index gain, as rent and housing prices appreciated. Electricity, natural gas, and air travel also aided in the CPI advance. The CPI is up only 1.4% over the past twelve months. The producer price index (PPI) had a headline figure of .5%. Looking at the core reading, which excludes food and energy, the May increase was only .1%. The headline and core PPI increase was 1.7% on a year-over-year basis. The Consumer Confidence Index (CCI) increased to a reading of 81.4 in June from 74.3 in May. This increase represented the highest reported level since 2008 and marks the third consecutive monthly gain in the index. The Commerce Department reported that sales for the month of May rose 0.6%. Retail sales have climbed 4.3% since May 2012. The report indicated that eight of the thirteen major retail categories showed monthly gains with auto dealers leading the pack, up 1.8% on a monthly basis. Grocery store and general retailer sales were stronger than restaurants, electronics and furniture merchandisers.

The National Association of Realtors reported that May existing home sales increased 4.2%, the highest level since November 2009, to an annualized pace of 518,000. The 12.9% increase in existing home sales on a year-over-year basis was propelled by a lack of supply, down 10.1% from a year ago, and growing demand which

fueled higher home prices and decreased the rate at which homes were sold. In May the existing home median price ascended 15.4% on a year-over-year basis to \$208,000, the highest price seen since 2008.

The trade deficit gap in April grew by 8.5% to \$40.3 billion from a \$37 billion shortfall in March, which was smaller than previously estimated. Accelerated demand for foreign-made mobile phones, automobiles and computers pointed to increases in business and household spending. The import total would have been even larger excluding a pullback in oil demand. U.S. petroleum purchases from abroad of \$29.6 billion were the lowest since November 2010. The Bureau of Economic Analysis reported its third and final revised estimate for first quarter gross domestic product (GDP) which showed an annualized rate of 1.8% down from the previous estimate of 2.4%. The downwardly revised figure was due to weaker than estimated personal consumption as well as fiscal drag.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 1.99% in June and the weighted average maturity was 1035 days. The year-to-date monthly average investable base was \$3.865 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 38% of the portfolio. Mortgage-backed securities were 40%, municipal bonds were 2% and Certificates of Deposit represented 2% of assets. Money market mutual funds were 11%, and the allocable portion of sales and use tax to General Revenue collected by the Oklahoma Tax Commission was 3%. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on challenging and potentially volatile market conditions, portfolio strategy consists of a combination of laddered maturities and market observation for investment opportunities that will maximize income in a secure environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,847,950,998 and State Agency balances in OK Invest at \$2,365,902,706 for a total of \$6,213,853,704.



In February 2012, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2013. The amount estimated was \$83,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison

June 30, 2013

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



NOTE: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securitiet Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$9,358.88. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
