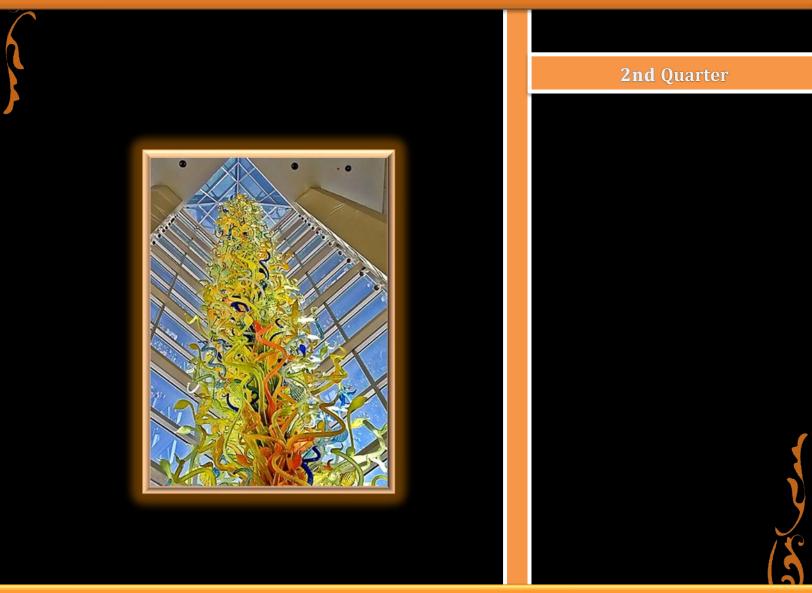

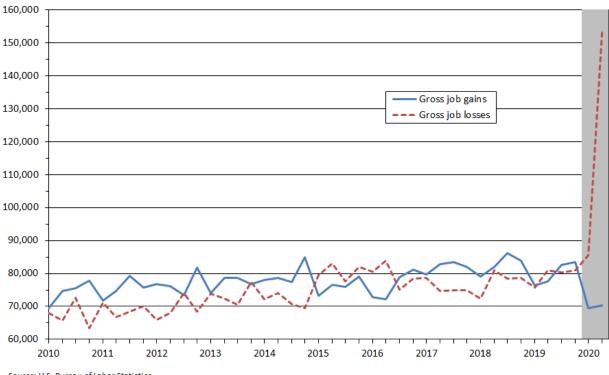

#### **OKLAHOMA BUSINESS EMPLOYMENT DYNAMICS: 2nd Quarter 2020**

#### Gross Job Gains and Gross Job Losses: 2nd Quarter 2020

From March 2020 to June 2020, gross job losses from closing and contracting private-sector establishments in Oklahoma totaled 153,017, an increase of 67,587 jobs from the previous quarter. Over this period, gross job gains from opening and expanding private-sector establishments numbered 70,388, an increase of 811 jobs from the previous quarter, according to the Oklahoma Employment Security Commission, Economic Research and Analysis Division, and the U.S. Bureau of Labor Statistics, (see Chart 1, below and Table 1, page 6). The difference between the number of gross job gains and the number of gross job losses yielded a net employment loss of 82,629 jobs in Oklahoma's private sector during the 2nd quarter of 2020.

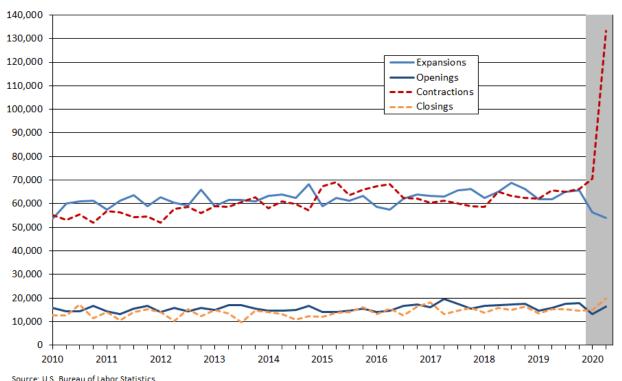
Private sector gross job gains and gross job losses in Oklahoma March 2010 - June 2020, seasonally adjusted

The change in the number of jobs over time is the net result of increases and decreases in employment that occur at all businesses in the economy. Business Employment Dynamics (BED) statistics track these changes in employment at private business establishments from the third month of one quarter to the third month of the next. *Gross job gains* are the sum of increases in employment from expansions at existing establishments and the addition of new jobs at opening establishments. *Gross job losses* are the result of contractions in employment at existing establishments and the loss of jobs at closing establishments. The difference between the number of gross job gains and the number of gross job losses is the net change in employment, (see Technical Note, page 6, for more information).

Gross job losses in the 2nd quarter of 2020 were at the highest level since BED record keeping began in 1992, eclipsing the previous high set in the 1st quarter of 2009, towards the end of the 'Great Recession', when 101,545 jobs were lost.

#### Gross Job Gains and Losses: Openings vs. Closings and Expansions vs. Contractions

Gross job gains are the sum of increases in employment due to expansions at existing establishments and the addition of new jobs at opening establishments. Gross job gains at expanding establishments in Oklahoma totaled 54,082 in the 2nd quarter of 2020, a decrease of 2,185 jobs compared to the previous quarter. Opening establishments accounted for 16,306 of the jobs gained in the 2nd quarter of 2020, an increase of 2,996 jobs from the previous quarter, (see Chart 2, above).

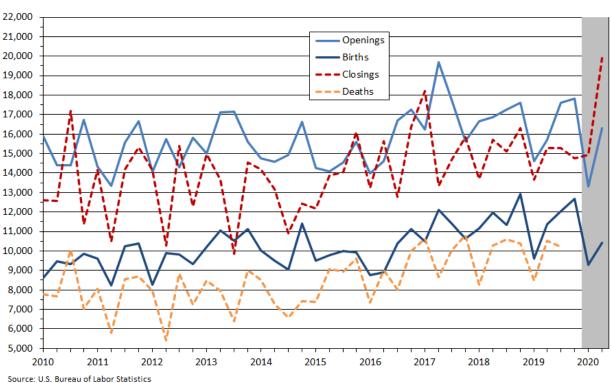
Gross job losses are the result of contractions in employment at existing establishments and the loss of jobs at closing establishments. Contracting establishments in Oklahoma lost 133,130 jobs in the 2nd quarter of 2020, an increase of 62,618 jobs from the prior quarter. In the 2nd quarter, closing establishments lost 19,887 jobs, an increase of 4,969 jobs from the previous quarter.

#### **Establishment Births and Deaths**

In Oklahoma, the number of private sector establishment births, (a subset of the openings data), increased by 344, for a total of 2,433 establishments in the 2nd quarter of 2020. These new establishments accounted for 10,420 jobs, an increase of 1,139 jobs from the previous quarter, (see Chart 3, next page).

Data for establishment deaths, (a subset of the closings data), are now available through the 3rd quarter of 2019, when 10,205 jobs were lost at 2,437 establishments, a decrease of 329 jobs from the 2nd quarter of 2019, (see Chart 3, below).

Employment from private sector openings, closings, births and deaths in Oklahoma March 2010 - June 2020, seasonally adjusted

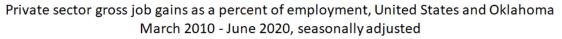

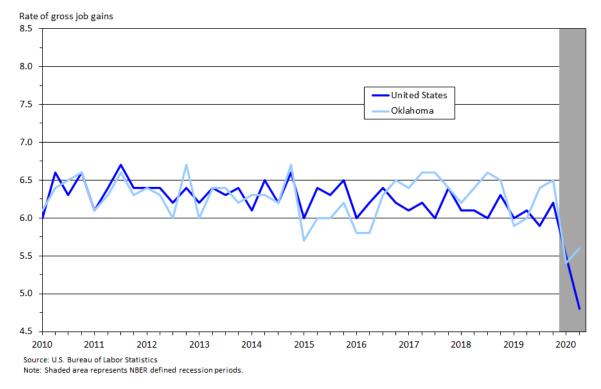
#### Gross Job Gains and Gross Job Losses: Percent of Total Private Sector Employment

In the 2nd quarter of 2020, gross job gains represented 5.6 percent of private-sector employment in Oklahoma with expansions accounting for 4.3 percent of total private sector employment and openings contributing 1.3 percent. Nationally, gross job gains accounted for 4.8 percent of private sector employment in the 2nd quarter of 2020. With few exceptions, Oklahoma's rates of gross job gains have generally tracked with the U.S. rates. However, beginning in the 1st quarter of 2015, the rate of Oklahoma's gross job gains slipped below the national rate for seven consecutive quarters, exceeded the U.S. rate in the following nine quarters but has lagged behind the U.S. rate in three out of the past six quarters, (see Chart 4, page 4).

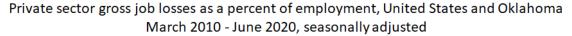
In the 2nd quarter of 2020, gross job losses represented 12.3 percent of private-sector employment in Oklahoma, with contractions accounting for 10.7 percent and closings adding another 1.6 percent. The national rate of gross job losses was 17.0 percent in the 2nd quarter of 2020. From the 3rd quarter 2013 forward, Oklahoma's rate of gross job losses has shown more volatility especially the period beginning 1st quarter 2015 through 1st quarter 2017, then began to track more with national trends from the 4th quarter of 2017 forward (See Chart 5, page 4).

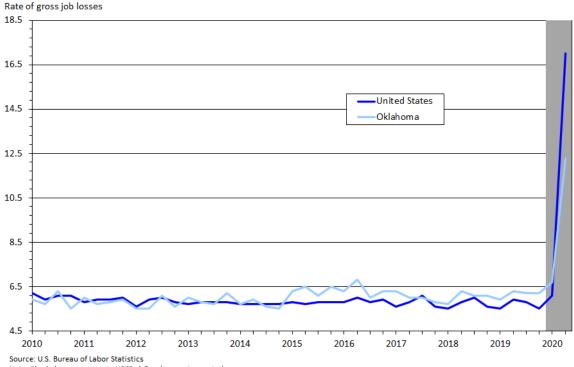

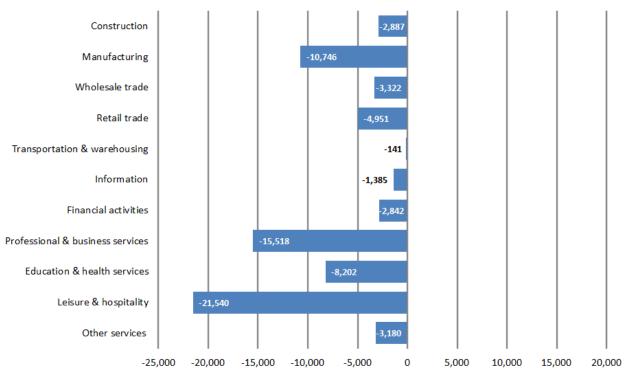

#### Gross Job Gains and Gross Job Losses by Industry: 2nd Quarter 2020

Gross job losses exceeded gross job gains in all of Oklahoma's 11 reported industries in the 2nd quarter of 2020. The service-providing industries experienced a net job decline of 61,081 jobs in the 2nd quarter of 2020. Within service-providing industries, the leisure and hospitality sector had the largest over-the-quarter net job decrease, losing 21,540 jobs. This was the result of 11,739 gross job gains and 33,279 gross job losses. The professional & business services sector also experienced a net decrease in the 2nd quarter of 2020, with 15,518 net jobs lost. Additional services-providing sectors experiencing net job losses in the 2nd quarter were education & health services (-8,202 jobs); retail trade (-4,951 jobs); wholesale trade (-3,322 jobs); other services (-3,180 jobs); financial activities (-2,842 jobs); information (-1,385 jobs); and transportation & warehousing (-141 jobs).

Oklahoma's goods-producing industries realized a net job decrease of 13,633 jobs in the 2nd quarter of 2020. Of the reported goods-producing industries, the manufacturing sector experienced a net decrease of 10,746 jobs, while construction showed a net loss of 2,887 jobs, (see Chart 6 below and Table 5, pp. 12-15).

#### **Technical Note**

#### **Concepts and Methodology**

The Business Employment Dynamics (BED) data are a product of a federal-state cooperative program known as Quarterly Census of Employment and Wages (QCEW), or the ES-202 program. The BED data are compiled from existing quarterly QCEW records. The QCEW reports are sent by the State Employment Security Agencies (SESAs) to BLS and form the basis of the Bureau's QCEW program and establishment universe sampling frame. These reports are also used to produce the QCEW data on total employment and wages. Other important Bureau uses of the QCEW reports are in the Current Employment Statistics (CES) program. The CES program produces monthly estimates of employment, net changes, and earnings by detailed industry.

In the BED program, the QCEW records are linked across quarters to provide a longitudinal history for each establishment. The linkage process allows the tracking of net employment changes at the establishment level, which in turn allows the estimation of jobs gained at opening and expanding establishments and jobs lost at closing and contracting establishments.

The change in the number of jobs over time is the net result of increases and decreases in employment that occur at all businesses in the economy. BED statistics track these changes in employment at private business establishments from the third month of one quarter to the third month of the next. Gross job gains are the sum of increases in employment from expansions at existing establishments and the addition of new jobs at opening establishments. Gross job losses are the result of contractions in employment at existing establishments and the loss of jobs at closing establishments. The difference between the number of gross jobs gained and the number of gross jobs lost is the net change in employment.

Gross job gains and gross job losses are expressed as rates by dividing their levels by the average of employment in the current and previous quarters. The rates are calculated for the components of gross job gains and gross job losses and then summed to form their respective totals. These rates can be added and subtracted just as their levels can. For instance, the difference between the gross job gains rate and the gross job losses rate is the net growth rate.

The formal definitions of employment changes are as follows:

**Openings**: These are either establishments with positive third month employment for the first time in the current quarter, with no links to the prior quarter, or with positive third month employment in the current quarter following zero employment in the previous quarter.

*Expansions*: These are establishments with positive employment in the third month in both the previous and current quarters, with a net increase in employment over this period.

*Closings*: These are either establishments with positive third month employment in the previous quarter, with no employment or zero employment reported in the current quarter.

*Contractions*: These are establishments with positive employment in the third month in both the previous and current quarters, with a net decrease in employment over this period.
