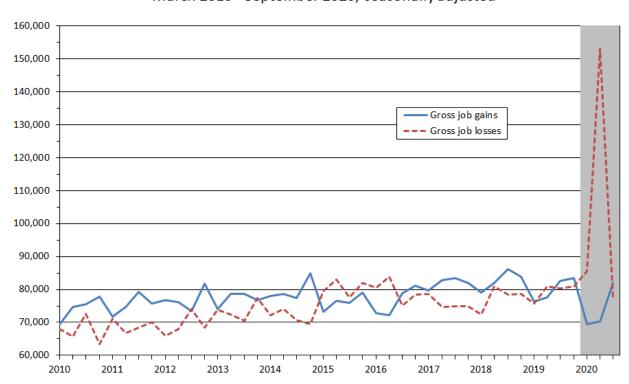
Gross Job Gains and Gross Job Losses: 3rd Quarter 2020

From June 2020 to September 2020, gross job gains from opening and expanding private-sector establishments in Oklahoma totaled 81,961, an increase of 11,573 jobs from the previous quarter. Over this period, gross job losses from closing and contracting private-sector establishments numbered 77,487, a decrease of 75,530 jobs from the previous quarter, according to the Oklahoma Employment Security Commission, Economic Research and Analysis Division, and the U.S. Bureau of Labor Statistics, (see Chart 1, below and Table 1, page 6). The difference between the number of gross job gains and the number of gross job losses yielded a net employment gain of 4,474 jobs in Oklahoma's private sector during the 3rd quarter of 2020.

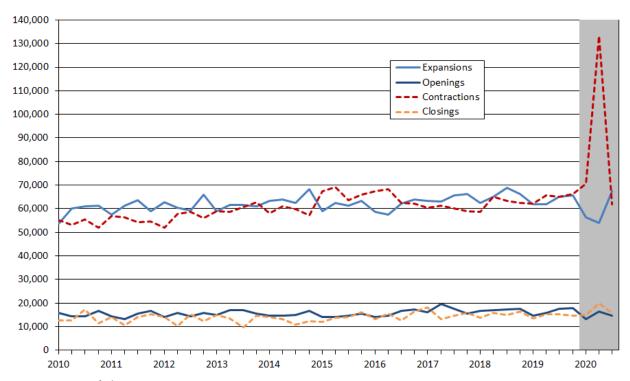
The change in the number of jobs over time is the net result of increases and decreases in employment that occur at all businesses in the economy. Business Employment Dynamics (BED) statistics track these changes in employment at private business establishments from the third month of one quarter to the third month of the next. *Gross job gains* are the sum of increases in employment from expansions at existing establishments and the addition of new jobs at opening establishments. *Gross job losses* are the result of contractions in employment at existing establishments and the loss of jobs at closing establishments. The difference between the number of gross job gains and the number of gross job losses is the net change in employment, (see Technical Note, page 6, for more information).

Gross job losses in the 2nd quarter of 2020 (153,017) were at the highest level since BED record keeping began in 1992, eclipsing the previous high set in the 1st quarter of 2009, towards the end of the 'Great Recession', when 101,545 jobs were lost.

Gross Job Gains and Losses: Openings vs. Closings and Expansions vs. Contractions

Gross job gains are the sum of increases in employment due to expansions at existing establishments and the addition of new jobs at opening establishments. Gross job gains at expanding establishments in Oklahoma totaled 67,274 in the 3rd quarter of 2020, an increase of 13,192 jobs compared to the previous quarter. Opening establishments accounted for 14,687 of the jobs gained in the 3rd quarter of 2020, a decrease of 1,619 jobs from the previous quarter, (see Chart 2, above).

Gross job losses are the result of contractions in employment at existing establishments and the loss of jobs at closing establishments. Contracting establishments in Oklahoma lost 61,762 jobs in the 3rd quarter of 2020, a decrease of 71,368 jobs from the prior quarter. In the 3rd quarter, closing establishments lost 15,725 jobs, a decrease of 4,162 jobs from the previous quarter.

Establishment Births and Deaths

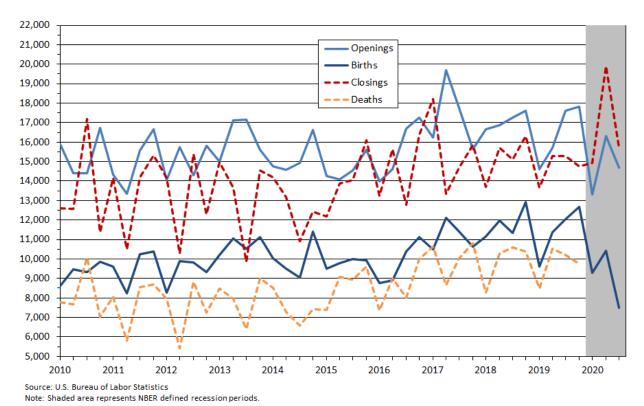
In Oklahoma, the number of private sector establishment births, (a subset of the openings data), decreased by 477, for a total of 1,956 establishments in the 3rd quarter of 2020. These new establishments accounted for 7,483 jobs, a decrease of 2,937 jobs from the previous quarter, (see Chart 3, next page).

Data for establishment deaths, (a subset of the closings data), are now available through the 4th quarter of 2019, when 9,744 jobs were lost at 2,575 establishments, a decrease of 461 jobs from the 3rd quarter of 2019, (see Chart 3, below).

Gross Job Gains and Gross Job Losses: Percent of Total Private Sector Employment

In the 3rd quarter of 2020, gross job gains represented 6.8 percent of private-sector employment in Oklahoma with expansions accounting for 5.6 percent of total private sector employment and openings contributing 1.2 percent. Nationally, gross job gains accounted for 9.4 percent of private sector employment in the 3rd quarter of 2020. With few exceptions, Oklahoma's rates of gross job gains have generally tracked with the U.S. rates. However, beginning in the 1st quarter of 2015, the rate of Oklahoma's gross job gains slipped below the national rate for seven consecutive quarters, exceeded the U.S. rate in the following nine quarters but has lagged behind the U.S. rate in four out of the past seven quarters, (see Chart 4, page 4).

In the 3rd quarter of 2020, gross job losses represented 6.4 percent of private-sector employment in Oklahoma, with contractions accounting for 5.1 percent and closings adding another 1.3 percent. The national rate of gross job losses was 6.0 percent in the 3rd quarter of 2020. From the 3rd quarter 2013 forward, Oklahoma's rate of gross job losses has shown more volatility especially the period beginning 1st quarter 2015 through 1st quarter 2017, then began to track more with national trends from the 4th quarter of 2017 forward (See Chart 5, page 4).

March 2010 - September 2020, seasonally adjusted

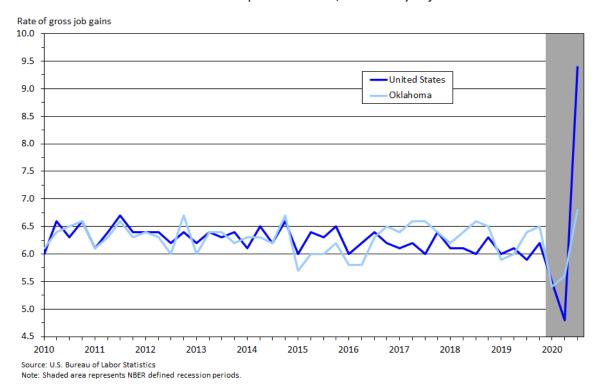
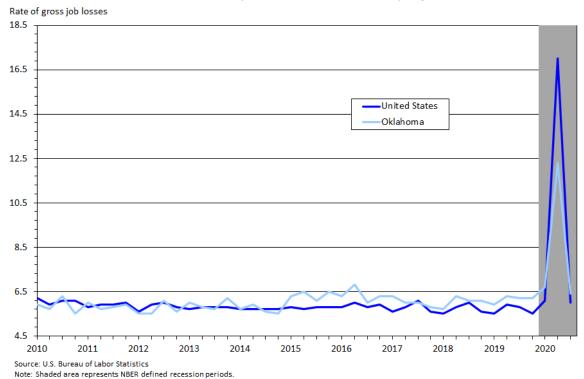

Private sector gross job losses as a percent of employment, United States and Oklahoma March 2010 - September 2020, seasonally adjusted

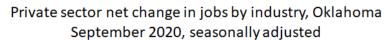


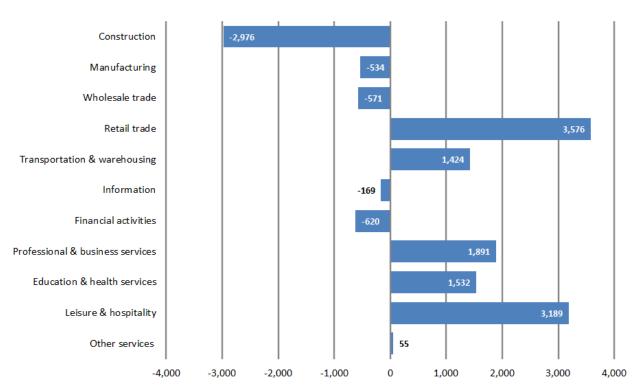
Gross Job Gains and Gross Job Losses by Industry: 3rd Quarter 2020

Gross job gains exceeded gross job losses in six of Oklahoma's 11 reported industries in the 3rd quarter of 2020. The service-providing industries experienced a net job increase of 10,307 jobs in the 3rd quarter of 2020. Within service-providing industries, the retail trade sector had the largest over-the-quarter net job increase, gaining 3,576 jobs. This was the result of 13,800 gross job gains and 10,224 gross job losses. The leisure & hospitality sector also experienced a net increase in the 3rd quarter of 2020, with 3,189 net jobs gained. Additional service-providing sectors experiencing net job gains in the 3rd quarter were professional & business services (1,891 jobs); health & education services (1,532 jobs); transportation & warehousing (1,424 jobs); and other services (55 jobs). Service-providing sectors reporting net job losses in the 3rd quarter of 2020 were financial activities (-620 jobs); wholesale trade (-571 jobs); and information (-169 jobs).

Oklahoma's goods-producing industries realized a net job decrease of 3,510 jobs in the 3rd quarter of 2020. Of the reported goods-producing industries, the construction sector experienced a net decrease of 2,976 jobs, while manufacturing showed a net loss of 534 jobs, (see Chart 6 below and Table 5, pp. 12-15).

Technical Note

Concepts and Methodology

The Business Employment Dynamics (BED) data are a product of a federal-state cooperative program known as Quarterly Census of Employment and Wages (QCEW), or the ES-202 program. The BED data are compiled from existing quarterly QCEW records. The QCEW reports are sent by the State Employment Security Agencies (SESAs) to BLS and form the basis of the Bureau's QCEW program and

establishment universe sampling frame. These reports are also used to produce the QCEW data on total employment and wages. Other important Bureau uses of the QCEW reports are in the Current Employment Statistics (CES) program. The CES program produces monthly estimates of employment, net changes, and earnings by detailed industry.

In the BED program, the QCEW records are linked across quarters to provide a longitudinal history for each establishment. The linkage process allows the tracking of net employment changes at the establishment level, which in turn allows the estimation of jobs gained at opening and expanding establishments and jobs lost at closing and contracting establishments.

The change in the number of jobs over time is the net result of increases and decreases in employment that occur at all businesses in the economy. BED statistics track these changes in employment at private business establishments from the third month of one quarter to the third month of the next. Gross job gains are the sum of increases in employment from expansions at existing establishments and the addition of new jobs at opening establishments. Gross job losses are the result of contractions in employment at existing establishments and the loss of jobs at closing establishments. The difference between the number of gross jobs gained and the number of gross jobs lost is the net change in employment.

Gross job gains and gross job losses are expressed as rates by dividing their levels by the average of employment in the current and previous quarters. The rates are calculated for the components of gross job gains and gross job losses and then summed to form their respective totals. These rates can be added and subtracted just as their levels can. For instance, the difference between the gross job gains rate and the gross job losses rate is the net growth rate.

The formal definitions of employment changes are as follows:

Openings: These are either establishments with positive third month employment for the first time in the current quarter, with no links to the prior quarter, or with positive third month employment in the current quarter following zero employment in the previous quarter.

Expansions: These are establishments with positive employment in the third month in both the previous and current quarters, with a net increase in employment over this period.

Closings: These are either establishments with positive third month employment in the previous quarter, with no employment or zero employment reported in the current quarter.

Contractions: These are establishments with positive employment in the third month in both the previous and current quarters, with a net decrease in employment over this period.
