DIRECT WINE SHIPPERS PERMIT APPLICATION CHECKLIST

Before completing the application packet read the information below:

- The application will be reviewed and under investigation upon filing of application.
- The license fee is due upon filing the application. We accept cash, credit card, business check, money order, or cashier's check for walk-in customers. Mail-in customers can submit the license fee by money order, cashier's check, or business check only.
- File the completed application in person or by mail at the ABLE Commission, 50 NE 23rd Street Oklahoma City, OK 73105, Monday thru Friday 7:30 am to 4:30 pm.

****In addition to the ABLE Direct Wine Shipper Permit, you must register with the Oklahoma Tax Commission.*** The Oklahoma Tax Commission provides an easy online application in order to register your business and become tax compliant. To apply for a tax account, proceed to <https://oktap.tax.ok.gov/OkTAP/Web> and select "Register a Business" under the Business Tab. Select NEW-Business Registration and answer NO to Are you a Remote Seller. Simply follow the prompts for registration as directed. Any questions with the registration process can be emailed to TaxAssist-Registration@tax.ok.gov. Your immediate attention to this matter is greatly appreciated.

***A Direct Wine Shipper's Permit may be issued by the Oklahoma ABLE Commission to a winery licensed in this state or any other state within the United States as a wine producer. A Direct Wine Shipper's Permit allows a winery to ship up to six nine-liter cases of wine annually directly to an Oklahoma resident who is twenty-one (21) years of age or older for such resident's personal use and not for resale. No resident shall be permitted to purchase more than thirty nine-liter cases of wine per year.**

*** Additional Items to be Submitted by Applicant:**

- *A certificate of good standing from the State you are licensed.**
- *A photocopy of the current winery license or license you are relying on to obtain this permit.**

AFFIDAVIT OF ELIGIBILITY

***Applicants for a Direct Wine Shippers Permit must complete this section:**

AFFIANT HEREBY STATES AND AFFIRMS THAT:

I, _____, hereby affirm that proof of current licensure in this or any other state as a wine producer has been provided. I/we shall not ship more than six nine-liter cases of wine annually to any person for his or her personal use or for resale. I/we shall ensure that all containers of wine shipped directly to a resident are conspicuously labeled with the words "CONTAINS ALCOHOL: SIGNATURE OF PERSON AGE 21 OR OLDER REQUIRED FOR DELIVERY." I/we shall require the transporter or common carrier that delivers the wine to obtain the signature of a person twenty-one (21) years of age or older at the delivery address at the time of delivery. At the expense of the Direct Wine Shipper shall receive a delivery confirmation from the express company, common carrier or contract carrier indicating the location of delivery, time of delivery and the name and signature of the individual who accepted the delivery. I/we shall report to the ABLE Commission annually, by a method prescribed by the ABLE Commission, the total amount of wine shipped into the state the preceding calendar year. I/we shall annually pay to the Oklahoma Tax Commission all applicable taxes due on sales authorized by this section to Oklahoma residents in the preceding calendar year. The amount of such taxes shall be calculated as if the sale were in Oklahoma at the location where delivery is made. Upon request, permit holders shall permit the Tax Commission to perform an audit of the permit holder's records in order to assure compliance. I/we shall be deemed to have consented to the jurisdiction of any agency or court of the State of Oklahoma tasked with the enforcement of or adjudication of controversies related to this section and any related laws or rules.
