

## Common Rules/Laws

---

**Employee Licenses** – All employees who serve/sell alcoholic beverages must have a valid employee license and attend the required training.

**Invoices** – All licensees must maintain alcohol invoices for the past 3 years. These invoices must be kept on site and be available for inspection at any time.

**Employees Drinking on Duty** – Employees may not consume alcoholic beverages while on duty.

**Purchase of Alcohol from Distributor** – All alcohol must be purchased from a wholesaler or distributor. Alcohol may not be purchased from a liquor store or retail establishment.

**6% Required Markup** – All alcoholic beverages must be sold at least 6% above wholesale cost.

**Inspection of Premise** – Law enforcement may inspect the licensed premise at any time. Licensees are required to cooperate with inspection and may not refuse entry to law enforcement.

**Violation of ABLE Rules/Alcoholic Beverage Statutes may result in fines, suspension, or revocation of ABLE License.**
