

How to submit a Change Request for Change of Officers & Directors online

The licensee needs to complete the change of officers & directors request forms located in the [Required Forms List](#) icon. After completing the forms, login to your online account, click the **Home** tab then click the **View My Records** icon, scroll down to see your ABE license number, to the right click the **Amendment/Change Request** button, next scroll down to **Change Requests** then from the drop down select **Change of Officers & Directors** then Continue to submit the information.
