NATURAL DISASTER EXCEPTION

First American Title will charge only \$150.00 for preliminary abstracting for issuance of Title insurance for any homeowner who sustains a material loss or damage to their home by reason of any natural disaster, including, but not limited to tornadoes, wild fires, or flooding of creeks or rivers that overflow their banks because of rain. This exception will pertain only to owner occupied homes at the time of the loss or damage.
