OKLAHOMA ABSTRACTORS BOARD MINUTES OF REGULAR MEETING February 21, 2023

- A regular meeting of the Oklahoma Abstractors Board (OAB) was called to order by Chairperson Randy Coffman at 10:00 a.m., at the OLERS Conference Room, 421 NW 13th Street, Suite 100, Oklahoma City, Oklahoma.
- 2. Darla Ringo called the roll. Attending were: Darin Kent, Darla Ringo, Jeff Lower, Jeff Mapes, Lisa Yates, Randy Coffman, Rex Koller, Scott Ward, and Sue Ann Loggains.
- The Minutes of the Regular Meeting of the OAB, conducted on January 17, 2023, were reviewed. A motion was made by Mr. Lower to approve the minutes as presented. The motion was seconded by Mr. Kent. - 4. <u>Chairperson's Report-Randy Coffman:</u> Mr. Coffman reported that he attended the OLTA Owners & Manager's meeting. It was a good meeting. One of the things discussed at the meeting what legislation, in particular a bill be sponsored by Senator Howard for OLTA and it's most of the things talked about a few months ago with changes to Title 1. We'll be following that bill as it makes its way through the legislative process.
- 5. <u>Administrator's Report (Board Report)</u>: Ms. Smith reported that she also went to the Owner's & Managers Meeting. There was a lot of representation from the legislature both at the meeting and during the legislative reception. In addition to there being a good turnout from the capitol, there were a lot of new faces.

Last week, she went to Representative Kendrix to discuss the agency's sunset date. There are bills on both sides and one has the new date set for 2026 and the other has a date of 2025 so it's just whichever bill passes. It's typical that they wait until the year you're set to expire before submitting legislation to adjust it.

Another form has been discovered to need adjustment. Form number 10 on the website, the Complaint form has been reviewed and the following changes are needed. The title is recommended to change to Public Complaint Against an Abstract Company instead of just showing Complaint Against an Abstract Company as it does now because that's how it is referred to. The other change is to the last paragraph referring to the public's ability to request a Formal Complaint. According to our statutes, a Formal Complaint can only be instigated by the Enforcement Committee.

Mr. Lower stated that he felt the changes were necessary to keep the form from being confusing. Mr. Coffman agreed and reiterated that there is no allowance in Title 1 for an individual to request a Formal Complaint.

After review and discussion, a motion was made by Ms. Ringo to approve the suggested changes as presented. Second by Ms. Yates. Motion carried.

The revenue for the month of January was \$37,555.00 and expenses were \$22,613.58 which leaves us with an ending cash balance of \$918,287.70.
