**RULE IMPACT STATEMENT**

Pursuant to 75 O.S. §303(D), the Board of Tests for Alcohol and Drug Influence provides the following rule impact statement with regard to proposed rule changes to Chapter 50 of Title 40 of the Oklahoma Administrative Code.

**a. Purpose and Legal Basis**

The proposed rule amendments are necessary to introduce cost-saving measures without negatively impacting public safety. The amendments are authorized under **47 O.S. § 6-212.5**, which directs the Board of Tests to administer and enforce the ignition interlock program for the State of Oklahoma. This statute provides the Board authority to establish rules governing program requirements, participant monitoring, and interlock provider obligations.

**b. Classification**

This rule amendment is classified as a *nonmajor rule amendment* with a reduction in financial impact.

**c. Purpose of Proposed Amendments**

The purpose of the amendments is to:

1. Allow a new feature developed by interlock manufacturers for applicable interlock devices;
2. Modify violations related to the Impaired Driving Accountability Program (IDAP) by removing power violations during the last 90-day active interlock review;
3. Remove outdated language that conflicts with state statute; and
4. Update definitions for clarification.

The proposed amendments have no relation to federally subsidized or assisted programs and are not federally mandated.

**d. Classes of Persons Affected**

No classes of persons will bear any financial costs pursuant to the amendments.

**e. Classes of Persons Benefiting**

The classes of persons who will benefit are IDAP participants.

**f. Probable Economic Impact**

There is no anticipated economic impact related to the proposed rules. No state agency, political subdivision, entity, or individual will experience costs related to implementation.

**g. Methodology**

Economic determinations were based on internal agency review and private sector feedback.

**h. Effect on Political Subdivisions**

The amendments will have no economic impact on political subdivisions.

**i. Effect on Small Business**

The amendments will have no adverse economic impact on small businesses.

**j. Minimization of Costs**

No measures were necessary to minimize compliance costs, as the amendments reduce or maintain existing regulatory burden.

**k. Effect on Public Health, Safety, and Environment**

The amendments contribute to increased public health and safety through improved interlock program administration.

**l. Detrimental Effect if Not Implemented**

Failure to implement the amendments will maintain current economic burden on affected parties and continue the status quo.

**RULE IMPACT STATEMENT**

Pursuant to 75 O.S. §303(D), the Board of Tests for Alcohol and Drug Influence provides the following rule impact statement with regard to proposed rule changes to Chapter 30 of Title 40 of the Oklahoma Administrative Code.

**a. Purpose and Legal Basis**

The proposed rule amendment is necessary to incorporate the CMI, Inc. Intoxilyzer 9000 testing procedures into the approved breath analysis operating procedures pursuant to **47 O.S. § 759**.

**b. Classification**

This rule amendment is classified as a *nonmajor rule amendment* with no financial impact.

**c. Purpose of Proposed Amendment**

The purpose of the amendment is to implement the next-generation breath alcohol device. This rule is not related to federally subsidized or assisted programs and is not federally mandated.

**d. Classes of Persons Affected**

No classes of persons will bear financial costs pursuant to the amendment.

**e. Classes of Persons Benefiting**

The beneficiaries include the agency, the legal community, the law enforcement community, and the users of Oklahoma roadways.

**f. Probable Economic Impact**

The proposed amendment is revenue neutral. No state agency, political subdivision, entity, or individual will experience costs or revenues as a result of implementation.

**g. Methodology**

Economic determinations were based on internal agency review.

**h. Effect on Political Subdivisions**

The amendment imposes no duties or costs on political subdivisions.

**i. Effect on Small Business**

The amendment will have no adverse economic impact on small businesses.

**j. Minimization of Costs**

No measures were necessary to minimize compliance costs, as no costs are imposed by the rule.

**k. Effect on Public Health, Safety, and Environment**

The amendment supports continued reliability and accuracy of breath alcohol testing, thereby protecting public health and roadway safety.

**l. Detrimental Effect if Not Implemented**

Failure to implement the amendment may adversely affect the civil and criminal judicial systems and hinder public safety.
