



DPPA PERMISSIBLE USE FORM

Records Containing Personal Information Obtained from Motor Vehicle Records

Pursuant to Oklahoma Statute 51 O.S. §24.5A(1)(c); personal information within driver records is confidential and protected. The Federal Driver's Privacy Protection Act (DPPA), 18 U.S.C. §§ 2721-2525, regulates access to personal information obtained from motor vehicle records. Under 18 U.S.C. § 2721-2725 and 51 O.S. §24.5A(1)(c), the Oklahoma Board of Tests for Alcohol and Drug Influence will make records containing personal information obtained from motor vehicle records available to an Attorney/Law Firm or other qualified Requester based on the Requester's certification that the Requester is authorized to obtain and use the records. This form must be completed before records containing personal information will be released without redacted information.

Notice to Requester: It is unlawful for any person to knowingly obtain, disclose or use personal information obtained from a motor vehicle record for any use not permitted under 18 U.S.C. § 2721-2725. Anyone requesting the disclosure of personal information who misrepresents their identity or makes a false statement to obtain personal information from an individual's motor vehicle record is subject to civil and criminal penalties. Knowledge of what access and uses are under the DPPA and Oklahoma Law is the responsibility of the Requester.
