4. Interim Director's Report

Interim Director Smith let the board members know we were able to get each member a copy of the Open Records Handbook. He also gave updates on training, instrumentation, interlock, and administration. The training program will be modifying and putting forth new training materials as needed for the changes implemented by the IDAP Program. The interlock division has inspected over 90% of the service centers in the State. Compliance testing and training also happens during the service center inspections. The maintenance program has ordered new forms for the Intoxilyzer to comply with the changes brought on by the new IDAP Program. There have been over 100 gateways deployed since January 2019, leaving around 20 more to be installed across the state. The administration is facing a few challenges with changes to comply with the IDAP Program. The IDAP Program is requiring DPS to receive a verified violation for the ignition interlock. The violations will be monitored and verified by the Board of Tests. This is going to require a full time staff member. One of the challenges we face is the limited space we have in the building we are housed in currently. Interim Director Smith would like to work with the chair and vice-chair on solutions for the space issue. Also, on the administration side we have three employees that will attend the Public Information Officer training as soon as enrollment is made available.
