1. Call Meeting to Order

Action Taken: Dr. Blick called the meeting to order at approximately 10:00 a.m. Roll was taken; five members were present representing a quorum. Earl Morrison joined the meeting at approximately 10:05 a.m.

Action Taken: Dr. Blick gave statement of compliance for the record.

Action Taken: Dr. Wagner motioned to approve the minutes for the regular meeting held November 10, 2020. Major Hampton seconded the motion.

4. Director's Report

Director Smith kept his update brief and referred to his monthly report to the Board members. The director introduced and welcomed new members Earl Morrison from CLEET and Chief Michael Bell from Oklahoma Assoc. Chiefs of Police as our newest Board members. He informed the Board the Department of Health position is still vacant. The director moved forward in recognizing Jenifer Steiner and Vince Barnard for their 10 years of service with the state of Oklahoma. They were presented with recognition certificates and pins. The director thanked the Board and staff for the active participation and continued endurance during the state of emergency.

5. Comments from interested parties for the petition for Declaratory Ruling or Other Order regarding Disposable Materials, Supplies And Paraphernalia submitted by DPS

All parties were given several minutes to address the Board members present. DPS was represented by Kevin Behrens, the District Attorney's Council was represented by Jeff Sifers, Mr. Stephen Fabian and Brian Morton represented themselves. DPS and the DAC encouraged the Board to adopt the proposed order. Mr. Fabian and Mr. Morton encouraged the Board to discuss the matter further and delay issuing any orders at this meeting.

6. Discussion and possible action for Declaratory Ruling or Other Order regarding Disposable Materials, Supplies and Paraphernalia to all parties

The director was asked for input regarding the proposed order by the chair. The director informed the Board that historically, the Board is often left out of court room discussion regarding our administrative rules and recommended that the Board issue the order so that state authority over breath testing might be heard and judges be informed even when the Board is not a present party.

Action Taken: Sheriff West motioned to withhold Board action until an in-person meeting could be conducted to discuss the issue further without technical difficulties interfering with the meeting. Chief Bell seconded the motion.

A roll call vote was taken with the following results Dr. Blick voted yes, Dr. Wagner voted yes, Major Hampton recused himself due to conflict of interest, Earl Morrison voted yes, Sheriff West voted yes, Chief Bell voted yes

7. Discussion and possible action on proposed Permanent Rulemaking

The director gave an overview of each proposed amendment to the administrative rules as requested by the chairman. The director informed the Board of one amendment to 40:40-1-2.

Action Taken: Major Hampton motioned to adopt the rules as amended. Dr. Wagner seconded the motion.
