TOTAL NUMBER OF UNECESSARY, COSTLY, INEFFECTIVE, DUPLICATIVE OR OUTDATED REGULATIONS: 0

Our agency is fairly new in the grand scheme of things and our Rules Committees have taken great pains to ensure that our Act and Rules remain as clear and concise as possible. Since our inception on January 2008, the only changes to our administrative rules minor adjustments and tweaking to provide additional clarity and guidance the only true additions to the Rules were made in 2018 and 2020. These are noted below.

In 2010 we reduced the activities requiring a license, in 2011, we defined "supervision", in 2014 we added further definitions for "abstract plant", "up-front commitment to pay", and "billing information", in 2016 the definition for "abstract plant" was further tweaked. In 2018 we did have an addition of the requirement for "tail-end" insurance or other provision to ensure existing certificates were protected for consumers for the 5 year validity requirement when a Transfer of Ownership occurred through an asset purchase, and in 2020 we made an addition in response to the Governor's requirement for felony specifications with regard to licensing.
