Method used to conduct review: During the Governor's Agency Leadership Retreat in 2019, Governor Stitt shared with agency directors his vision to reduce Administrative Rules. Therefore, prior to issuance of Executive Order 2020-03, the Board took a proactive approach and began its own review. The Act & Rules/Legislative Committee, which consists of several Board members, Board Counsel, the Executive Director, and other staff members thoroughly reviewed the Administrative Rules to determine which Rules could be revoked or edited to remove information that was redundant, unnecessary, or outdated. The edits were then presented to the entire Board, which approved those changes.
