Method Used to Conduct Review:

Policy Director Suzanne Cox began the review by assembling a complete list of all rules accepted on December 30, 1991, for publication in the first *Oklahoma Administrative Code*. Included in the list are all sections that were added or revoked since the original codification date. Director Cox, who coordinated codification of the rules promulgated prior to 1991 and who has managed all rulemaking since that date, made recommendations for revocation of obsolete and unnecessary rules that still remain in Title 230, as well as offering a brief history of rules, including the intent of and reason or need for the rules at the time of adoption. Secretary Paul Ziriax, Assistant Secretary Pam Slater, and Director Cox met several times in July to discuss the recommendations for retaining, revoking, or amending current rules. This report also was reviewed by Assistant Attorney General Thomas S. Schneider, the agency's legal counsel.

All Sections revoked since codification in 1991, displayed in red, and all expired emergency rules have been included in this report to show this agency's ongoing and consistent effort to keep Title 230 accurate and up-to-date. The rules contained in these Chapters, Subchapters, Parts, and Sections still form the foundation of Oklahoma's uniform and unified statewide election system. Rules that are determined to be necessary provide specific information and/or procedure and process to implement a requirement in federal or state law. Some still contain direct duplication of language in statutes because it is intended to show that many parts of Oklahoma election procedure exist because it is the will of the Oklahoma Legislature or of the United States Congress that they exist. Specific explanations for why individual rules are necessary are not generally included. When laws are amended, we amend the rules, when laws are repealed, we revoke related rules, and when new laws are enacted, we develop the procedures, processes, *and* rules the Secretary deems necessary to implement the will of the Oklahoma Legislature or of Congress.

Most, if not all, remaining Sections in Title 230 contain one or more of these words: "shall, must, require, shall not, may not, and prohibit." We believe these words are necessary. Rules are not, by definition, suggestions. The rules promulgated by the Secretary of the State Election Board do not apply to the general public. They do not apply to voters or candidates. These rules apply to <u>election officials</u> at the State, County, and precinct levels. These rules are intended to provide a consistent interpretation of federal and state election law and to create uniform procedures and processes for the purpose of protecting the rights of all Oklahomans to cast their ballots in free and fair elections without regard of ethnic background or religious or political affiliation.
