#### **Title 277 Forensic Review Board**

The Forensic Review Board is created by 22 O.S. §1161(F), and its rules are found in Title 277 of the Oklahoma Administrative Code. This Board reviews individuals who have been determined Not Guilty by Reason of Mental Illness. The composition of the board and its procedures are in large part set forth in statue. As this body does not require administrative authority for enforcement, it is unnecessary to restate any statute or federal regulation within their own regulations. Therefore, the rules of the Forensic Review Board are brief. In fact, there are only three (3) rules in Title 277.
