Explanation of Determined Category

To implement the provisions of the Licensed Alcohol and Drug Counselors Board.

Describes the meaning of terms used by our Board.

Governs individual proceedings.

Expired. No longer needed. Was emergency rule.

Describes procedures for filing complaints, the CRC make up and investigations into complaints. This was amended 9/21/14 to include a Board member on the CRC.

Allows for continuances. Generally in accordance with the APA. To prevent hardship to and excessive burden upon a party. Describes issuance and service, failure to obey and motions to quash. Open to the public, recordings and transcriptions. Also, maintenance of records and appeal designation. The hearing officer may impose sanctions. Outlines procedures for the Order of a Hearing. Procedures for issuance and services of the final orders, appeal as provided by APA and settlements. To establish administrative operations of the Board and Agency. Allowed to expired. Initially an emergency rule used in setting up the board. No longer needed. Covered in Title 59 § 1873.

Applies to the Oklahoma Board of Licensed Alcohol and Drug Counselors, all employees of the Board and individuals subject to licensure or certification.

Definition of terms or words used in the Act or Rules.

To be compliant with any statute of the United States or state of Oklahoma now existing and all persons and organizations affected by the rules.

The Board is vested with authority to make rules and to employ, direct and discharge staff.

As required by Open Meetings Act.

Procedures for persons making a request for records.

The Board will devise and maintain forms for use by any party.

Procedures to secure a declaratory ruling

Procedure for petitioning the Board to request the promulgation, amendment or repeal a rule.

Explanation of Determined Category

Define unprofessional conduct and context of drug and alcohol counseling and establish norms of professional conduct.

Stated Code of Ethics for alcohol and drug counselors.

Statement of confidentiality, discrimination, credentials, records, dual relationships, privacy, referrals, sanctions.

Violations of other laws, drug and alcohol use, sexual contact and updating of information.

Outlines misrepresentation of credentials, advertising, display of license, public statements, rebates and accepting fees from agency clients.

Subject to sanctions for failure to comply

Although we have never established the Counselor Assistance Program, the Complaint Review Committee has used portion in investigating complaints and working with counselors to rehabilitate persons struggling with addiction and/or mental health.

To set forth criteria for fitness of applicants.

7-2-(a)-(2)-(a) / 7-2-(c)-(2)-(a)- Moral Character should be removed per HB 1373. - Portions regarding LADC/MH Application & Designation in 10-7-2 a 3 F have been amended in 2020 Rules. The balance of 7-2 is still effective.

Rules establishing criteria for establishing private or independent practice.

7-6-(q) - was intended to replace 7-6-(n) with had an effective date of 9/14/2018

Requirement for Oral examination possibly outdated. IC&RC, the standards OK operates under dropped the oral exam in 2008. The OK board has continued to conduct the oral exam as being necessary.

7-8-(b) & 7-8-(d) need to be updated to include the Renewal online portal

Standards outlining requirements for reciprocity from other states, the armed services, or foreign countries. It assures that incoming licensees meet the OK standards for licensure.

Testing availability, due to IC&RC eliminating this credential, has made it not possible to meet the testing requirements related to the co-occurring disorder credential.

Guidelines for documentation of supervised work experience, supervisor and supervisee requirements.

Word for word duplication, with exception that 10-9-5 (e) (7) includes an additional statement regarding confidentiality

Outlines the supervisee's responsibilities in supervision.

Outlines the responsibilities of the supervisor's role in supervision, requirements to become a supervisor. Amended 2020 to allow more audio/video supervision in hardship cases (effective 09/11/2020)

Explanation of Determined Category

Explanation of fees necessary to conduct Board business.

Personal check, cashiers check, money order, cash or credit card.

Fees schedule reviewed yearly. Amended for the first time in 2019. Three new fees added in 2019, numbers 19, 20 and 21. # 17. LADC/MH amended 2020 to clarify language and change fee to match other application fees.

Explanation of Determined Category

Define continuing education standards and amended to add process for approved continuing education providers.

Required hours, approval of continuing education, Armed services exemption, hardship exemption, prorating for newly licensed or certified. (b) Amended to require candidates to acquire 6 hours of continuing education per year, 3 hours being ethics.

Retention of attendance certificates. Necessary for audits

Outline of continuing education audit.

Failure to complete required continuing education shall constitute failure to renew the license.
