#### Method Used to Conduct Review:

The Oklahoma Department of Mental Health and Substance Abuse Services (ODMHSAS) has conducted a thorough review of its administrative rules contained in Title 450 and has identified a significant number of unnecessary, duplicative, and/or outdated regulations. The agency conducted numerous meetings with legal, policy, provider certification, and program staff over the course of the last few months to identify the optimal strategy to reduce regulatory burden and streamline provider requirements within administrative rules. Staff also considered feedback from providers on desired rule changes. The identified rule reductions in this report accomplish the following goals: 1) eliminating unnecessary or duplicative regulations while maintaining a regulatory framework that ensures safety of consumers, 2) applies regulations consistently across provider types where appropriate, and 3) eliminates burdensome and unclear requirements.

ODMHSAS evaluated the need for sweeping changes within the body of its administrative rules while conducting its review. As such, some reorganization of rules across chapters is planned, as indicated in this report. This reorganization will result in some addition of language in strategic places in order to eliminate duplicative language across chapters and increase consistency, with an overall impact of reduced regulations. The agency has noted below both the total and the estimated "net" reduction that takes into account those additions.

ODMHSAS will conduct ongoing review of it administrative rules and continue to monitor the need for reduced regulations for providers.
