Division Administrator reviewed further and found no additional revisions. The powers and duties of the Commission for Rehabilitation Services in relation to the special schools are set forth in Title 10, O.S., Sections 1418, 1419, and 1420; and in 74 O.S., Section 166.1 et seq.

Chapter 25. Business Enterprise Program

Chapter 25 was reviewed and revised by the Division Administrator in 2018. Antiquated language was removed and citations were updated. Division Administrator reviewed further and found no restrictive words requiring additional revisions. All amendments to Chapter 25 must be submitted for approval to the Rehabilitation Services Administration (RSA) of the U.S. Department of Education. RSA is currently several years behind on final approval of submitted rule revisions. Rules for the Business Enterprise Program (BEP) are promulgated by the Oklahoma Commission for Rehabilitation Services under the authority of 74 O.S., Section 166.1 et seq., and in accordance with the federal Randolph-Sheppard Act (20 U.S.C. § 107 et seq.) and 7 O.S. §§ 71-78.
