Chapter 25 – Notary Public

This entire Chapter was updated at the beginning of this year by emergency action, to remove outdated and unnecessary provisions, and to implement the new remote online notarization legislation that was enacted in 2019 and became effective on 1/1/20 [SB 915 (2019)]. The emergency rules also became effective on 1/1/20, following approval by the Governor on 12/18/19. Permanent rules are set to supersede these emergency rules on 9/11/20.
