Method Used to Conduct Review: A Department attorney reviewed each Section individually and all of the Chapters promulgated by the Administrator as a whole. Teams of Department attorneys reviewed the specific Chapters and Sections of which they are most experienced. In connection with rulemaking in recent years, the Department has made a diligent effort to revoke or amend unnecessary, costly, ineffective, duplicative, and outdated regulations. The Department gave particular emphasis in 2018 and 2020 to Chapters 2, 6, and 11, and as a result, the majority of the rules in these chapters are current and effective. This report does identify Sections that need attention and the Department will address them as part of its next rulemaking project.
