The Department first identified the unnecessary rules that were repetitive, overly specific, or covered by current statutes. The Department then reviewed each Administrative Rule and began reviewing them with Division Directors of the Department for information that is outdated due changes in statute, internal procedures or policies that do not involve the public, or other changes resulting outdated information. The Department is planning on conducting a full recodification of all Administrative Rules in fiscal year 2021 to address and resolve the issues found in this Review.
