A. Brief description of the purpose of the proposed rule.

The purpose of the proposed rule amendments to Subchapter 3 is to provide language for administering Dropout Recovery Grants, promulgate rules for House Bill 2672 to support new graduation requirements, update agricultural education language to expand CareerTech offerings set forth by House Bill 2321, and define, and defines planning and supervisory periods for agriculture education instructors. Amendments provide clarity on Business, Marketing and IT Education offerings and student organization requirements for divisions. Health Careers was changed to Health Science to align with the national association. Rules were defined for the new Industry Specialist Certification as outlined in House Bill 3273. Chapter 20 includes procedural edits to clean up content and provide consistent language.

B. Description of the classes of persons who most likely will be affected by the proposed rule, including classes that will bear the costs of the proposed rule, and any information on cost impacts received by the agency from any private or public entities.

Instructors and students in Career and Technology Education programs will be affected by the proposed rule amendments. There are no known cost impacts of the proposed rules.

C. Description of the classes of persons who will benefit from the proposed rule.

The proposed rule amendments benefit Career and Technology Education students and instructors by helping them better understand the organizational structure options for program offerings and high school graduation credits.

D. A description of the probable economic impact of the proposed rule upon affected classes of persons or political subdivisions, including a listing of all fee changes and, whenever possible, a separate justification for each fee change.

There is no known economic impact on any class of persons because of the proposed rule amendments.
