## ***Children of OAETA Members Scholarship***

### **2025 Scholarship Rules and Application**

The ***Children of OAETA Members Scholarship*** is available to children of current Active OAETA members upon the completion of the child's first year of post-secondary education. Post-secondary education may include college, university, Careertech, or other recognized technical or trade school programs. Scholarships will be awarded to all eligible applicants as long as a parent is an Active OAETA member in good standing, the student completes the application, and all scholarship eligibility requirements are met.

#### ***Eligibility:***

- The applicant must have graduated from high school in 2024 and successfully completed their first full year of post-secondary education following high school graduation.
- The applicant must provide documentation from the institution of successful completion of their first year of post-secondary education.
- The applicant must be the son or daughter of a current Active OAETA member. A stepson or stepdaughter is eligible if the current member is a legal guardian of the stepchild.
- The applicant does not have to have been an active FFA member.
- The OAETA member must have been an active member for a minimum of 5 years and a member at the time of the required graduation date.
- The children of a past OAETA member who completed at least 25 years of OAETA membership would be eligible for the scholarship.
- In the event that an OAETA member dies after the completion of 5 years of service, their children will always be eligible for the scholarship.
- The OAETA board reserves the right to review any applications on an individual basis to determine eligibility, and will have the final decision.

#### ***Required Information:***

- Completed scholarship application is required.
- Scholarship recipients must submit proof of successful completion of first year of postsecondary education (i.e. tuition statement for following semester, schedule, letter from institution stating good standing, transcript, etc.) to the state OAETA office to receive scholarship funds. Document must be from the post-secondary institution.
- A copy (does not have to be official) of your high school transcript.

***Deadline:*** Application and supporting materials must be post marked to the state OAETA office by **July 1, 2025**. Late applications will **NOT** be accepted.

***Awards:*** The Agricultural Education State Staff will review Scholarship applications and scholarships up to \$1,000 will be awarded September 2025. Scholarship amounts will be determined by available money and number of applications received this year.
