SUMMARY:

The proposed amendments in 140:15-1-2 provides a definition for "Recognized Chiropractic Specialty Program (RCSP). The proposed new language under subchapter 5 provides a chiropractic formulary for allowed vitamins, minerals and nutritional supplements, and provides those injectables which are prohibited for those chiropractic physicians who are certified in the administration of injectables. The proposed amendments in 140:15-7-1. Display of License, and 140:15-7-4. Appendages to names of licensees, insertion of "or her", "they are", "or herself" rather than just "his" or "himself". The proposed amendment in 140:15-9-1 provides language to allows the Board to recognize the requirements adopted by the Federation of Chiropractic Licensing Boards, Recognized Chiropractic Specialty Program, but still allows the Board to reserve the approval authority for all programs based on the furtherance of professional development and related areas, and in the interest of the public protection objectives of the Practice Act. The proposed amendment in 140:15-3-3 is necessary to change the word "twelve" to "twenty-four" since it reflects (24) in the current rule.
