**SUMMARY:**

The proposed amendment in 140:10-1-2 would amend the definition of "Continuing Education" in paragraph (c) that would require that the 8 hours of mandatory in-state continuing education be offered by a registered, domestic Oklahoma association. The new language will remove "registered, domestic, Oklahoma" and allow continuing education that is mandatory in-state to be offered by an association, and/or accredited chiropractic college as defined in Title 59 O.S. 161.3. The proposed amendments in 140:10-5-2 would provide language to come in line with current statutory amendments that are currently in effect as of November 1, 2023 through amendments implemented through the passage of HB 1385 during the 2023 Legislative Session. The proposed amendment in 140:10-5-3 is necessary to come in line with current statutory language in Title 59 O.S. 161.11(D)(1).
