Pursuant to 70 O.S. § 3311(J)(8), reports of final orders of peace officer terminations or resignations while under investigation are to be “considered as personnel records and shall be afforded confidential protection pursuant to Sections 24A.7 and 24A.8 of Title 51 of the Oklahoma Statutes.”

A. Review and Approve Private Security Phase IV Rifle Course Curriculum

Information: The Private Security Advisory Committee (PSAC) has reviewed and recommended for final approval a Phase IV rifle course curriculum. The curriculum will be applicable to armed security guards, armed private investigators, armed bail enforcers, and any combination licensee or applicant who wishes to be authorized to carry an approved rifle while performing licensed duties. Acting Director Williams and staff will present and review the curriculum with the Council.
