4. Agency Report from Interim Executive Director Casebolt

Overview: Update on Business Portal, Licensing, Thentia Portal, Two-Year Renewal.

- **Business Portal**

- The business portal is up and running.
- During testing phase, changes were restricted, leading to issues after launch.
- Fixing issues cost \$7,000 per instance, so adjustments are being made internally.
- **Licensing**
 - Mail-in processing is currently at November 7th for issuance and October 24th for other items.
 - Approximately 3,000 to 4,000 licenses are issued monthly.
 - Over 500 exams are conducted monthly.
 - Student registrations are around 600 for the last two months.
- **Citations**
 - Over \$11,000 in citations have been collected in the last two months.
- **Thentia Portal**
 - Thentia wants MiMi Casebolt to start working on inspections portal.
 - The education portal is supposedly ready but contains information from August 2024, possibly from John, Molina, or Heather.
 - Aiming to have both portals running by the end of the year.
- **Two-Year Renewal**
 - The two-year renewal process started on November 1st.

- A motion was made and passed to authorize AG Mule to open the record, make statements on the record as to whether service was properly affected, rule on motions, and answer board questions on legal matters.
- The strict rules of evidence do not apply in administrative hearings.
- The board will vote on whether to uphold citation and impose the fine as stated, dismiss the citation or uphold part of the citation.
- Council will prepare final order which will be signed by the interim executive director and mailed to respondents.
- The Board takes official notice of the Oklahoma Administrative Procedures act, and Title 175 of Oklahoma Administrative Code.
- The hearing is being recorded, and the recording constitutes the official record of these recordings.

- A quorum of the board is present, and this board had jurisdiction to hear these citations.
- Board members confirm they can accord the respondent a fair and impartial hearing.
- Kylie Cooper is the board's prosecutor
- Coilette Smith identifies herself as the owner of Final Touch
- The citation for Final Touch is entered as evidence (109 Exhibit 2).
- At the time that the citation was issued, Final Touch was an unlicensed establishment

Prosecution's Case- Citation 00109 (Final Touch)

- Inspector Mauri Pettis is sworn in
- Pettis inspected Final touch Salon on August 21, 2025
- The inspector found that the establishment was employing an expired licensee and the business license for Final Touch had expired

Respondent's Defense - Citation 00109 (Final Touch)

- Smith states she sent in her license renewal with extra money to cover late charges.
- She claims to have called the state board multiple times but her calls were not returned.
- Smith has evidence of when she purchased the money order to renew her license.
- She also has evidence of dates of when the mail returned to her to let her know that there was now upcharge on the license.
- Smith has evidence of her new license and how they came separately.
- Smith has been in business for 33 years.
- Smith has records that she wants to be copied and shown to the board.

Evidence

- Five documents entered as evidence, marked as 109.

License Renewal Delay

- License renewal delayed.
- Paid original fees, then late charge (\$20) on June 30th.
- Received envelope from state board on July 29th, indicating an additional \$10 needed.
- Paid the extra \$10 and received separate envelopes for the license and establishment renewal.

Timeline Discrepancies

- Originally paid on June 28th, then paid late fee on June 30th.
- Money order returned on July 29th.
- License expired in April, renewed on June 30th.
 - Working with expired license from April to June.

Lack of Receipts

- No receipt for payment/renewal before August 21st.
- No receipt for the additional \$10 payment.

Late Fee

- Claims to have paid \$20 late fee for two licenses.
- Late fee is consistently \$10 after 60 days.

Communication Issues

- Called the agency multiple times but calls were not returned.

- "If you say leave a message and no one returns my call, what do we do? That's not fair to us."

Staying Updated

- Advised to check the website for current rules, regulations, and registration process.
- Website provides a step-by-step registration process and a portal.
